# Committee stage

Appropriation Bill 2014 : The Financial Secretary

(During the Committee stage of the Bill, the meeting was suspended at 9:51 pm on 7 May, 9:50 pm on 8 May, and 12:50 pm on 9 May 2014, and resumed at 2:30 pm on 8 May, and 9:00 am and 4:04 pm on 9 May 2014.)

The Council went into committee and continued to consider the Schedule to the Bill. The committee continued with the first joint debate covering 14 heads to which no amendments were proposed. After Members and a public officer had respectively spoken, the question that the sums for the 14 heads stand part of the Schedule was put and agreed to (details of division in the **Appendix**).

The committee proceeded to consider a total of 1 192 amendments, which involved 69 heads, proposed by 14 Members to the Bill as set out on the Agenda.

The committee commenced the second joint debate, the theme of which was "Governance, Constitutional Development and District Administration", covering 280 amendments to 20 heads as set out in the Official Record of Proceedings. Members spoke on the amendments.

The Council resumed. The President declared that the next Council meeting would be held on 14 May 2014 at 11:00 am.

The Council was adjourned at 9:58 pm on 9 May 2014.
