Attendance

Presentation of Petition

Hon WU Chi-wai and Hon Charles Peter MOK presented, under Rule 20 of the Rules of Procedure, a petition to the Council as set out on the Agenda. Immediately after Hon WU Chi-wai had presented the petition, Hon Charles Peter MOK rose in his place and requested that the petition be referred to a select committee. As 21 Members rose to support the request, the President referred the petition to a select committee in accordance with Rule 20(6) of the Rules of Procedure.

Questions

Six oral questions as set out on the Agenda (i.e. Questions 1 to 6) were put by Members and oral replies were given by the public officers.

First Reading and Second Reading

- Securities and Futures and Companies : Secretary for Financial Services and
Legislation (Uncertificated Securities the Treasury
Market Amendment) Bill 2014
- Sex Discrimination (Amendment) : Secretary for Constitutional and
Bill 2014 Mainland Affairs
- Private Columbaria Bill : Secretary for Food and Health

After the above Bills were read the first time and ordered to be set down for Second Reading under Rule 53(3) of the Rules of Procedure, the public officers moved the Second Reading of the Bills respectively. The President's Deputy proposed the questions on the Second Reading of the Bills respectively and referred them to the House Committee in accordance with Rule 54(4) of the Rules of Procedure. The debates on the Bills were adjourned.

Resumption of Second Reading debate, Committee stage and Third Reading

- Inland Revenue (Amendment) Bill 2014 : Secretary for Financial Services and the Treasury

The debate on the Second Reading of the above Bill, which was moved on 7 May 2014, resumed. After Members and the public officer had respectively spoken, the President put the question on the Second Reading of the Bill, and the question was agreed to (details of division in **Appendix 1**). The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clauses 1 to 7 stand part of the Bill was proposed, put and agreed to (details of division in **Appendix 2**).

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage without amendment. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading was proposed, put and agreed to (details of division in **Appendix 3**). The Bill was read the third time and passed.

Hon LEE Cheuk-yan moved the motion as set out on the Agenda. The President proposed the question on the motion. After Members had spoken, question on the motion was put. The motion was negatived (details of division in **Appendix 4**).
