Motions proposed under paragraph 37A of the Finance Committee Procedure

At the Finance Committee ("FC") meeting on 6 June, you presented two motions under paragraph 37A of the Finance Committee Procedure ("FCP") (motions numbered 721 to 722, see **Annex**).

In considering whether the motions are directly related to the agenda item, I have reviewed in detail the contents of related documents under the agenda. Item no. FCR(2014-15)2 – PWSC(2013-14)38 is to seek the approval of the FC for "the upgrading of part of 747CL, as 772CL, entitled 'Advance site formation and engineering infrastructure works at Kwu Tung North new development area and Fanling North new development area – detailed design and site investigation', to Category A at an estimated cost of \$340.8 million in money-of-the-day prices".

In respect of the motion numbered 721, item no. FCR(2014-15)2 – PWSC(2013-14)38 makes no mention of the matter you raise in the motion. The motion numbered 722 requests the FC to urge the Administration to withdraw the funding application. After considering item no. FCR(2014-15)2 – PWSC(2013-14)38, I am not satisfied that the contents of these two motions are directly related to the above-mentioned agenda item. Hence, I rule that motions numbered 721 and 722 that you purpose to move do

not comply with the provisions of paragraph 37A of the FCP and should not be referred to the Committee for consideration. Accordingly, I return these two motions to you.
