**Report No. 13/13-14 of the House Committee on Consideration of
Subsidiary Legislation and Other Instruments**

Purpose

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire at the Council meeting of 19 March 2014.

Subsidiary legislation considered

2. The House Committee has considered the following items of subsidiary legislation -

(3)	Public Health and Municipal Services Ordinance (Public Pleasure Grounds) (Amendment of Fourth Schedule) Order 2014 (L.N. 20/2014)	21 February 2014
(4)	Air Pollution Control (Amendment) Ordinance 2014 (Commencement) Notice (L.N. 21/2014)	21 February 2014

3. The House Committee formed two subcommittees at its meeting on 24 January 2014 to study in detail items (1) and (2) respectively. The former Subcommittee reported its deliberations to the House Committee on 28 February 2014 vide LC Paper No. CB(4)434/13-14. The latter Subcommittee made a verbal report at the same meeting, and provided Members with a written report issued vide LC Paper No. CB(1)1043/13-14 on 7 March 2014.

4. In respect of items (3) and (4), the House Committee considered it not necessary to form any subcommittee to study these two items of subsidiary legislation.

Note: Regarding the Toys and Children's Products Safety (Additional Safety Standards or Requirements) Regulation (L.N. 17/2014), Toys and Children's Products Safety Regulation (Repeal) Regulation (L.N. 18/2014) and Toys and Children's Products Safety (Amendment) Ordinance 2013 (Commencement) Notice (L.N. 19/2014), the President has given permission for Hon Jeffrey LAM, Chairman of the relevant Subcommittee, to move a proposed resolution at the Council meeting of 19 March 2014 to extend the period for amending these three items of subsidiary legislation to the Council meeting of 9 April 2014.
