Land Registry statistics for September

The Land Registry today (October 6) released its statistics for September 2014.

Land registration

- The number of sale and purchase agreements for all building units received for registration in September was 7,996 (+1.2% compared with August and +56.4% compared with September 2013)
- The 12-month moving average for September was 6,267 (4% above the 12-month moving average for August but 14% below that for September 2013)
- The total consideration for sale and purchase agreements in September was \$53.8 billion (+2.7% compared with August and +122.1% compared with September 2013)
- Among the sale and purchase agreements, 5,958 were for residential units (-4.1% compared with August but +61.6% compared with September 2013)
- The total consideration for sale and purchase agreements in respect of residential units was \$42.2 billion (+0.3% compared with August and +122.3% compared with September 2013)

The statistics only cover sale and purchase agreements with payment of stamp duty. Sale and purchase agreements relating to the sale of units under the Home Ownership Scheme, the Private Sector Participation Scheme and the Tenants Purchase Scheme are not included unless the premium of the unit concerned has been paid after the sale restriction period.

Figures on sale and purchase agreements received for the past 12 months, the year-on-year rate of change and breakdown figures on residential sales have also been released.

As deeds may not be lodged with the Land Registry until up to 30 days after the transaction, these statistics generally relate to land transactions in the previous month.

Land search

• The number of searches of land registers made by the public in September was 398,549 (-3.5% compared with August but +15.6% compared with September 2013)

The statistics cover searches made at the counter, through the self-service terminals and via the Integrated Registration Information System Online Services.



The Land Registry Chart showing the number of Sale and Purchase Agreements of building units from September 2013 to September 2014


