Proposed timing for discussion

1. Measures against cross-boundary corruption

To be confirmed

At the meeting on 20 October 2009, Hon Cyd HO suggested that measures taken by Independent Commission Against Corruption ("ICAC") against cross-boundary corruption should be discussed at a future meeting.

An information paper on the efforts made by ICAC in forging closer cooperation with the Guangdong Provincial People's Procuratorate ("GDPP") and the Commission Against Corruption of Macao ("CCAC") on corruption prevention and education was circulated to members vide LC Paper No. CB(2)910/09-10(02).

At the meeting on 1 June 2010, in the context of discussing the item "Security matters under the Framework Agreement on Guangdong/Hong Kong Co-operation", members were briefed on the collaboration among ICAC, GDPP and CCAC in the exchange of anti-corruption experiences on practical issues and the provision of corruption prevention services to cross-boundary business enterprises in the Pearl River Delta region.

According to ICAC, it had agreed with GDPP and CCAC in July 2010 to set up a standing working group to jointly map out long-term strategies and objectives to strengthen tripartite cooperation on corruption prevention and education. The working group has agreed that a conference for small and medium size enterprises ("SMEs") in the Pearl River Delta region be held in Hong Kong in September 2011 and a practical guide be published in 2012.

ICAC advised that the conference with the theme of

"Integrity and Professionalism - Key to Business Success" was held on 22 September 2011 in Hong Kong. It was attended by some 200 participants from major chambers of commerce, trade associations, as well as entrepreneurs from Hong Kong, Macao and Speakers included government officials, Guangdong. professionals and entrepreneurs from the three places, sharing with participants anti-corruption strategies, corruption prevention measures and business ethics related to SME operation. The conference helped gauge the needs of cross-boundary SME entrepreneurs and shed light on the framework and contents of the corruption prevention guide. Production of the guide, a joint publication of ICAC, GDPP and CCAC, had The guide, covering respective been completed. anti-corruption legislation of Hong Kong, the Mainland and Macao as well as corruption prevention measures for cross-boundary SMEs entrepreneurs, was launched and promoted to businessmen in Hong Kong through related chambers of commerce and trade associations in early October 2012.

2. Development of a computer system in the Fire Services Department ("FSD") for provision of advanced post-dispatch advice

FSD plans to procure and develop a computer system which provides an internationally accredited questioning protocol to allow the provision of more elaborated and comprehensive post-dispatch advice to callers of emergency ambulance service. The Administration plans to consult the Panel on the proposal before submission to the Finance Committee. 2nd Quarter of 2014

3. Establishment of a declaration and disclosure system To be confirmed for the physical cross-boundary transportation of currency and bearer negotiable instruments

The Administration intends to brief the Panel on the details of establishing a declaration and disclosure system for the physical cross-boundary transportation of currency and bearer negotiable instruments, pursuant to the relevant international standards on anti-money laundering and counter financing of terrorism set by the Financial Action Task Force.

4. Co-location arrangement at the control point for the To be advised by Guangzhou-Shenzhen-Hong Kong Express Rail Link THB ("XRL")

Item proposed by Hon Dennis KWOK, whose letter on the subject had been circulated to members vide LC Paper No. CB(2)707/12-13 on 27 February 2013. At the meeting on 1 March 2013, members agreed that the subject be discussed at a future meeting. **Members** agreed that members of the Panel also on Administration of Justice and Legal Services and representatives from the Department of Justice would be invited to attend when the subject was discussed.

The Administration advised that co-location arrangement at the control point concerned was part and parcel of the XRL project spearheaded by the Transport and Housing Bureau (THB), which would provide information to the Panel on Transport on the co-location arrangement of immigration and customs facilities at the control point as part and parcel of the XRL project in due course.

The Administration intends to brief the Panel on its progress of follow-up work in due course. 6. **Contingency plan for nuclear incidents near Hong** To be confirmed Kong Item proposed on 10 October 2013 by Dr Hon Kenneth CHAN, who expressed concern about nuclear safety and the Administration's contingency plan in the event of a nuclear incident near Hong Kong. The Administration intends to brief the Panel on the relevant notification mechanism and contingency plan in due course. 7. Use of military sites and implementation of the To be confirmed **Garrison Law in Hong Kong** Item proposed by Dr Hon Kenneth CHAN on 10 October 2013. Dr CHAN also proposed in his letter (LC of 27 November 2013 Paper No. CB(2)399/13-14(01)) the discussion of legal liability under the Garrison Law. Hon Frederick FUNG raised a question on the review of the use of military sites at the Council meeting of 9 October 2013.

Two referrals from the Public Complaints Office on rezoning a site at the Central waterfront from "Open Space" to "Military use" were circulated to members vide LC Paper No. CB(2)745/13-14 on 22 January 2014.
