Action

I. Election of Chairman

1. <u>Mr Andrew LEUNG</u>, the member present who had the highest precedence, presided at the election and called for nominations for the chairmanship of the Bills Committee. Mr Kenneth LEUNG was nominated by <u>Mr Charles MOK</u> and the nomination was seconded by <u>Mr SIN Chung-kai</u>. <u>Mr Kenneth LEUNG</u> accepted the nomination.

2. <u>Mr Andrew LEUNG</u> invited other nominations for the chairmanship. Mr Andrew LEUNG was nominated by <u>Ms Starry LEE</u> and the nomination was seconded by <u>Ir Dr LO Wai-kwok</u>. <u>Mr Andrew LEUNG</u> accepted the nomination. As Mr Andrew LEUNG was nominated, <u>Mr Charles MOK</u> presided over the election. There was no other nomination.

3. <u>Mr Charles MOK</u> announced a vote by secret ballot. After members present had cast their votes, <u>Mr Charles MOK</u> invited Mr SIN Chung-kai and Ms Starry LEE to monitor the counting of votes. Of the members present, three

As both nominees received the same number of votes, <u>Mr Charles MOK</u> drew lots and gave the casting vote to Mr Andrew LEUNG in accordance with the lot drawn. Mr Andrew LEUNG was declared elected as the Chairman of the Bills Committee. <u>Mr Andrew LEUNG</u> then took the chair.

4. <u>The Chairman</u> sought members' view on the need for a deputy chairman. It was agreed that no deputy chairman was required.
