3. <u>The Administration</u> was requested to consider whether it was appropriate to move an amendment to delete the word "paper" from clause 20(1)(a) of the Kai Tak Cruise Terminal Bill ("the Bill") in view of the policy intention of making littering a prohibited act.

(*Post-meeting note*: The English and Chinese versions of the Administration's written response together with the revised set of draft Committee stage amendments ("CSAs") to be moved by the Administration were issued to members vide LC Paper No. CB(4)813/15-16(02) on 5 April and 8 April 2016 respectively.)

4. <u>The Chairman</u> concluded that the Bills Committee had completed the scrutiny of the Bill and had no objection to the draft CSAs proposed by the Administration. The Bills Committee would not move any CSAs in its name.
