# Item No. 2 – FCR(2014-15)33A HEAD 705 – CIVIL ENGINEERING Environmental Protection – Refuse disposal 165DR – West New Territories Landfill Extension

## Motions proposed by members pursuant to paragraph 37A of the Finance Committee Procedure

# Motions proposed by Mr Gary FAN

2. <u>The Chairman</u> put to vote the questions, one by one, that the motions proposed by Mr Gary FAN numbered W085 and W086 be proceeded forthwith. As requested by members, <u>the Chairman</u> ordered a division for each of the proposed motions, and the division bell was rung for one minute for each division. With the agreement of the Chairman, <u>Mr FAN</u> read out each of his proposed motions during the ringing of the division bell. All the questions were negatived.

## Motions proposed by Mr Albert CHAN

3. <u>The Chairman</u> put to vote the questions, one by one, that the motions proposed by Mr Albert CHAN numbered W019 to W046 and W048 and W058 be proceeded forthwith. As requested by members, <u>the Chairman</u> ordered a division for each of the proposed motions, and the division bell was rung for one minute for each division. With the agreement of the Chairman, <u>Mr CHAN</u> read out each of his proposed motions during the ringing of the division bell. All the questions were negatived.

## Motions submitted by Mr CHAN Chi-chuen without notice

4. # Motions proposed by Dr Fernando CHEUNG

6. <u>The Chairman</u> put to vote the questions, one by one, that the motions proposed by Dr Fernando CHEUNG numbered W061 to W066 be proceeded forthwith. As requested by members, <u>the Chairman</u> ordered a division for each of the proposed motions, and the division bell was rung for one minute for each division. With the agreement of the Chairman, <u>Dr CHEUNG</u> read out each of his proposed motions during the ringing of the division bell. All the questions were negatived.

## Motions submitted by Mr LEUNG Kwok-hung without notice

7. At around 6:15 pm, Mr LEUNG Kwok-hung submitted 40 proposed motions to be moved under paragraph 37A of the FC Procedure. <u>The Chairman</u> considered that 18 were directly related to FCR(2014-15)33A, and agreed that they would be put to the Committee to decide whether they should be proceeded forthwith. At around 7:00 pm, Mr LEUNG submitted another 19 motions. <u>The Chairman</u> considered that seven were directly related to FCR(2014-15)33A, and agreed that they would be put to the committee to decide whether they should be proceeded forthwith.

## Motions proposed by Ms Emily LAU

8. <u>The Chairman</u> put to vote the questions, one by one, that the motions proposed by Ms Emily LAU numbered W087 to W089, W091 to W093, W095 and W096 be proceeded forthwith. As requested by members, <u>the Chairman</u> ordered a division for each of the proposed motions, and the division bell was rung for one minute for each division. With the agreement of the Chairman, <u>Ms LAU</u> read out each of her proposed motions during the ringing of the division bell. All the questions were negatived.

# Motions proposed by Mr CHAN Chi-chuen

9. <u>The Chairman</u> put to vote the questions, one by one, that the motions proposed by Mr CHAN Chi-chuen numbered W108 to W114 be proceeded forthwith. As requested by members, <u>the Chairman</u> ordered a division for each of the proposed motions, and the division bell was rung for one minute for each division. With the agreement of the Chairman, <u>Mr CHAN</u> read out each of his proposed motions during the ringing of the division bell. All the questions were negatived.

# Motions proposed by Mr LEUNG Kwok-hung

10. <u>The Chairman</u> put to vote the questions, one by one, that the motions proposed by Mr LEUNG Kwok-hung numbered W059, W118 to W134 and W141 be proceeded forthwith. As requested by members, <u>the Chairman</u> ordered a division for each of the proposed motions, and the division bell was rung for one minute for each division. With the agreement of the Chairman, <u>Mr LEUNG</u> read out each of his proposed motions during the ringing of the division bell. All the questions were negatived.

# Motions submitted by Mr Albert CHAN without notice

11. At 7:20 pm Mr Albert CHAN submitted seven proposed motions to be moved under paragraph 37A of the FC Procedure. <u>The Chairman</u> considered that all of them were directly related to FCR(2014-15)33A, and agreed that they would be put to the Committee to decide whether they should be proceeded after Mr LEUNG Kwok-hung had moved all his motions.

# Motions proposed by Mr LEUNG Kwok-hung

12. <u>The Chairman</u> put to vote the questions, one by one, that the motions proposed by Mr LEUNG Kwok-hung numbered W158 to W161 be proceeded forthwith. As requested by members, <u>the Chairman</u> ordered a division for each of the proposed motions, and the division bell was rung for one minute for each division. With the agreement of the Chairman, <u>Mr LEUNG</u> read out each of his proposed motions during the ringing of the division bell. All the questions were negatived.

13. After the Committee had dealt with the proposed motion numbered W161, <u>the Chairman</u> reminded members that if no more members submitted further proposed motions, he would put the item to vote after the Committee had dealt with 10 outstanding motions from members.

14. <u>The Chairman</u> put to vote the questions, one by one, that the motions proposed by Mr LEUNG Kwok-hung numbered W162 to W164 be proceeded forthwith. As requested by members, <u>the Chairman</u> ordered a division for each of the proposed motions, and the division bell was rung for one minute for each division. With the agreement of the Chairman, <u>Mr LEUNG</u> read out each of his proposed motions during the ringing of the division bell. All the questions were negatived.

# Motions proposed by Mr Albert CHAN

15. <u>The Chairman</u> put to vote the questions, one by one, that the motions proposed by Mr Albert CHAN numbered W165 to W171 to be proceeded forthwith. As requested by members, <u>the Chairman</u> ordered a division for each of the proposed motions, and the division bell was rung for one minute for each division. With the agreement of the Chairman, <u>Mr CHAN</u> read out his proposed motions during the ringing of the division bell. All the questions were negatived.

# Voting on FCR(2014-15)33A

16. As the Committee had dealt with all of the motions proposed to be moved under paragraph 37A of the FC Procedure to express views on item FCR(2014-15)33A, the Chairman put the item to vote.

17. <u>Mr Albert CHAN</u> raised a point of order and asked if he could move a motion to change the duration of the division bell to two minutes. <u>The Chairman</u> referred Mr CHAN to the note prepared by the Secretariat and distributed to members vide LC Paper FC67/14-15 dated 10 December 2014. He said that it was not in order for a member to move such a motion.

18. <u>Mr Albert CHAN</u> said that he had interest to declare. He said that the collection and treatment of waste were financed by General Revenue to which he had contributed through tax and that the charging of waste disposal would affect him as he also contributed towards the generation of waste. <u>The</u> <u>Chairman</u> interrupted and said that the matter that Mr CHAN mentioned was not a direct or indirect pecuniary interest related to the item.

19. <u>The Chairman</u> continued with the voting procedure. At the request of members, he ordered a division, and the division bell was rung for one minute. <u>The Chairman</u> announced that 27 members voted in favour of, and 16 voted against the item.
