#### **RECOMMENDATIONS OF THE PUBLIC WORKS SUBCOMMITTEE ON PUBLIC WORKS PROGRAMME AND CAPITAL SUBVENTION PROJECTS**

Encl. 1 to 3 At Enclosures 1 to 3 are summaries of the recommendations of the Public Works Subcommittee (PWSC) made at its meetings on 16 June, 24 June and 30 June 2015.

2. Agenda item **PWSC(2015-16)32** in Enclosure 3 originally comprised Ten projects under the Signature Project Scheme (SPS) in seven districts, namely –

- **453RO** Harbourfront Enhancement and Revitalisation at the Western Wholesale Food Market
- **61RG** Yung Shue Wan Library cum Heritage and Cultural Showroom, Lamma Island
- **285RS** Improvement Works at Silvermine Bay Beach, Mui Wo, Lantau Island
- **59RG** Improvement of Trails and Provision of Ancillary Facilities at Wu Tip Shan and Wa Mei Shan in Fanling
- **60RG** Improvement of Trails and Provision of Facilities in Sha Tau Kok
- **70RE** Enhancement of Leisure Facilities of Morse Park
- 65RG Mei Foo Neighbourhood Activity Centre
- **461RO** Redevelopment of Sai Lau Kok Garden
- **454RO** Revitalisation of Shing Mun River Promenade near Sha Tin Town Centre
- 170CD Decking of Tai Wai Nullah in Sha Tin

Given the large number of items awaiting deliberations in PWSC and with a view to streamlining, the Government consolidated the ten projects under one PWSC agenda item.

3. At the PWSC meeting on 30 June 2015, Members requested that **461RO** and **170CD** be voted on separately from the remaining eight projects. Since the Government had originally planned to implement the SPS projects separately and since we would not want to hold up progress on the other eight projects, we are only inviting FC to approve en bloc the eight projects recommended by PWSC (namely **453RO**, **61RG**, **285RS**, **59RG**, **60RG**, **70RE**, **65RG** and **454RO** under **PWSC(2015-16)32**). We will invite FC to consider the remaining two projects, **461RO** and **170CD**, in due course.

4. The relevant papers considered by PWSC have been forwarded to all Members and are therefore not enclosed. The Government will provide supplementary information on **19NB**, **763CL**, **711CL**, **110ET**, **351EP**, **60RE** and **69JA** before the FC meeting.

5. Members are invited to approve the PWSC recommendations.
