## A History of Success

By being overly dependent on others, Hong Kong's success will then lie not in the hands of its hard-working and forward-thinking residents but the whims of these third-parties who do not necessarily have Hong Kong's best interests in mind.

It is our opinion that a new Innovation and Technology Bureau can best help Hong Kong achieve success by focusing on the following core areas:

- Identifying, formulating and developing comprehensive and appropriate ICT standards and policies through dedicated high-level leadership, turning innovation and technology into our strengths and ensuring the sustainable growth of Hong Kong's economy.
- Collaborating with various resources and strengthening linkages among stakeholders to create greater synergy among government bodies, education institutions, private and public sectors.
- Developing new opportunities and a sustainable future for the next generation of residents, spanning from their formative education to long-term career opportunities.
- Evolving Digital 21 strategies effectively, by implementing practical uses of a new generation of technologies, such as the Internet of Things (IoT), Cloud computing, mobile Internet, and others, in the daily lives of residents of this Smart City.
