**Supplementary information on
contract residential care homes for the elderly**

At the meeting of the Finance Committee (FC) held on 17 April 2015, the item FCR(2015-16)5 on the provision of a new Contract Residential Care Home for the Elderly (RCHE) with a Day Care Unit for the Elderly in Shek Mun Estate Phase II, Shatin was discussed. FC has requested the Government to provide information on the various levels of fees being charged and the average level of fees in respect of the 24 Contract RCHEs in operation after the meeting. Note 1: The difference in fees charged for service users with the same impairment level of the same home is determined by the room type where the non-subsidised places are located. The fees charged must be within or lower than the amount set out in the table.

Note 2: Average fee is calculated based on the weighted average of the monthly fees to be charged for places located in rooms with different capacities and the frailty level of the elderly residents. The impairment level is defined by the Standardised Care Need Assessment Mechanism for the Elderly. For calculation purpose, the case mix is assumed to be 10% at moderate and 90% at severe level of impairment.
