Question:

Regarding the work to "continue to assist in the licensing and regulatory matters in relation to domestic free television programme services, domestic pay television programme services and analogue sound broadcasting services", Asia Television Limited (ATV) has defaulted for times on payments of wages, Mandatory Provident Fund contributions and licence fees. Moreover, it has been providing limited informative, entertainment and educational television (TV) programme services only. All this will bring losses to the public in the long run. If ATV is unable to sustain its operation as a TV station, what measures will be taken by the Administration to maintain its basic operation? Will it even take over ATV as an interim measure? If so, what are the details? In addition, will the Administration consider revocation of ATV's licence and introduction into the market other competitors interested in running a TV station when reviewing the grant of the licence in question so as to fill the gap?

Reply:

On 1 April 2015, the Government announced that the Chief Executive (CE) in Council had decided not to renew Asia Television Limited (ATV)'s current domestic free television programme (free TV) service licence under the Broadcasting Ordinance (BO) (Cap. 562). For the purpose of complying with the requirement in section 8(1)(a) of Schedule 4 to the BO as to the length of advance notice to be served on ATV regarding the aforesaid decision, the CE in Council has ordered that the term of ATV's current free TV service licence originally expiring on 30 November 2015 be extended, under section 8(2) of Schedule 4 to the BO, for a period from 1 December 2015 to 1 April 2016 (both dates inclusive) (but such extension shall not continue in force an exclusive right to provide the service under the licence, if any). ATV will continue to comply with all relevant requirements and the

provisions in its free TV service licence in the next 12 months until the expiry of its licence. During the transitional period before the expiry of ATV's current licence, audiences will have fewer choices of free TV programmes. As part of the contingency measures, the Government is exploring with Radio Television Hong Kong (RTHK) the arrangement to broadcast RTHK's existing digital television programmes on the analogue programme channels to be vacated after ATV's licence has expired, so as to provide audiences (in particular those households which have not yet switched over to digital terrestrial television) with an alternative choice.

Question:

On 4 November 2014, the Communications Authority (CA) submitted to the Chief Executive (CE) in Council its recommendations on the application for the renewal of the licence of Asia Television Limited (ATV). However, on 28 January 2015, the Convenor of the Executive Council (ExCo), Mr Lam Woon-kwong, claimed that "no messages concerning ATV's licence renewal have been received so far." According to section 11(5) of the Broadcasting Ordinance (BO), where recommendations are made under subsection (3), the CE in Council shall consider them and as soon as is practicable - (a) extend or renew the licence to which they relate subject to such conditions as he thinks fit specified in the licence; or (b) decide not to extend or renew the licence.

The CE in Council has yet to receive messages relating to ATV's licence renewal 87 days after the CA submitted its recommendations on the licence renewal. Has the decision in question contravened section 11(5) of the BO? If yes, what follow-up action will be taken by the Administration and what is the estimated expenditure involved? If not, what are the reasons? Has the Administration assessed if the decision in question will lead to legal proceedings? Has the Department of Justice been consulted? If not, what are the reasons? The members concerned have yet to receive relevant messages within 87 days. What are the reasons? What responsibilities should the Bureau and the ExCo Secretariat shoulder? Given that no relevant messages have been received within 87 days, does the Administration think there is reasonableness and work efficiency?
