# NOTE FOR PUBLIC WORKS SUBCOMMITTEE OF FINANCE COMMITTEE

### Forecast of submissions for the 2014-15 Legislative Council session

This note gives an overview of the potential capital works items to be submitted to the Public Works Subcommittee (PWSC) in the 2014-15 Legislative Council session.

A total of 89 items, as listed in Enclosure 1, may be ready for submission to the PWSC before the 2015 summer recess. To enable Members to have a better understanding of the items, we have provided supplementary information on each item at Enclosure 2 following the same order presented in Enclosure 1.

3. Among the 89 items, 21 of them have been submitted to the PWSC in the 2013-14 Legislative Council session but were not voted on or discussed. Due to the lapse of time, it is necessary to revise the project programmes and cost estimates of these items. To date, the delay in securing funding approval of these items has resulted in an increase in estimated project cost by a total of \$1 billion. There is a programme delay of six months on average for each project. In particular, the refurbishment project of the Hong Kong Buddhist Hospital (item 38) has to be retendered due to the expiry of the tender validity period in August 2014.

4. The Administration will try to adhere to the target dates as set out in Enclosures 1 and 2 as much as possible. However, there may be programme changes arising during the design, statutory gazettal and objections, and consultation stages, etc. for individual items. We will account for deviations from the current forecast in a year-end report for Members' reference.

**Project Code and Title:** Provision for Capital Works Reserve Fund (CWRF) block allocations in 2015-16

**Policy Bureau and Branch:** Various controlling officers of CWRF block allocations

### Works Department: Various

### **Project Description:**

To enable Members of the Finance Committee (FC) and the Public Works Subcommittee (PWSC) to make better use of their time and concentrate on the more important and higher value projects, FC has authorised the Administration to seek funding for the various block allocations on a lump-sum basis once every year. Within the lump sum approved for each CWRF block allocation, FC has further delegated to the Administration the power to approve expenditure on individual projects.

The submission seeks PWSC's support and FC's approval for the proposed allocation for the CWRF block allocations for 2015-16, and an additional allocation for Subhead 4100DX—Drainage works, studies and investigations for items in Category D of the Public Works Programme under Head 704—Drainage for 2014-15.

Indicative cost of the proposed allocation (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

**Previous or planned panel consultation:** We plan to consult the Panel on Information Technology and Broadcasting, the Panel on Development and the Panel on Transport in November 2014.

Project Code and Title: 5233DS—Sludge treatment facilities

Policy Bureau and Branch: Environment Bureau

Works Department: Environmental Protection Department

#### **Project Description:**

The project was upgraded to Category A in June 2009 at an Approved Project Estimate (APE) of \$5,154.4 million. The approved scope of the project comprises (a) design and construction of a sludge treatment facility of capacity of 2 000 tonnes per day; (b) provision of ancillary facilities; (c) provision of environmental educational and associated facilities; and (d) environmental monitoring during the construction stage.

The design, build and operate contract of the project was awarded in September 2010. The construction works commenced in October 2010 and the first phase of the facility is currently under testing with a view to starting the operation in early 2015. We need to seek approval from the Finance Committee to increase the APE to cover additional costs arising from the increase in provision for contract price adjustment for the construction works.

Indicative cost of the proposed increase in the APE (Below \$200 million / \$200 million - \$500 million / Above \$500 million): \$200 million - \$500 million

**Previous or planned panel consultation:** We plan to consult the Panel on Environmental Affairs on the proposed increase in the APE in January 2015.

**Project Code and Title:** 6845TH—Hong Kong–Zhuhai–Macao Bridge (HZMB) Hong Kong Boundary Crossing Facilities (HKBCF)—Reclamation and Superstructures

Policy Bureau and Branch: Transport and Housing Bureau (Transport Branch)

#### Works Department: Highways Department

#### **Project Description:**

The project was upgraded to Category A in November 2011 at an Approved Project Estimate (APE) of \$30,433.9 million. The approved scope of the project comprises mainly reclamation to provide land for the development of the HKBCF, and the construction of cargo clearance facilities, passenger clearance facilities, provision of accommodation for and facilities of government departments, transport and miscellaneous facilities inside the HKBCF, road access for connection of the HKBCF to HZMB Hong Kong Link Road, Tuen Mun-Chek Lap Kok Link and Hong Kong International Airport, and other associated infrastructures and facilities.

The construction works commenced in November 2011. The works are divided into one reclamation contract and 9 superstructure contracts. The tender prices of most of the works contracts have been known. As the tender prices/estimated tender prices for the works contracts awarded/to be awarded are higher than the estimate in 2011, together with the increase in provision for price adjustments, we need to seek the approval of the Finance Committee for increasing the APE to meet the latest forecast of construction expenditure.

# Indicative cost of the proposed increase in the APE (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

**Previous or planned panel consultation:** We plan to consult the Panel on Transport on the proposed increase in the APE in 2015–Q1.

**Project Code and Title:** 5019GB—Liantang/Heung Yuen Wai Boundary Control Point (BCP) and associated works—site formation and infrastructure works

#### Policy Bureau and Branch: Development Bureau (Works Branch)

Works Department: Civil Engineering and Development Department

#### **Project Description:**

The project was upgraded to Category A in July 2012 at an Approved Project Estimate (APE) of \$16,253.2 million. The approved scope of the project comprises mainly (a) site formation for the Liantang/Heung Yuen Wai Boundary Control Point (BCP) (about 23 hectares); (b) construction of an approximately 11 kilometre long dual two-lane connecting road connecting the BCP with Fanling Highway; and (c) design and construction of four vehicular bridges and one pedestrian bridge crossing Shenzhen River (cross-boundary bridges).

The site formation works at the BCP commenced in April 2013 for completion in mid-2015. The construction of the connecting road from Fanling Highway to Sha Tau Kok including the interchange at Fanling Highway is also in progress for completion in 2018. Despite the incorporation of appropriate cost saving measures in the works contracts, the remaining fund under the APE would be insufficient for carrying out the remaining works of the project, including the construction of the connecting road from Sha Tau Kok to the BCP and the cross-boundary bridges as a result of the upsurge in construction prices, poor ground conditions for tunneling works, tenderers' perception on higher risks associated with construction constraints, increase in provision for price adjustment and increase in contingencies. We need to seek approval from the Finance Committee (FC) to increase the APE before awarding the contracts of the remaining works is tentatively scheduled to commence in 2014–Q4 and we will strive to complete them in 2018.

# Indicative cost of the proposed increase in the APE (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

**Previous or planned panel consultation:** We consulted the Panel on Development on the proposed increase in the APE on 7 January, 22 April and 5 May 2014.

**Project Code and Title:** 3013GB—Liantang/Heung Yuen Wai boundary control point and associated works—construction of boundary control point buildings and associated facilities

Policy Bureau and Branch: Development Bureau (Works Branch)

Works Department: Architectural Services Department

#### **Project Description:**

The proposed project is for the construction of buildings and associated facilities for the new boundary control point at Liantang/Heung Yuen Wai. The proposed scope of the project comprises the construction of (a) passenger clearance facilities; (b) cargo processing facilities; (c) accommodation for and facilities of government departments providing services in connection with the boundary control point; (d) transport-related facilities that include internal road networks, a public transport interchange, transport drop-off and pick-up areas, vehicle holding areas and other associated road furniture; (e) a public carpark; and (f) other ancillary facilities. The construction is tentatively scheduled to commence in 2015–Q1 for completion in 2018–Q2.

Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

**Previous or planned panel consultation:** We plan to consult the Panel on Development on the proposed works in December 2014.

**Project Code and Title:** 3237LP—Kowloon East Regional Headquarters and Operational Base-cum-Ngau Tau Kok Divisional Police Station

Policy Bureau and Branch: Security Bureau

Works Department: Architectural Services Department

#### **Project Description:**

The proposed project is for the construction of the Kowloon East Regional Headquarters and Operational Base-cum-Ngau Tau Kok Divisional Police Station at 105 Concorde Road, Kai Tak, Kowloon. The proposed scope of the project comprises (a) demolition of the existing vacated Kai Tak Operational Base; (b) construction of an integrated complex for the reprovisioning of the Kowloon East Regional Headquarters units (Administration Wing, Operations Wing, Crime Unit, Traffic Unit) and two operational units (including Emergency Unit and Police Tactical Unit), Railway District Headquarters, Kowloon East Auxiliary Headquarters Unit, Indoor Firing Range, Ngau Tau Kok Divisional Police Station; provision of ancillary facilities including armouries, dangerous goods storage facilities, dog kennels, petrol filling station, parking areas, etc.; and (c) demolition of the existing Kowloon East Operational Base, Indoor Firing Range and Ngau Tau Kok Divisional Police Station and ex-Tsz Wan Shan Divisional Police Station upon commissioning of the integrated complex. The construction is tentatively scheduled to commence in 2015–Q1 for completion in 2018–Q2. Upon commissioning of the new regional headquarters, the demolition works will commence with completion scheduled for 2020–Q2.

# Indicative cost of the proposed project (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

**Previous or planned panel consultation:** We consulted the Panel on Security on the proposed works on 2 July 2013.

Project Code and Title: 4160DS—Tuen Mun sewerage, stage 1

Policy Bureau and Branch: Environment Bureau

Works Department: Drainage Services Department

#### **Project Description:**

The part of the project proposed for upgrading to Category A is for the provision of trunk sewerage to housing developments in Tuen Mun East and extension of public sewerage to three unsewered villages in Tuen Mun. ### **Project Description:**

The project was upgraded to Category A in June 2009 at an Approved Project Estimate (APE) of \$1,671 million. The approved scope of the project comprises (a) construction of a northern chiller plant; (b) construction of a southern underground chiller plant cum underground seawater pumphouse and above-ground operational facilities; (c) laying of seawater intake and discharge pipelines; (d) laying of chilled water distribution pipe networks; and (e) provision of connection facilities at user buildings at KTD. We invited tenders for the Phase III (Package A) (Phase IIIA) of the project in 2012–Q4 and obtained PWSC's support and FC's approval in May 2013 and June 2013 respectively for the increase in APE to \$3,145.9 million for implementing Phase IIIA works before awarding the respective contracts. The construction for Phase IIIA works commenced in 2013–Q3 for completion in 2018–Q2.

To tie in with the upcoming developments and infrastructure works at KTD, we target to invite tenders for the Phase III (Package B) (Phase IIIB) of the project in 2014–Q4 and to seek PWSC's support and FC's approval for further increasing the APE for implementing the Phase IIIB works before awarding the respective contracts. The construction is tentatively scheduled to commence in 2015–Q2 for completion in 2018–Q4 for Phase IIIB works.

## **Project Description:**

The proposed project is to construct a community services building in the existing car park of the Yuen Long Town Hall. The proposed scope of the project comprises (a) construction of a multi-storey community services building with a floor plate of about 600 square metres ( $m^2$ ). The total floor area will be approximately 3,000 m<sup>2</sup>; (b) provision of no less than 20 multi-purpose function rooms for meetings, classes and community activities. The room size varies from 40 m<sup>2</sup> to 300 m<sup>2</sup> each; (c) provision of a covered parking space for 10 private cars; (d) building services installations such as lift, air-conditioning, as well as electrical and fire services installations; and (e) associated builders' works and utilities. The construction is tentatively scheduled to commence in 2016–Q1 and for completion in 2017–Q4.

**Project Code and Title:** 7394CL—Sha Tin New Town—stage II : servicing and extension of Pai Tau Village in area 6A

Works Department: Civil Engineering and Development Department

#### **Project Description:**

The proposed project is to service and extend Pai Tau Village in area 6A of Sha Tin known as the Pai Tau and Sheung Wo Che Village Expansion Area (VEA) intended to provide land for small house sites and associated infrastructure. The approved scope of the project comprises (a) formation of 1.7 hectares of land; and (b) ancillary works including retaining walls, roads, sewerage, drainage and utility works.

The project was upgraded to Category A in June 1992 at an Approved Project Estimate (APE) of \$11.2 million. The construction works was originally planned to start in September 1992 for completion in September 1993. However, following the upgrading of the project to Category A, some difficulties on land resumption were encountered, and the project was put on hold. Further suspension of the project was decided by the Government in 1999 in view of the review on the small house policy.

It was subsequently decided by the Government that the two remaining VEAs with land resumed, namely the current project and the Ha Mei San Tsuen VEA, should not be further put on hold in view of the prolonged time of suspension. In reinitiating this VEA project, as a result of the upsurge in construction prices, design changes and additional infrastructure works including retaining walls, additional village house site, extension of emergency vehicular access and provision of natural terrain hazard mitigation measures in accordance with the new technical requirements, we expect that the existing APE would not be enough for carrying out the works of the project. We will invite tenders in end 2015 and seek approval from the Finance Committee to increase the APE before awarding the works contract. The construction is tentatively scheduled to commence in 2016–Q2 for completion in 2018–Q2.
