Agenda of the Public Works Subcommittee Meeting on 6 May 2015

I write to give notice of the agenda items of the Public Works Subcommittee (PWSC) meeting to be held on 6 May 2015. Attached please find a copy of the agenda for reference.

There are seven items on the agenda, including six items carried over from the last meeting held on 22 April 2015 and one new item which seeks to increase the approved project estimate (APE) of the Sludge Treatment Facilities (STF). Since the PWSC has not completed examination of item 1 "Kai Tak Multi-purpose Sports Complex" at the last two meetings, we have reviewed the urgency of the other items and would like to propose the following changes to the order of agenda items –

(a) advancing the West Kowloon Government Offices (WKGO) project from item 4 on the last agenda to item 2. The tender validity period of the contract for the construction of WKGO will expire on 25 June 2015. If funding approval from the Finance Committee (FC) is not available before the expiry of the tender validity period, the Government may have to re-tender the project which will lead to programme delay and possible increase in project cost. Subject to PWSC's support, we plan to submit the funding proposal for FC's consideration on 29 May 2015;

- (b) inserting the new item relating to the STF as item 4. This item seeks to increase the APE of the STF from \$5,154.4 million by \$209.9 million to \$5,364.3 million to cover the higher-than-expected price adjustment. The STF was upgraded to Category A in June 2009. The first phase of works was completed and the second phase is progressing well. Up to mid-April 2015, about \$4,790.8 million has been spent and the remaining fund will not be sufficient to cover a major capital payment to be made by October 2015. Hence, there is an urgent need to seek the additional funding within the current legislative session; and
- (c) moving the Refurbishment and Upgrading of Sha Tin Transfer Station (item 3 on the last agenda) to item 7.

Apart from the above, the order of the other items follows that of the agenda of the last meeting. We would be happy to provide further information, if required.
