2. <u>The Chairman</u> said that there was nothing special to report.

## III. Further business for the Council meeting of 19 November 2014

## (a) <u>Tabling of papers</u>

Report No. 3/14-15 of the House Committee on Consideration of Subsidiary Legislation and Other Instruments

(LC Paper No. CB(2)250/14-15 issued vide LC Paper No. CB(3)151/14-15 dated 13 November 2014)

3. <u>The Chairman</u> said that the Report covered one item of subsidiary legislation (i.e. L.N. 121), the period for amendment of which would expire at the Council meeting of 19 November 2014. No Member had indicated intention to speak on the subsidiary legislation.

4. <u>The Chairman</u> informed Members that Mr Michael TIEN had replaced his oral question, and Mr Christopher CHEUNG had given up his oral question slot which had been allocated to Dr Elizabeth QUAT.

5. <u>The Chairman</u> said that Mr James TO, Chairman of the Subcommittee on the above two Orders, had given notice to move a proposed resolution at the meeting to extend the scrutiny period of the two Orders to the Council meeting of 10 December 2014.

10. <u>The Chairman</u> said that the subject of the motion to be moved by Mr Gary FAN was "Adhering to the need to 'put Hong Kong people first' in formulating policies". The wording of the motion had been issued to Members.

11. <u>The Chairman</u> reminded Members that the deadline for giving notice of amendments, if any, to the motion to be moved by Mr Gary FAN was Wednesday, 19 November 2014.

### Report of the House Committee ("HC") on Consideration of Subsidiary Legislation

12. <u>The Chairman</u> invited Members to note the list tabled at the meeting (LC Paper No. CB(3)152/14-15), which contained eight items of subsidiary legislation the period for amendment of which would expire at the Council meeting of 26 November 2014. He reminded Members to indicate their intention by 5:00 pm on Tuesday, 18 November 2014 should they wish to speak on any of these items of subsidiary legislation.

### V. Reports of Bills Committees and subcommittees

#### (a) Report of the Bills Committee on Contracts (Rights of Third <u>Parties) Bill</u> (LC Paper No. CB(4)145/14-15)

13. <u>Mr Kenneth LEUNG</u>, Chairman of the Bills Committee, briefed Members on the deliberations of the Bills Committee as detailed in its report. Members noted that the Bills Committee agreed to the Committee stage amendments ("CSAs") proposed to be moved by the Administration and supported the resumption of the Second Reading debate on the Bill at the Council meeting of 26 November 2014.

#### (b) Report of the Bills Committee on Statute Law (Miscellaneous <u>Provisions) Bill 2014</u> (LC Paper No. CP(4)144/14, 15)

(LC Paper No. CB(4)144/14-15)

14. <u>Mr TAM Yiu-chung</u>, Chairman of the Bills Committee, briefed Members on the deliberations of the Bills Committee as detailed in its report. <u>Members</u> noted that the Bills Committee had no objection to the CSAs proposed to be moved by the Administration and the resumption of the Second Reading debate on the Bill at the Council meeting of 26 November 2014.

15. <u>The Chairman</u> reminded Members that the deadline for giving notice of CSAs, if any, proposed to be moved to the above two Bills was Monday, 17 November 2014.

# (c) Report of the Subcommittee on Food and Drugs (Composition and Labelling) (Amendment) (No. 2) Regulation 2014

(LC Paper No. CB(2)256/14-15)

16. <u>Miss Alice MAK</u>, Chairman of the Subcommittee, briefed Members on the deliberations of the Subcommittee as detailed in its report. <u>Members</u> noted that some members of the Subcommittee had indicated their intention to propose amendments to the length of grace period for different types of formula products and prepackaged food for infants and young children set out in the Amendment Regulation. However, as the motion to extend the scrutiny period of the Amendment Regulation could not be dealt with by the Council before the expiry of the 28 days' scrutiny period (i.e. the Council meeting of 22 October 2014), the period for amending the Amendment Regulation had expired at the said Council meeting. As such, it was technically not feasible for any Member to amend the Amendment Regulation.

(d) Report of the Subcommittee on Overseas Lawyers (Qualification for Admission) (Amendment) Rules 2014 (Commencement) Notice (LC Paper No. CB(4)147/14-15)

17. <u>Mr Dennis KWOK</u>, Chairman of the Subcommittee, briefed Members on the deliberations of the Subcommittee as detailed in its report. <u>Members</u> noted that the Subcommittee did not object to the commencement of the Overseas Lawyers (Qualification for Admission) (Amendment) Rules 2014 on 2 January 2015.

18. <u>The Chairman</u> reminded Members that as the deadline for amending the above Notice was the Council meeting of 10 December 2014, the deadline for giving notice of amendments, if any, to the Notice was Wednesday, 3 December 2014.

## VI. Position on Bills Committees and subcommittees

(LC Paper No. CB(2)249/14-15)

19. <u>The Chairman</u> said that as at 13 November 2014, there were 16 Bills Committees, seven subcommittees under HC and nine subcommittees on policy issues under Panels in action. One Bills Committee was on the waiting list. 20. <u>The Chairman</u> further said that as two vacant slots had become available after two Bills Committees had reported under agenda items V(a) and (b) above, the Bills Committee on District Cooling Services Bill on the waiting list could be activated.

VII. Nomination and election of Members for appointment to the Select Committee to Inquire into the Background of and Reasons for the Delay of the Construction of the Hong Kong section of the Guangzhou-Shenzhen-Hong Kong Express Rail Link

21. <u>The Chairman</u> said that at the last HC meeting, Members agreed to the procedure for the nomination and election of Members for appointment to the Select Committee, as set out in paragraphs 13 and 14 of as well as Appendix III to LC Paper No. CB(1)181/14-15.

22. <u>The Chairman</u> invited Members to make nominations for appointment to the Select Committee. A total of 14 valid nominations were made in the following order and the nominees were as follows -

23. As the number of valid nominations exceeded that required for appointment to the Select Committee, <u>the Chairman</u> said that a poll should be taken by using the Electronic Voting System.

24. <u>The Chairman</u> then ordered that a vote be taken on each of the 14 nominees. In respect of the vote taken on Mr LEUNG Kwok-hung, six Members (viz. Mr LEE Cheuk-yan, Ms Emily LAU, Mr Alan LEONG,

Mr MA Fung-kwok, Mr Dennis KWOK and Mr SIN Chung-kai) requested that their votes be taken out. The number of valid votes for Mr LEUNG Kwok-hung was accordingly adjusted. The numbers of votes obtained by the nominees were as follows –

25. <u>The Chairman</u> declared that the following 13 Members who obtained the highest numbers of votes were elected for appointment to the Select Committee –

27. <u>The Chairman</u> informed Members that Mr Martin LIAO and Mr Tony TSE were nominated for appointment as the Chairman and Deputy Chairman of the Select Committee respectively.

28. <u>The Chairman</u> further said that the chairmanship, deputy chairmanship and membership of the Select Committee would be submitted to the President for appointment.
