- 3. The House Committee formed three subcommittees at its meeting on 6 February 2015 to study respectively items (1) and (2), items (3) to (5), as well as item (6) in detail. The three Subcommittees reported their deliberations at the House Committee meeting on 13 March 2015 vide LC Paper Nos. CB(2)1002/14-15, CB(1)623/14-15 and CB(4)619/14-15 respectively.
