**Report No. 16/14-15 of the House Committee on Consideration of
Subsidiary Legislation and Other Instruments**

Purpose

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire at the Council meeting of 15 April 2015.

2. The House Committee has considered the following items of subsidiary legislation -

3. A subcommittee was proposed to be formed to study item (2) in detail at the House Committee meeting on 13 March 2015. Since only two Members have signified their intention to join the proposed subcommittee by the deadline for signification of membership, it cannot be formed by virtue of House Rules 21(b) and 26(f).

4. Regarding items (3) to (6), the House Committee formed a subcommittee to study the four items of subsidiary legislation in detail at its meeting on 27 February 2015. The Subcommittee made a verbal report at the House Committee meeting on 20 March 2015, and provided Members with a written report vide LC Paper No. CB(4)729/14-15 on 2 April 2015.

5. In respect of items (1), (7) and (8), the House Committee considered it not necessary to form any subcommittee to study these three items of subsidiary legislation.
