[Consultation Report and Proposals on the Method for Selecting the Chief Executive by Universal Suffrage]

- 2. <u>The Subcommittee</u> received views from 57 deputations/individuals attending the meeting, and noted three written submissions from other organizations/individuals which/who did not attend the meeting.
- 3. At 12:28 pm, Mr CHAN Chi-chuen drew the attention of the Chairman to the fact that a quorum was not present. The Chairman directed members to be summoned.
- 4. At 12:42 pm, the Chairman said that as he reckoned that a quorum would not be present by 12:43 pm (i.e. expiry of 15 minutes during which members were summoned), he proposed and members agreed that arrangements be made to convene another meeting at 2:30 pm in that afternoon to continue to receive views from deputations.
- 5. At 12:43 pm, the Chairman said that as a quorum was not present within 15 minutes after members had been summoned, he declared the meeting closed.

012724 - 013252	Chairman Mr CHAN Kam-lam Mr MUK Ka-chun	Mr CHAN Kam-lam considered that the strong aspiration of Hong Kong people for implementing universal suffrage for the CE election in 2017 should be met. He noted that the Proposals were generally supported by local academics as well as overseas politicians. The deputation agreed with Mr CHAN's view that CE should "love the country and Hong Kong" and be accountable to the Central Authorities and Hong Kong people because Hong Kong was not an independent country but a special administrative region of the State.	
013253 - 014321	Chairman Mr LEE Cheuk-yan Mr CHAN Chi-chuen Administration	Mr LEE Cheuk-yan considered that the Proposals, based on the Decision of the Standing Committee of the National People's Congress ("NPCSC") on 31 August 2014 ("2014 Decision of NPCSC"), would only give Hong Kong people "fake universal suffrage", and voters could only choose from candidates whose nomination process was completely controlled by the Central Authorities. Mr CHAN Chi-chuen pointed out that such a system would have no credibility at all as CE candidates nominated by the nominating committee ("NC") would not help ensure that the CE-elect would be accountable to the general public.	
014322 - 014736	Chairman Mr YIU Si-wing	Mr YIU Si-wing considered that the Hong Kong community would become more divided if the Proposals were voted down by the Legislative Council ("LegCo"), and the democratic development in Hong Kong would be delayed.	
014737 - 015237	Chairman Mr SIN Chung-kai Democratic Party	Mr SIN Chung-kai invited views from deputations on the unfairness of the nomination system under the framework of the 2014 Decision of NPCSC. The deputation believed that the 1 200 members of NC would conduct political screening to ensure that only those who were favoured by the Central Authorities could stand as candidates.	
015238 - 015754	Chairman Mr Michael TIEN	Mr Michael TIEN considered that a system that allowed Hong Kong people to elect the CE-elect was surely more democratic than the existing system that the CE-elect was only elected by the 1 200-member Election Committee. He pointed out that the timetable for attaining universal suffrage had not come by easily; and after the

015755 - 020258	Chairman Dr Priscilla LEUNG	implementation of universal suffrage for the CE election in 2017, the electoral method could be further refined, and would be developed in the light of the actual situation in the Hong Kong Special Administrative Region. Dr Priscilla LEUNG suggested that the Administration should explain to the community that implementing universal suffrage would not be able to resolve all the problems and livelihood issues. She stressed that a pragmatic approach should be adopted in taking forward constitutional development of Hong Kong.	
020259 - 021850	Chairman Miss CHAN Yuen-han Mr James TIEN Mr Steven HO	Miss CHAN Yuen-han, Mr James TIEN and Mr Steven HO considered that the strong aspiration of Hong Kong people for implementing universal suffrage for the CE election in 2017 should be met, thereby taking an important step forward in the constitutional development of Hong Kong. They considered that further efforts should be made in enhancing communication with Members of the pan-democratic camp in order to narrow the gap in views and strive for the endorsement of the Proposals.	
021851 - 022028	Chairman Administration	In response to the concerns raised by Members and deputations, the Administration emphasized that the Proposals, which were formulated after more than 16 months of extensive and in-depth discussions during the public consultations, were in strict compliance with the Basic Law and relevant Decisions of NPCSC. The Administration had made the best endeavour to strike a balance amongst the diverse views, to secure acceptance by a majority of the public, the LegCo, CE, as well as the Central Authorities, so that the aim of selecting CE by universal suffrage could be attained. The Administration called on Members to support the Proposals so as to meet the aspiration of the community for electing the next CE through "one person, one vote" in 2017, thereby taking an important step forward in the constitutional development of Hong Kong.
