### I. Election of Chairman and Deputy Chairman

<u>Dr Priscilla LEUNG</u>, the incumbent Chairman, invited nominations for the chairmanship of the Panel. <u>Mr Abraham SHEK</u> nominated Dr Priscilla LEUNG and <u>Dr CHIANG Lai-wan</u> seconded the nomination. <u>Dr LEUNG</u> accepted the nomination. As Dr Priscilla LEUNG was nominated, <u>Mr Dennis KWOK</u>, the incumbent Deputy Chairman, presided over the election of the chairmanship of the Panel.

- 2. <u>Ms Emily LAU</u> nominated Mr Dennis KWOK and <u>Mr James TO</u> seconded the nomination. <u>Mr KWOK</u> accepted the nomination. As Mr Dennis KWOK was nominated, <u>Mr James TO</u>, member of the highest precedence among members present, presided over the election of the chairmanship of the Panel.
- 3. Mr James TO called for other nominations. As there was no other

nomination, <u>Mr TO</u> announced that voting be conducted by secret ballot. After all members had cast their votes, <u>Mr TO</u> invited Mr Abraham SHEK and Ms Emily LAU who had nominated the two candidates to monitor the counting of votes.

4. <u>Mr James TO</u> announced that 14 and eight members voted for Dr Priscilla LEUNG and Mr Dennis KWOK respectively. <u>Mr James TO</u> declared that Dr Priscilla LEUNG was elected Chairman of the Panel for the 2014-2015 session. Dr Priscilla LEUNG then took the chair.

#### **Election of Deputy Chairman**

- 5. <u>The Chairman</u> called for nominations for the deputy chairmanship of the Panel.
- 6. <u>Ms Emily LAU</u> nominated Mr Dennis KWOK and <u>Mr Ronny TONG</u> seconded the nomination. <u>Mr KWOK</u> accepted the nomination.
- 7. <u>The Chairman</u> called for other nominations. As there was no other nomination, <u>the Chairman</u> declared that Mr Dennis KWOK was elected Deputy Chairman of the Panel for the 2014-2015 session.

### II. Schedule of meetings for the 2014-2015 session

8. <u>Members</u> noted a proposed schedule of regular meetings of the Panel for the 2014-2015 session, to be held on the fourth Tuesday of each month at 4:30 pm, tabled at the meeting. <u>The Chairman</u> said that as Mr Martin LIAO proposed to hold the regular meetings of the Panel at another timeslots, <u>the Chairman</u> directed the clerk to explore other timeslots for holding regular meetings of the Panel and to seek members' views on this before finalizing the schedule of meetings of the Panel for the 2014-2015 session. <u>Members</u> did not raise any queries.

- 11. <u>The Chairman</u> advised that she and the Deputy Chairman would shortly convene a meeting with the relevant bureau/departments to draw up a work plan for the Panel for the current session.
