# Legislative Council Panel on Public Service Conditioned Hours of Work for Model Scale 1 Grades

On 22 December 2014, Hon TANG Ka-piu and Hon KWOK Wai-keung wrote to the Panel Chairman, requesting information on the employment situation of the Model Scale 1 (MOD 1) Grades. The letter was subsequently referred to this Bureau by the Secretariat for follow-up. Having collated the relevant information, our responses are as follows.

# Additional financial implication and manpower requirement

As we have reiterated before, to ensure prudent use of public funds and the upkeep of the level of service to the public, as well as proper management of the civil service on parity grounds, all proposals of reduction of conditioned hours have to abide by the three prerequisites (i.e. cost-neutrality, no additional manpower, and maintaining the same level of service to the public) and the "same grade/rank, same conditioned hours of work" principle. Hence, we have not assessed the financial implication and additional manpower required for reducing the conditioned hours of work of all MOD 1 staff to 45 hours gross per week.

## Breakdown of the review findings

According to the review, the relevant bureaux/departments have identified around 1 500 staff whose conditioned hours of work could be reduced to 45 hours gross per week while meeting the three prerequisites but not complying with the "same grade, same conditioned hours of work" principle. Separately, the conditioned hours of work of around 40 staff could be reduced while complying with both the said prerequisites and principle. Members have requested the information of these staff pertaining to their grade/rank, number, average monthly salary, average monthly CSPF/MPF contribution, total expenditure on fringe benefits, number of working days per week, length of service and age.

Grade, number of staff, average monthly salary and number of working days per week

The breakdown provided to the Panel by the Administration in September 2014 in response to Members' request has already included the relevant information pertaining to grade and number of staff. See details at <u>Annex</u>.

Concerning salary, except for the Workman II grade whose mid-point salary is \$12,040 per month, the mid-point salary of the other MOD 1 grades is \$13,035 per month.

As for number of working days per week, over 90% of the approximately 40 staff concerned work five days a week while the remaining work either 5.5 days a week or on an alternate Saturday-off pattern. Of the around 1 500 staff concerned, about 72% work five days a week and the remaining 28% or so are on non-five-day work pattern, which includes 5.5/6 days a week, alternate Saturday-off or shift duty patterns.

Average monthly CSPF/MPF contribution, total expenditure on fringe benefits, length of service and age

In conducting the above-mentioned review, the Administration only requested the relevant bureaux/departments to provide information directly related to the review. No personal data of the staff in the relevant posts (e.g. their CSPF/MPF contribution, total expenditure on fringe benefits, length of service and age, etc) has been gathered. We regret that no such information can be provided.
