#### I. Election of Chairman and Deputy Chairman (if required)

<u>The Subcommittee</u> agreed that it was not necessary to re-elect the Chairman and Deputy Chairman for the Subcommittee in the 2014-2015 session.

# II. Research Report on Future Development of Retirement Protection in Hong Kong

- 2. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).
- 3. <u>The Subcommittee</u> received oral representations from 62 deputations on the Research Report on Future Development of Retirement Protection in Hong Kong ("the Research Report"), which was prepared by the research team led by Prof Nelson CHOW and released in August 2014. <u>Members</u> also noted that two organisations not attending the meeting had provided the Subcommittee with written submissions. <u>The deputations</u> expressed views on the Research Report and the future development of retirement protection in Hong Kong. Their major concerns and views are summarised below
  - in view of the increasing number of the elderly population (a) and one-third of the elderly living below the poverty line, it was high time for the implementation of universal retirement protection to safeguard the basic livelihood of the elderly. Having regard to the Chief Executive("CE")'s pledge in his election manifesto in respect of making improvement to retirement protection and the considerable fiscal reserve, the Government should implement the universal retirement protection scheme as soon as practicable. Under the scheme, a universal, non-means-tested old age monthly pension at about \$3,000 for all Hong Kong permanent residents aged 65 and above should be set up with tripartite contributions from the Government, employers and employees for replacement of the existing three-pillar retirement protection system in Hong Kong, namely the non-contributory social security system (made up of the Comprehensive Social Security

Assistance ("CSSA") Scheme, and the Social Security Allowance Scheme, including the Old Age Allowance ("OAA") and the Old Age Living Allowance ("OALA"), the Mandatory Provident Fund ("MPF") system and voluntary private savings. The inefficacies of the three-pillar retirement protection system included the following -

- (i) the labelling effect of the requirement to make declaration on non-provision of financial support by family members of the elderly applicants under the CSSA Scheme had deterred many vulnerable elders from seeking appropriate financial assistance;
- (ii) the effectiveness of the MPF system in providing adequate retirement protection in view of the limited amount of accrued benefits accumulated owing to the low contribution from low income, the arrangement of allowing severance payments and long service payments to be offset with MPF accrued benefits derived from employers' contributions, the low investment return, as well as high management and administration fees. In addition, there was concern that the current generation of elders, homemakers and unemployed persons were not covered by the employment-based MPF system that had been implemented only in late 2000; and
- (iii) given the need to meet the day-to-day living expenses, the low-income earners and homemakers could hardly save up for their retirement life;
- a non-means-tested monthly retirement pension should be (b) individual rights of all citizens and the subject of retirement protection should not be studied from the perspective of poverty alleviation. There was a further view that the old age pension should be taken as a token of respect for the elderly in recognition of their past contribution to the society. Taking into consideration the broad consensus among the community on the implementation of a universal retirement protection scheme which was projected to be financially viable in the Research Report, the Government should introduce universal sustainable non-means-tested a retirement protection scheme without further delay;

- (c) should a universal retirement protection scheme not be implemented, the ageing population would also impose a heavy burden on the public expenditure on the social security payments (including OAA and OALA); and
- (d) the Government should draw up a concrete timetable and a roadmap, including conducting public consultation on the findings and recommendations of the Research Report, for the implementation of universal retirement protection as soon as practicable and the relevant policy initiatives should be included in CE's 2015 Policy Address.
- 4. on the other Some deputations, hand, opposed to the implementation of universal retirement protection and considered public resources should be targeted at the elderly in need through means-tested social security system (such as the CSSA Scheme which served as a safety net for the needy). It was stressed that the finite public resources should be used in a prudent manner. Concern was raised about the financial sustainability of a universal retirement protection scheme and the long-term impact on the public finance. These deputations also expressed concern that to finance the implementation of a universal non-means-tested retirement protection scheme, both employees and employers would inevitably have to make extra contribution and extra profit tax would be levied on the business enterprises. There was a view that the proposed universal retirement protection scheme would be unfair to the younger generation who would need to make contribution for a long period of time before they could benefit from it.
- 5. <u>Members</u> shared the concerns raised by the majority of the deputations and strongly urged the Government to launch immediately a public consultation exercise on the findings and recommendations of the Research Report, as well as put forward a concrete proposal and an implementation timetable in CE's 2015 Policy Address.
- 6. In response to the views and concerns of deputations and members, Secretary for Labour and Welfare made the following responses -
  - (a) the Government attached great importance to the challenges brought about by an ageing population. As a matter of fact, poverty alleviation and elderly welfare were areas of work priority of the current Government. The Government had taken the initiative to commission Prof Nelson CHOW to conduct a research study on retirement protection;

- the Government was aware of the community's concern (b) about the follow-up to be taken by the Commission on Poverty ("CoP") and the Government in respect of the findings and recommendations in Research Report, which provided useful reference for future discussion on retirement protection. The Government adopted an open mind on the way forward for retirement protection. CoP had just been presented with the Research Report at its meeting on 20 August 2014. Given that retirement protection was a highly complex subject which would affect all Hong Kong and had far-reaching impact on sustainability and socio-economic developments in Hong Kong, members of CoP agreed that the subject had to be taken forward prudently and that more time was needed to examine the report and discuss relevant issues in depth. CoP would convene another meeting on 24 November 2014 to further discuss in detail the Research Report; and
- (c) views and concerns expressed by deputations and members on the Research Report and the future development of retirement protection in Hong Kong would be relayed to CoP for consideration.

#### III. Any other business

- 7. <u>The Chairman</u> said that the next meeting of the Subcommittee would be held after CoP had further discussed the Research Report. Members would be informed of the meeting date in due course.
- 8. The Chairman said that subject to members' views on the need for the Subcommittee to extend the period of its work and continue to operate in the 2014-2015 session, the Subcommittee should seek the endorsement of the Panel on Welfare Services and the approval of the House Committee of the proposal. Members generally considered that there was such a need. The Chairman said that the Clerk would prepare the relevant paper for members' consideration.

9. There being no other business, the meeting ended at 2:33 pm.
