INTRODUCTION

Section 29A of the Interpretation and General Clauses Ordinance (Cap. 1) empowers the Financial Secretary (which means also the Secretary for Financial Services and the Treasury by virtue of section 3 of Cap. 1) to vary fees which were previously fixed by subsidiary legislation made by the Chief Executive in Council. In exercise of the aforementioned power, the Secretary for Financial Services and the Treasury has made the Amendment Regulations at **Annexes A to M** to revise the fees specified in the relevant subsidiary legislation as set out below –

JUSTIFICATIONS

2. In line with the "user pays" principle, it is Government's policy that fees and charges of government services should in general be

set at levels sufficient to recover the full cost of providing the services. In the 2013-14 Budget Speech, the Financial Secretary emphasized the need to review fees and charges systematically for upholding the "user pays" principle, with priority given to those fees that had not been revised for years and did not directly affect people's livelihood, as well as items which had low cost recovery rates.

- 3. In this connection, the Department of Health (DH) has reviewed the statutory fees relating to the registration of healthcare professionals. These fees were either last revised between 2000 and 2006 or had not been revised since their introduction, and DH's costing review shows that their current cost recovery levels range from 11% to 116%. In order to achieve full cost recovery gradually and avoid a steep fee increase, we have adopted the following guidelines for the fee revision in our proposal
 - (a) for items with an existing cost recovery rate of less than 40%, adopt an increase of about 20%;
 - (b) for items with an existing cost recovery rate of 40% to 70%, adopt an increase of about 15%;
 - (c) for items with an existing cost recovery rate of over 70%, adopt an increase of about 10% or less; and
 - (d) for items with an existing cost recovery rate of over 100%, adjust downwards to the full cost recovery level.
- 4. Accordingly, we propose to adjust a total of 118 fee items as set out at **Annex N**. Among them, 117 fees are proposed to be increased by 7% to 20%, while the remaining fee (item 108 in **Annex N**) to be reduced by 14%. With the proposed fee levels, the cost recovery rates of these statutory fee items will be adjusted to the range of 13% to 100%.

THE AMENDMENT REGULATIONS

5. The Amendment Regulations at Annexes A to M seek to

revise the 118 fee items concerned and will come into effect on 1 January 2016.

EFFICIENCY IMPROVEMENT MEASURES

7. DH will continue to enhance efficiency and streamline procedures so as to contain the costs of providing the services.

IMPLICATIONS OF THE FEE ADJUSTMENTS

- 8. All the fees should have relatively little impact on the daily life of the general public or general business activities. If the adjustments to the 118 fee items are implemented, the estimated net increase in revenue is about \$3.5 million per annum.
- 9. The legislative amendments are in conformity with the Basic Law, including the provisions concerning human rights, and do not affect the binding effect of the relevant Ordinances.

PUBLIC CONSULTATION

10. We have sought the views of the bodies at **Annex O** on the

proposal to adjust the relevant fees. We have also consulted the Legislative Council Panel on Health Services on 20 April 2015. These bodies and the Panel raised no objection to the fee revision proposal.

PUBLICITY

11. A press release will be issued on 3 July 2015 when the Amendment Regulations are published in the Gazette. A spokesperson will be available to answer media enquiries.

Though the Licensing Examination has all along been run by the University of Hong Kong and the Chinese University of Hong Kong, as in the last fee revision exercise in 2006, the cost incurred by the two universities (including setting examination questions, providing examiners and testing candidates in hospital environment with patient participation) has not been factored into the unit cost computation in deriving the fee revision proposal. The existing cost recovery rates are computed based on the cost incurred by the Medical Council Secretariat in arranging the examination only. The percentage in brackets denotes the cost recovery rate if the computation methodology is changed to include the expenses incurred by the two universities. To avoid increasing the fees to a prohibitively high level which would discourage eligible candidates from sitting the Licensing Examination, we consider that the existing calculation methodology should remain unchanged for the time being. Nevertheless, this computation methodology would be reviewed in future when these examination fees have all been revised to a level close to the full recovery of the cost incurred by the Medical Council Secretariat.
