Action

I. Meeting with the Administration

[File Ref.: FHCR1/F/3261/92, LC Paper Nos. LS44/15-16, CB(2)1118/15-16(02) to (04), CB(2)1131/15-16(01), CB(2)1317/15-16(01), CB(2)1349/15-16(01) to (02), CB(2)1363/15-16(01) and CB(3)422/15-16]

The Bills Committee deliberated (index of proceedings attached at **Annex**).

Admin 2. The Bills Committee requested the Administration to:

- (a) provide the proposed legislative timetable to enable the Legislative Council to deal with the Bill before its prorogation on 16 July 2016;
- (b) provide details of the arrangements to be introduced by the Administration for the patient-related groups to elect representatives among themselves for appointment by the Chief Executive for filling the three additional lay member seats representing patients' interests in the Medical Council of Hong Kong ("the Medical Council"), including, among others, what would constitute a patient-related group. According to the Administration, the arrangements would not be specified in the legislation in order to allow flexibility of implementation;
- (c) consider, having taken into account members' various proposals of increasing the elected element in the composition of the Medical Council with a view to maintaining the current ratio of 1:1 between elected and appointed members, refining the Administration's latest proposal of converting the two existing appointed medical practitioner members nominated by the Hong Kong Academy of Medicine ("the Academy of Medicine") to two medical practitioner members to be elected in accordance with the rules and regulations to be devised by the Academy of Medicine in this regard;
- (d) advise the efforts made by the Administration in consulting the

medical sector and the patient groups, including information on the organizations being consulted, on its latest proposals concerning maintaining the ratio of elected and appointed members as well as the arrangements for nominating representatives to fill the four additional lay member seats in the Medical Council;

- (e) in respect of the nine bottlenecks of the existing complaints investigation and disciplinary inquiry mechanism of the Medical Council as identified by the Hong Kong Public Doctors' Association in its submission (LC Paper No. CB(2)1221/15-16(04)),
 - (i) provide information on the breakdown, by the nine bottlenecks, of the average time required by the Medical Council for the handling of complaint cases at different stages; and
 - (ii) advise the respective administrative measures for shortening the time required of the Medical Council for handling complaints as referred to in item (i) above, with a breakdown by those that could only be implemented upon the enactment of the Bill and those that could still be implemented even if the Bill was not passed;
- (f) in respect of the applications from persons whose names had been removed from the registers of medical practitioners for the restoration of their names to the relevant registers, provide information on the median time required for arranging inquiries of the Medical Council for the purpose of deciding whether to allow or refuse the applications in the past year and the number of scheduled inquiries which were postponed due to not having sufficient members to form a quorum; and
- (g) address the concern raised by members regarding the possible conflict of interest that might arise when the appointed or elected members of the Medical Council were from medical groups.
- 3. <u>The Administration</u> indicated that it would provide its proposed draft Committee stage amendments ("CSAs") to the Bill for consideration by the Bills Committee at the next meeting.
- 4. <u>Dr LEUNG Ka-lau</u> indicated his intention to move a CSA to the effect that the number of medical practitioner members and lay members in the

Medical Council would both be increased by four. The Chairman invited members who intended to propose CSAs to the Bill and wished their CSAs to be considered by the Bills Committee to forward their proposed CSAs to the Secretariat as early as practicable for consideration by the Bills Committee at its next two meetings.

		The Administration's advice that its initial thought was that in order for an organization to be eligible for nomination and voting in the election, the relevant patient groups and patient support groups would have to be recognized by credible patient-related platform(s) that had knowledge and experience in dealing with patient groups, say, the Hospital Authority ("HA"). The patient groups would be required to register with the electoral office during a specified registration period after the announcement of the election date.	
		In response to Mr Tommy CHEUNG, the Administration's affirmation that having regard to the principle of professional and academic autonomy, its latest proposal was to convert the two existing appointed seats of the Medical Council to be nominated by the Hong Kong Academy of Medicine ("the Academy of Medicine") for appointment by CE to two elected seats to be elected by the Academy of Medicine in accordance with its regulations or procedures. CE's appointment would not be required for the members elected by the Academy of Medicine.

The legislative proposal of increasing the number of lay members on the Medical Council was in response to the community's call for enhancing lay participation in the Medical Council. The above legislative proposal, together with the legislative proposals of enabling the Medical Council to set up more than one Preliminary Investigation Committee ("PIC") and increasing the total number of assessors from 14 to 34, would help shorten the time required by the Medical Council in	required

		The Administration's advice that it objected to the suggestion as the registered medical practitioners nominated by HKU and CUHK had a role to maintain professional competency of local medical graduates, whereas the registered medical practitioners nominated by HA had to provide views to the Medical Council from the perspective of the major public healthcare services provider. It should also be noted that the Academy of Medicine supported the Administration's proposal of converting the two existing appointed seats of the Medical Council to be nominated by the Academy of Medicine for appointment by CE to two elected seats to be elected by the Academy of Medicine in accordance with its regulations or procedures.

		Mr LEUNG Yiu-chung surmised that the reason why there was a relatively high percentage of registered medical practitioners concerned were found guilty of a disciplinary offence after an inquiry was because many complaint cases were not referred to the Medical Council for inquiries. He considered that to ensure that the complaint cases were handled at the pre-PIC stage (i.e. under initial consideration by the PIC chairman and deputy chairman) and PIC stage in an impartial manner, the Administration should further increase lay participation in the Medical Council.	
		The Chairman's enquiry as to whether there were cases whereby the chairman and deputy chairman of PIC considered the complaint concerned being groundless or frivolous and hence should not be proceeded further but the lay member of PIC held a contrary view.	
		The Administration's advice that a complaint would be dismissed only if the chairman, deputy chairman and the lay member of PIC reached a consensus that the complaint was groundless or frivolous, and should not proceed further. This apart, it was proposed under the Bill that at least one of the members forming the quorum of a meeting of PIC shall be a lay person i.e. a lay member of the Medical Council or a lay assessor.
