 Inland Revenue (Amendment) (No. 3) : Secretary for Financial Services and Bill 2015
 the Treasury The debate on the Second Reading of the above Bill, which was moved on 24 June 2015, resumed. After a Member and the public officer had respectively spoken, the President put the question on the Second Reading of the Bill, and the question was agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clauses 1 to 14 stand part of the Bill was proposed, put and agreed to.

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage without amendment. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading of the Bill was proposed, put and agreed to. The Bill was read the third time and passed.

 Clearing and Settlement Systems: Secretary for Financial Services and (Amendment) Bill 2015
 the Treasury

The Second Reading debate on the above Bill, which was moved on 4 February 2015, resumed. After Members and the public officer had respectively spoken, the President put the question on the Second Reading of the Bill, and the question was agreed to. The Bill was read the second time and committed to a committee of the whole Council.

The Council went into committee and considered the Bill. The question that clauses 1 to 4, 6 to 11, 13, 15, 16, 18, 19, 20, 22, 24, 25, 26, 30, 31, 32, 34, 35, 39, 42, 45 to 51, 55 to 63, 65, 66 and 67 stand part of the Bill was proposed, put and agreed to.

The question that clauses 5, 12, 14, 17, 21, 23, 27, 28, 29, 33, 36, 37, 38, 40, 41, 43, 44, 52, 53, 54 and 64 stand part of the Bill was proposed. The public officer moved amendments to the above clauses and spoke on the amendments. After Members had spoken, the question on the amendments was put and agreed to. The question that the above clauses as amended stand part of the Bill was proposed, put and agreed to.

New clauses 43A, 53A, 62A and 63A, and the new Division headings before new clauses 53A and 63A were read the first time. The public officer moved the Second Reading of the above new clauses and new Division headings and spoke on them. The question on the Second Reading of the above new clauses and new Division headings was proposed, put and agreed to.

New clauses 43A, 53A, 62A and 63A, and the new Division headings before new clauses 53A and 63A were read the second time. The public officer moved the addition of the above new clauses and new Division headings. The question on the addition was proposed, put and agreed to.
