The debate on the above motion, which was moved on 21 January 2016, continued. After Members and the public officer had respectively spoken, the question on the motion was put. The motion was negatived (details of division in **Appendix 1**).

### Committee stage

The Council went into committee to consider the Copyright (Amendment) Bill 2014. The question that clauses 4, 6, 8, 9, 13, 18, 19, 21 to 27, 30 to 35, 37, 41, 42, 43, 47, 48, 50, 52, 75, 76, 78 to 81, 83, 84, 86 and 89 stand part of the Bill was proposed. The committee proceeded to the first debate. Hon CHAN Kam-lam moved his first group of amendments as set out in the Official Record of Proceedings and spoke on the amendments. The Chairman ordered a joint debate on the relevant parts of clauses 18, 19, 24, 75 and 78, the original clause 76 and Hon CHAN Kam-lam's amendments. Members spoke in the debate. Hon WONG Yuk-man then moved a motion under Rule 40(4) of the Rules of Procedure that further proceedings of the committee of the whole Council be now adjourned.
