#### **Government Bill**

#### Resumption of Second Reading debate and Committee stage

- Appropriation Bill 2016 : The Financial Secretary

The Second Reading debate on the above Bill, which was moved on 24 February 2016, resumed. After the Financial Secretary and other public officers had spoken, the President put the question on the Second Reading of the Bill, and the question was agreed to (details of division in **Appendix 1**). The Bill was read the second time and committee to a committee of the whole Council.

(During the Committee stage of the Bill, the meeting was suspended at 7:57 pm on 20 April and resumed at 9:00 am on 21 April 2016.)

The Council went into committee and considered the Bill. In accordance with Rule 68 of the Rules of Procedure, the committee first considered the Schedule to the Bill. The Chairman proposed the question that the sums for the 10 heads, as set out in the Official Record of Proceedings, to which no amendments were proposed stand part of the Schedule. The committee proceeded to the first debate and Members spoke on the heads. Hon CHAN Chi-chuen then moved a motion under Rule 40(4) of the Rules of Procedure that further proceedings of the committee of the whole Council be now adjourned.

Appropriation Bill 2016: motion under Rule 40(4) of the Rules of Procedure that further proceedings of the committee of the whole Council be now adjourned

The Chairman's Deputy proposed the question on the motion. After Members had spoken, the question on the motion was put. The motion was negatived (details of division in **Appendix 2**).

The committee continued with the first debate. After Members had spoken, the question that the sums for the 10 heads stand part of the Schedule was put and agreed to (details of division in **Appendix 3**).

The committee proceeded to consider a total of 407 amendments, which involved 74 heads, proposed by 16 Members to the Bill as set out on the Agenda.

The committee commenced the second debate under the theme of "Rule of Law, Governance, Elections and District Administration", covering 163 amendments proposed by 12 Members to 23 heads as set out in the Official Record of Proceedings. Members spoke on the amendments. Hon CHAN Chi-chuen drew the attention of the Chairman's Deputy to the absence of a quorum. The Chairman's Deputy then directed the Members to be summoned.

## Next meeting

After 15 minutes had expired, a quorum was not present. The Council then resumed. The President adjourned the Council in accordance with Rule 17(2) of the Rules of Procedure until 11:00 am on 27 April 2016.

The Council was adjourned at 12:18 pm on 21 April 2016.
