(During the Committee stage of the Bill, the meeting was suspended at 7:57 pm on 27 April and resumed at 9:00 am on 28 April 2016.)

The Council went into committee to continue the consideration of the Schedule to the Bill. The committee continued the second debate under the theme of "Rule of Law, Governance, Elections and District Administration". After Members and a public officer had respectively spoken on the amendments, the second debate came to a close.

The committee commenced the third debate under the theme of "Poverty Alleviation, Welfare and Medical Services, Elderly Care, Public Health and Population Policy", covering 46 amendments proposed by 7 Members to 8 heads as set out in the Official Record of Proceedings. After Members and a public officer had respectively spoken on the amendments, the third debate came to a close.

The committee commenced the fourth debate under the theme of "Land, Housing, Transportation, Environment and Conservation", covering 69 amendments proposed by 9 Members to 16 heads as set out in the Official Record of Proceedings. Members spoke on the amendments. Hon CHAN Chi-chuen drew the attention of the Chairman to the absence of a quorum. The Chairman then directed the Members to be summoned.

After 15 minutes had expired, a quorum was not present. The Council then resumed. The President adjourned the Council in accordance with Rule 17(2) of the Rules of Procedure until 11:00 am on 4 May 2016.
