The Council went into committee and considered the Bill. The question that clauses 1 to 8 and 10 stand part of the Bill was proposed, put and agreed to.

The question that clauses 9 and 11 stand part of the Bill was proposed. Hon James TO had given notice to move his amendments to amend clauses 9 and 11. The Chairman ordered a joint debate on the relevant parts of the original clauses and the amendments thereto. After Members and the pubic officer had respectively spoken, the question on the amendments was put and not agreed to (details of division in **Appendix 1**). The question that clauses 9 and 11 stand part of the Bill was put and agreed to (details of division in **Appendix 2**).

The Council then resumed. The public officer reported that the Bill had passed through the Committee stage without amendment. The Bill was ordered to be set down for Third Reading under Rule 59 of the Rules of Procedure. The question on the Third Reading of the Bill was proposed. After Members had spoken, the question was put and agreed to (details of division in **Appendix 3**). The Bill was read the third time and passed.

Financial Institutions (Resolution) Bill

After a Member and the public officer had respectively spoken, the question was put and agreed to.

The question that clauses 2, 5, 19, 22, 24, 27 to 30, 32, 33, 35, 37, 47, the heading of Subdivision 5 of Division 1 of Part 5, clauses 57 to 65, 69, 74, 75, 81, 88, 89, 91, 95, 102, 103, 104, 114, 121, 123, 130, 138, 140, 143, 144, 151, 163, 171, 172, 186, 190, 191, 194, 199, 204, 207, 212, 216, 217, 218, 221, 227 and 239 stand part of the Bill was proposed. The public officer moved amendments to the above clauses and heading, and spoke on them. After a Member had spoken, the question on the amendments was put and agreed to. The question that the above clauses and heading as amended stand part of the Bill was proposed, put and agreed to.

New clauses 110A, 126A, 212A, 216A and 229A were read the first time. The public officer moved the Second Reading of the above new clauses and spoke on them. The question on the Second Reading of the above new clauses was proposed, put and agreed to.

New clauses 110A, 126A, 212A, 216A and 229A were read the second time. The public officer moved the addition of the above new clauses to the Bill. The question on the addition of the new clauses was proposed, put and agreed to.

The question that Schedules 1 and 7 stand part of the Bill was proposed, put and agreed to.

The question that Schedules 2 to 6, 8 and 9 stand part of the Bill was proposed. The public officer moved amendments to the above schedules and spoke on them.
