#### **Council meeting of 14 October 2015**

## Amendments to motion on "Seizing the opportunities brought about by 'One Belt One Road' and seeking new directions for Hong Kong's economy"

Further to LC Paper No. CB(3) 9/15-16 issued on 2 October 2015, four Members (Hon Christopher CHEUNG, Hon CHAN Kam-lam, Hon NG Leung-sing, and Hon MA Fung-kwok) have respectively given notice of their intention to move separate amendments to Hon Martin LIAO's motion on "Seizing the opportunities brought about by 'One Belt One Road' and seeking new directions for Hong Kong's economy" scheduled for the Council meeting of 14 October 2015. As directed by the President, the respective amendments will be printed in the terms in which they were handed in on the Agenda of the Council.

- 2. The President will order a joint debate on the above motion and the four amendments. To assist Members in debating the motion and the amendments, I set out below the procedure to be followed during the debate:
  - (a) the President calls upon Hon Martin LIAO to speak and move his motion;
  - (b) the President proposes the question on Hon Martin LIAO's motion;
  - (c) the President calls upon the four Members who wish to move amendments to speak in the following order, but no amendment is to be moved at this stage:
    - (i) Hon Christopher CHEUNG;
    - (ii) Hon CHAN Kam-lam;

- (iii) Hon NG Leung-sing; and
- (iv) Hon MA Fung-kwok;
- (d) the President calls upon the public officer(s) to speak;
- (e) the President invites other Members to speak;
- (f) the President gives leave to Hon Martin LIAO to speak for the second time on the amendments:
- (g) the President calls upon the public officer(s) to speak again;
- (h) in accordance with Rule 34(5) of the Rules of Procedure, the President has decided that he will call upon the four Members to move their respective amendments in the order set out in paragraph (c) above. The President invites Hon Christopher CHEUNG to move his amendment to the motion, and forthwith proposes and puts to vote the question on Hon Christopher CHEUNG's amendment;
- (i) after Hon Christopher CHEUNG's amendment has been voted upon, the President deals with the other three amendments; and
- (j) after all amendments have been dealt with, the President calls upon Hon Martin LIAO to reply. Thereafter, the President puts to vote the question on Hon Martin LIAO's motion, or his motion as amended, as the case may be.
- 3. For Members' reference, the terms of the original motion and of the motion, if amended, are set out in the **Appendix**.

# Motion debate on "Seizing the opportunities brought about by 'One Belt One Road' and seeking new directions for Hong Kong's economy" to be held at the Council meeting of 14 October 2015

#### 1. Hon Martin LIAO's original motion

That the 'Silk Road Economic Belt' and the '21st Century Maritime Silk Road' ('One Belt One Road') is a major strategy for the country's future long-term development, and is a new opportunity for promoting multi-faceted co-operation in regional economies and market development around the world; in this connection, this Council urges the SAR Government to lead and support various industries to seize the opportunities in a timely manner, and seek new directions for the sustainable development of Hong Kong's overall economy.

#### 2. Motion as amended by Hon Christopher CHEUNG

That the country is seeking a new pathway for economic development, and the 'Silk Road Economic Belt' and the '21st Century Maritime Silk Road' ('One Belt One Road') is a major strategy for the country's future long-term development, and is a new opportunity for promoting multi-faceted co-operation in regional economies and market development around the world; in this connection, this Council urges the SAR Government to lead and support various industries to seize the opportunities in a timely manner, and seek new directions for the sustainable development of Hong Kong's overall economy, including striving for setting up the headquarters of the Asian Infrastructure Investment Bank in Hong Kong, so as to consolidate Hong Kong's status as an international financial centre, thereby attracting more multinational enterprises to issue bonds and get listed in Hong Kong and making Hong Kong's financial market more vibrant.

#### 3. Motion as amended by Hon CHAN Kam-lam

That during his visits to countries in Central Asia and Southeast Asia in September and October 2013, State President XI Jinping respectively put forward the vision of jointly building the 'Silk Road Economic Belt' and the

'21st Century Maritime Silk Road' ('One Belt One Road'); 'One Belt One Road' is a major strategy for the country's future long-term development, and is a new opportunity for promoting multi-faceted co-operation in regional economies and market development around the world; in this connection, this Council urges the SAR Government to lead and support various industries to seize the opportunities in a timely manner, and seek capitalize on Hong Kong's own advantages in modernized services to promote the development of Hong Kong's major industries of trade and logistics, finance, tourism, professional services and information technology, etc., with a view to providing innovative and high quality services for the Asian Infrastructure Investment Bank and related projects of the Silk Road Fund under the development strategy of 'One Belt One Road', and seeking new directions for the sustainable development of Hong Kong's overall economy.

#### 4. Motion as amended by Hon NG Leung-sing

That the 'Silk Road Economic Belt' and the '21st Century Maritime Silk Road' ('One Belt One Road') is a major strategy for the country's future long-term development of its own economy and external economic and trade activities, and is a new opportunity for promoting multi-faceted co-operation in regional economies and market development around the world; in this connection, this Council urges the SAR Government to lead and support various industries to seize the opportunities in a timely manner, and seek give play to Hong Kong's unique advantages as an international financial centre as well as its role as a 'super-connector' between the Mainland and the world, with a view to exploring new development potentials and seeking new directions for the sustainable development of Hong Kong's overall economy.

#### 5. Motion as amended by Hon MA Fung-kwok

That the 'Silk Road Economic Belt' and the '21st Century Maritime Silk Road' ('One Belt One Road') is a major strategy for the country's future long-term development, and is a new opportunity for promoting multi-faceted co-operation in regional economies and market development around the world; in this connection, this Council urges the SAR Government to lead and support various industries to seize the opportunities in a timely manner, and seek not only implement the suggestions made by the Chief Executive at the Annual

Conference of Boao Forum this year to develop Hong Kong into the fundraising hub, offshore Renminbi hub, trade and investment hub, hub for service professionals as well as logistics and transportation hub under the 'One Belt One Road' initiatives, but also take the opportunities brought about by 'One Belt One Road' to help promote the development of local culture and arts and the creative industry, with a view to seeking new directions for the sustainable development of Hong Kong's overall economy.
