

**Eastern Harbour Crossing Legislation (Amendment) Bill 2015**  
**Debate and voting arrangements**

**Main object of the Bill :** To amend the Road Tunnels (Government) Ordinance (Cap. 368) (“Ordinance”) and its subsidiary legislation to extend their application to the Eastern Harbour Crossing (“EHC”) and incorporate the existing tolls chargeable under the Eastern Harbour Crossing Ordinance (Cap. 215).

**First debate : Clauses with no – Clauses 1 to 6, 8, 9, 11 to 18 and 21 to 28 amendment**

**Voting :** To vote on the above clauses standing part of the Bill

**Second debate : Clauses with amendments – Clause 7, Heading of Part 4, clauses 19 and 20 proposed by Hon WONG Yuk-man and the Secretary for Transport and Housing (“STH”)**

Joint debate on the original clauses and the amendments thereto.

**Debate theme : Textual amendments to the above clauses**

*Hon WONG Yuk-man’s amendments:*

**Clause 7**

- To amend the proposed regulation 3(1B) of the Road Tunnels (Government) Regulations (Cap. 368A) (“Regulations”) in clause 7(2) to replace “Without prejudice to” with “Without affecting”.

**Clause 20**

- To amend the Chinese text of the definition *EHC By-laws* in section 1 of the proposed Schedule 2 to the Ordinance in clause 20 to replace “指在緊接” with “指緊接”.

*STH’s amendments:*

**Heading of Part 4, clauses 19 and 20**

- To amend the Chinese texts of Part 4 and the following clauses of the Bill to replace “過渡性” with “過渡”: Heading of Part 4, the proposed heading of section 24 and section 24 of the Ordinance in clause 19, and the proposed headings of Schedule 2 and section 4 of Schedule 2 to the Ordinance in clause 20; and
- To amend the Chinese texts of the proposed sections 2 and 3 of Schedule 2 to the Ordinance in clause 20 to replace “干” with “所” (i.e. to replace “干犯” with “所犯”).

**Third debate : Clause with five – Clause 10 amendments proposed by Hon WU Chi-wai**

Joint debate on the original clause and the amendments thereto.

**Debate theme : Specifying a date on which EHC tolls will cease to have effect**

**Clause 10**

- Hon WU Chi-wai proposes five amendments which seek to respectively amend clause 10 by adding a sunset clause immediately after regulation 12(1) of the Regulations to the effect that the proposed “Part 3 Tolls (for EHC)” of Schedule 2 to the Regulations (to be added by clause 18 of the Bill) will cease to have effect at the midnight on the following dates respectively:

First amendment	: 31 January 2018
Second amendment	: 31 July 2018
Third amendment	: 31 July 2019
Fourth amendment	: 31 July 2020
Fifth amendment	: 2 September 2023

**Fourth debate : STH's amendment to the long title of the Bill**

**Debate theme : Textual amendment to the long title**

- To amend the Chinese text of the long title to replace “過渡性” with “過渡”.
