Mr Kenneth LEUNG, Chairman of the Establishment Subcommittee ("ESC") in office, chaired the meeting. He informed members that the purpose of the meeting was to elect the Chairman and Deputy Chairman of ESC for the 2015-2016 session.

Election of Chairman

- 2. <u>Mr Kenneth LEUNG</u> invited nominations for the chairmanship for the 2015-2016 session.
- 3. Mrs Regina IP was nominated by Mr TAM Yiu-chung and the nomination was seconded by Dr CHIANG Lai-wan. Mrs Regina IP accepted the nomination.
- 4. Mr Kenneth LEUNG was nominated by Mr Alan LEONG and the nomination was seconded by Dr Kenneth CHAN. Mr Kenneth LEUNG accepted the nomination.
- 5. <u>Mr SIN Chung-kai</u>, the Deputy Chairman in office, took over from Mr Kenneth LEUNG to preside over the election. He asked if there were other nominations. There was no other nomination.
- 6. <u>Dr Helena WONG</u> requested that the candidates be given time to present their platforms. <u>Mr SIN Chung-kai</u> agreed and directed that each candidate be given one minute to introduce his/her platform, to be followed by questions from members. <u>Mrs Regina IP</u> and <u>Mr Kenneth LEUNG</u> made their respective presentations, and responded to questions put forward by <u>Ms Emily LAU</u> and <u>Dr Helena WONG</u>. (A verbatim transcript of the presentation of platforms and answering of questions is in the **Appendix**.)
- 7. Mr SIN Chung-kai announced a vote by secret ballot. Of the members present for voting, 24 voted for Mrs Regina IP and 15 voted for Mr Kenneth LEUNG. Mrs Regina IP was declared Chairman of ESC for the 2015-2016 session.

Election of Deputy Chairman

8. <u>Mrs Regina IP</u> presided over the election of Deputy Chairman. She invited nominations for the deputy chairmanship. Mr WONG Kwok-kin was nominated by <u>Dr CHIANG Lai-wan</u> and the nomination was seconded by <u>Mr CHAN Kam-lam</u>. <u>Mr WONG Kwok-kin</u> accepted the nomination.

- 9. Mr Kenneth LEUNG was nominated by Ms Cyd HO and the nomination was seconded by Ms Emily LAU. Mr Kenneth LEUNG accepted the nomination. There was no other nomination.
- 10. <u>Dr Helena WONG</u> requested that the candidates be given time to present their platforms. <u>The Chairman</u> agreed and directed that each candidate be given one minute to introduce his platform. <u>Mr WONG Kwok-kin</u> and <u>Mr Kenneth LEUNG</u> made their respective presentations. (A verbatim transcript of the presentation of platforms is in the **Appendix**.)
- 11. <u>The Chairman</u> announced a vote by secret ballot. Of the members present for voting, 24 voted for Mr WONG Kwok-kin and 16 voted for Mr Kenneth LEUNG. Mr WONG Kwok-kin was declared Deputy Chairman of ESC for the 2015-2016 session.

12. <u>The Chairman</u> said that the schedule of ESC meetings for the 2015-2016 session would be issued to members after the meeting.

黃碧雲議員:請發表一下政綱。

單仲偕議員:按照財委會習慣,每人 1 分鐘時間,介紹自己。 需要發問的議員請舉手。由於時間所限,需要設定時限。首先 請葉劉淑儀議員用 1 分鐘時間發表選舉政綱。

葉劉淑儀議員:我想黃碧雲議員有點誤會 — 並不需要 — 出任法定委員會主席並非直選,無需要政綱。身為法定委員會的主席,首要是有效率、有效地主持會議、公正不阿,無需要搞太多政治化的政綱。

單仲偕議員:梁繼昌議員。

梁繼昌議員:去年大家都見到我主持會議,亦見到政府提交的所有項目,其實都經過本小組委員會詳細討論。我們亦盡了應有的責任,監察政府。而且我必須指出,有些非常困難的職位、有爭議性的職位,例如禁毒處的職位,亦包括高永文局長開設有關電子醫療系統的職位,我們都經過多方面斡旋,令到政府或者議員能夠使到該等職位順利開設。所以我覺得,有效率主持會議之餘,亦要令到所有議員有足夠時間發問,以及盡量發揮議員監察政府、向市民負責的責任。謝謝。

單仲偕議員:秘書處會就這個環節擬備逐字紀錄本。提問議員 請舉手。

單仲偕議員:有兩位。每人兩分鐘,連問、連答。劉慧卿議員。

劉慧卿議員:多謝主席。

主席,我想問葉劉淑儀議員,她剛才說做主席最重要是 她說不要政治化。我相信葉太在議會那麼長時間,都知道議會 就是一個很政治化的場合,這個沒有問題;大家表達大家的立 場、大家去辯論,最終去投票。人事編制小組委員會就是審議 政府加位的建議 —— 有時是減位,不過很少 —— 所以也是 市民非常關注的。

她說要有效率、有效地主持會議,這即是甚麼意思呢?即是很快、很迅速便全部通過?抑或真的會 —— 第一、當然要官員很清晰地在文件交代其建議,以及要真正回答議員的問題,亦好像剛才梁繼昌議員 —— 即上屆主席 —— 所說的,要給時間議員發問,葉太會不會承諾這樣做呢?

單仲偕議員:葉太。

葉劉淑儀議員:主席,立法會顧名思義是一個立法組織,當然有很多機會給議員發表他們的政治意見,亦有很多冗長的辯

論。但是,身為法定委員會主席,一定要公正不阿,以及處理程序要有相當效率。做主席要有效率這一點,過往法官就立法會主席"剪布"的裁決中說得很清楚:作為主席, preside over 一個 meeting,包括有責任確保會議順利進行,當然亦包括給予所有同事足夠時間發問問題,以及給予時間官員回答問題。劉議員無須擔心。

單仲偕議員:黃碧雲議員。

黃碧雲議員:主席,剛才我問葉太......兩位候選人政綱,葉太一句就反駁過來:問甚麼?何須問?根本就不懂事的。是否這個意思?(眾笑)

我覺得這是一個很差的主席候選人的做法。何須政綱?這是 很傲慢的態度。我覺得這是很差的,是公民教育的反面教材。 所有候選人都應該要坦然面對所有投票人對他們的質詢。我只 是問你有甚麼政綱,並沒有挑釁你。你前來參選,票在我手, 為甚麼要投票給你,或不投票給你,而是投票給他?你當然要 交代。你現在是說問也不能問,日後由你主持會議,葉太,我 們是否不可以發問呢?純粹是主持會議的話,隨便一個人就可 以了,為甚麼要找你呢?
