Establishment Subcommittee Follow-up to meeting on 3 February 2016

EC(2015-16)14

In respect of the captioned proposal to retain one supernumerary post of Principal Economist (D2) in the Economic Analysis Division ("EAD") of Economic Analysis and Business Facilitation Unit under the Financial Secretary's Office, the Administration is requested to provide:

- (a) a list of economic assessments and studies conducted respectively by the five sections in EAD in the past few years;
- (b) a list of major economic assessments and studies conducted by Government bureaux and departments, including the Central Policy Unit, the Commerce and Economic Development Bureau, the Environment Bureau, and FSTB in the past few years; and
- (c) in respect of (b) above, if EAD has participated in the assessments and studies concerned, information on the division of work between EAD and the relevant bureaux and departments.

The reply made by the Economic Analysis and Business Facilitation Unit (EABFU) under the Financial Secretary's Office is as follows:

- (a) The <u>Annex</u> lists out the economic assessments and studies conducted by the five sections in the Economic Analysis Division (EAD) in the past few years, including the regular and topical studies under each area, as well as economic analyses and economic impact assessments on specific policies concerned.
- (b) After the meeting on 3 February, we have made relevant enquiry to all bureaux. All the bureaux replied that they did not conduct any internal or commissioned independent economic studies or analyses in 2015. In case they need any economic assessment in a policy deliberation, they would seek analytical support from the Government Economist's team.

Apart from Government bureaux and departments, the Hon. Members

also specifically enquired about the research work of the Central Policy Unit (CPU) and the Hong Kong Monetary Authority (HKMA). CPU's reply indicated that there is no economist in CPU. It had commissioned a university to undertake an independent study titled "Study on The Impact of the Hong Kong-Zhuhai-Macao Bridge on Regional Economic Development" during July 2014 to October 2015. One of the key focuses of this research was to analyse the impact mechanism of the Bridge on regional development. This report is still under review. CPU will examine various completed research reports from time to time and upload those that are suitable for release to the website (http://www.cpu.gov.hk/en/research_reports/index.html).

As for the HKMA, it has a Research Department specifically responsible for conducting analyses. There are also academic research through funding the Visiting Scholars Programme under the Hong Kong Institute for Monetary Research. HKMA expressed that its analyses and research studies are mainly focussed on global monetary and financial stability issues, as well as assessing the potential risks posed to Hong Kong's monetary and financial stability by economic and financial market developments in the major advanced countries, the Asia-Pacific region and the Mainland China. The research and analyses released by HKMA in the past few years are published on the following website (http://www.hkma.gov.hk/eng/publications-and-research/research/). HKMA will exchange views with EABFU from time to time on various macroeconomic analyses, including economic data for analytic and research purposes.

(c) In policy formulation process, various Government bureaux will take into account a whole range of factors, of which the associated economic implications are one such factor. As such, the division of work between bureaux/departments and EAD on analyses and economic impact assessments of specific policies concerned is rather clear. As mentioned above, different bureaux and departments would seek the relevant analytical support from EABFU whenever such need arises from the policy deliberation, while EAD would purport to provide the necessary economic analyses, assessments and professional advice based on objective data. The economic assessments and analyses with EAD's key involvement in relevant policy work under different bureaux over the past few years are listed in the **Annex**.
