Subhead 000 - Operational expenses

- The Chairman advised that agenda item FCR(2016-17)15 was to seek approval from the Finance Committee ("FC") for the recommendation of the Establishment Subcommittee made at its meeting held on 29 February 2016, i.e. the recommendation made in EC(2015-16)14, to retain a supernumerary Principal Economist ("Pr Econ") post in the Economic Analysis Division ("EAD") of the Economic Analysis and Business Facilitation Unit ("EABFU") under the Financial Secretary's Office for a period of three years, so as to strengthen support at the directorate level in enhancing the economic analytical and research capacity in the policy areas of population, poverty and welfare. Some members requested separate voting for the recommendation at the FC meeting.
- 8. Mr WONG Yuk-man and Mr Albert HO were concerned about the work priorities and direction of the supernumerary Pr Econ post ("supernumerary post"). Mr Albert HO argued that the supernumerary post should work on three issues, namely resolving the problems of poverty, disparity between the rich and the poor and stagnant social mobility; formulate objectives to combat poverty on the basis of the information as reflected by the poverty line; and studies the basic needs for living with dignity with reference to the International Covenant on Economic, Social and Cultural Rights, with a view to allowing the Administration to review the inadequacy of its welfare policy and seek improvements. Dr Fernando CHEUNG enquired how

economic analyses could enable the supernumerary post to improve the problems of disparity in wealth distribution, poverty among individual social classes (such as ethnic minorities) and lack of opportunities for upward social mobility for young people. Mr LEUNG Kwok-hung expressed concern about the tendency of poverty among the elderly population. Mr Albert CHAN and Mr LEUNG Kwok-hung were of the view that the poverty alleviation work of the Administration was ineffective.

- In response, Government Economist ("G Econ") advised that the 9. supernumerary post would be responsible for conducting economic analyses on the areas of population, poverty alleviation and welfare policy. poverty data analyses had been conducted since the establishment of the official poverty line in 2013, which allowed the Government to master more information about the forms and manners by which poverty was manifested and their underlying causes, and give policy steers to the Administration for formulation of poverty alleviation policies. An example was the Low-income Working Family Allowance Scheme, which was designed on the basis of the objective analyses of the poverty situation reports and aimed to relieve the burden on low-income working families by encouraging self-reliance and granting more allowance to those working more. The supernumerary post would also be responsible for overseeing the study on the earnings mobility of recent post-secondary graduates from grass-roots families, as well as topical studies on the forms of poverty among ethnic minorities, the disabled, new arrivals and single-parent families.
- 10. <u>G Econ</u> pointed out that, regarding the future work arrangements, the holder of the supernumerary post would further conduct in-depth analysis of the expenditure pattern of the poor or low-income households (including the expenditure pattern of the elderly) based on the latest Household Expenditure Survey with a view to identifying social groups in need of care, examining the underlying causes of their poverty, and determining whether there were changes in the forms of their poverty. Furthermore, in 2017, the holder of the post would, on the basis of the results of the 2016 Population By-census which was to be conducted soon, examine the income conditions of various groups and strata subsequent to the introduction of statutory minimum wage ("SMW"), with a view to determining whether income disparity had narrowed over the past five years. That would be one of the future work priorities of the supernumerary post.

- 11. <u>Ms Emily LAU</u> believed that the outsourcing policy of the Administration was one of the causes of the problem of working poverty. <u>Mr Tommy CHEUNG</u> opined that the introduction of minimum wage had made it even harder for small and medium enterprises to carry on their businesses.
- G Econ pointed out that a dedicated team formed under EABFU was responsible for providing economic research and analyses to the Minimum Wage Commission ("MWC") and supporting MWC to review and make recommendations on the SMW rate based on an evidence-based approach, with a view to safeguarding low-income employees and improving treatment of the employees. She advised that where necessary, EABFU would, at the request of relevant government departments, provide economic assessments and analytical support in respect of the outsourcing policy. In response to the remark of Mr Tommy CHEUNG, G Econ advised that the Government had been mindful of the impact of introduction of SMW on small and medium enterprises and their ability in coping with SWM. EABFU had been conducting impact assessments on SMW in light of the functions and analytical needs of MWC by striking an appropriate balance between the objectives of forestalling excessively low wages and minimizing the loss of low-paid jobs while maintaining Hong Kong's economic growth and competitiveness in an impartial manner based on objective data. At the request of MWC, assessments had been made on the possible ripple effects of an increased SMW rate.
- 13. At 6:03 pm, the Chairman advised that the two funding proposals FCR(2016-17)15 and FCR(2016-17)16 were submitted by the Administration to FC for retention and creation of posts in EABFU. The Chairman suggested combined discussion and separate voting of the two proposals. Members agreed to the suggestion of combined discussion.
- The Chairman advised that agenda item FCR(2016-17)16 was to seek approval from FC for the recommendations of the Establishment Subcommittee made at its meeting held on 2 March 2016, i.e. the recommendations made in EC(2015-16)13, including the creation of a new rank and permanent post of Government Economist (D5) and the deletion of the existing rank and permanent post of Government Economist (D4) as an offset; and the creation of a new rank and permanent post of Deputy Government Economist (D3), so as to strengthen directorate support in EABFU under the Financial Secretary's Office. Some members requested separate voting for the recommendations at the FC meeting.

- 15. Mr WU Chi-wai enquired whether EABFU's research findings would be made available to the public and whether the public could obtain the raw data used for research purposes. G Econ replied that the relevant macroeconomic analyses and data had always been publicly available in a transparent manner. For instance, during the past five years, as many as 150 topical research papers on broad direction of macro-economy and relevant topical issues had been compiled by EABFU and all of them were available for public access on EABFU's website. The public could also request the raw data used for compiling those papers from EABFU as long as the data requested did not contain personal privacy and sensitive information. G Econ added that for data originating from other policy bureaus or departments, the public had to direct their request to the policy bureaus or departments concerned.
- 16. Ms CHAN Yuen-han and Mr TANG Ka-piu expressed support for the funding proposals. Ms CHAN suggested inclusion of social factors as consideration in EABFU's researches. While appreciating Ms CHAN's concern, G Econ advised that there were difficulties in conducting quantitative analysis involving social factors at the present stage. On the one hand, such researches would be beyond the scope of economic analysis. On the other hand, the data involved were very complicated. For instance, analysis on relationship between health status and working hours of employed persons and their medical expenditures would normally require long-term collection of data, which could also involve other personal factors (such as living habits). Nevertheless, if policy bureaux or relevant committees considered it necessary to conduct assessments in that aspect in the future, EABFU might, with the support of objective data, provide technical support under relevant analytical framework. G Econ further advised that in the experience of the Standard Working Hours Committee, qualitative views were no less important than results of quantitative analyses. As evident from the newly published consultation document on working hours policy directions, there was no shortage of discourse on social factors in the document.
- 17. Mr TANG Ka-piu expressed concerned on the direction of EABFU's research on abolition of the offsetting arrangement under the Mandatory Provident Fund. Dr CHIANG Lai-wan expressed concern about mismatches in human resources. G Econ advised that it took time for EABFU to collate and consolidate information for Mr TANG's enquiry. Upon completion of the above-mentioned study on earnings mobility of recent post-secondary graduates from grass-roots families, EABFU had submitted the recommendations to relevant policy bureaux, and it would soon release a study report. On the other hand, EABFU would continue to enhance its work regarding analyses of manpower demand in different sectors.

- 18. At 6:59 pm, Mr LEUNG Kwok-hung moved without notice a motion under paragraph 39 of the Finance Committee Procedure to adjourn the discussion on FCR(2016-17)15. The Chairman proposed the question on the motion to adjourn the discussion and directed that each member, when speaking on the question, could speak once for not more than three minutes.
- 19. <u>Mr LEUNG Kwok-hung</u> introduced his motion and expressed his dissatisfaction over the welfare policy. <u>Mr Albert CHAN</u> spoke in support of the motion.
- 20. As there were members who still wished to speak in respect of the motion to adjourn the discussion and the agenda item, the Chairman directed that members could continue discussion at the next meeting. The Chairman declared that the meeting be now adjourned.
- 21. The meeting ended at 7:10 pm.
