Follow－up to meeting on 20 May 2016
FCR（2016－17）18

I refer to your email of 23 May 2016 requesting for supplementary information on FC items．The information requested relating to FCR（2016－17） 18 is set out below for Members＇reference．
（a）the locations of the land granted to private sports clubs and other organisations under Private Recreational Leases（PRL）to operate facilities；and

A list showing the locations of the land granted to the 49 PRL lessees is at Annex．
(b) the qualifications, knowledge, experience, etc. required of the officers to fill the proposed posts for overseeing the planning and construction of the Kai Tak Multi-purpose Sports Complex (MPSC) considering that it would be an unprecedented building project in the territory and how suitable officers would be identified to fill the posts.

The planning for the MPSC project is multi-faceted and highly complex, it is necessary to have a directorate officer to oversee its planning and implementation. In the planning stage, an Administrative Officer Staff Grade C with extensive administrative and management experience, versatility, political acumen and leadership capability will lead the project team, monitor the work of the consultants, identify and resolve issues at an early stage, coordinate inputs from the bureaux and departments concerned and give steer to ensure that Government's policy objectives are met in full.

As the project enters the implementation stage, a Government Architect (GA) is needed to oversee the construction of the MPSC. Leading the project team, the GA will be responsible for managing all works contracts, vetting contractors' designs and submissions, monitoring progress and quality of construction works, implementing site safety and environmental protection measures, controlling cash-flows and expenditures, coordinating with other departments/bureaux, statutory and licensing authorities and resolving interfacing and technical issues with other projects in the Kai Tak Development Area to ensure that the MPSC is completed in accordance with the contractual requirements and specifications, on time and within budget. The GA concerned will be a sufficiently senior professional officer with extensive experience in delivery of government works projects and construction contract management so as to effectively discharge the duties mentioned above.

At the Finance Committee meeting on 20 May 2016, upon Members' enquiry, we informed Members that our operations consultant had completed the first stage of stakeholder engagement targeting mainly the sports sector and entertainment industry. The Chinese version of the consultant's stakeholder report has been uploaded to the project website and the English version will follow shortly. To provide updated project information to the public and to collect community views, we have launched a two-month public engagement exercise on 20 May 2016. The engagement exercise includes the launch of a new project website, roving exhibitions in more than 20 locations in different districts, a questionnaire survey and consultations with the District Councils concerned. The exercise will end on 19 July. Members are invited to visit the project website at www.KaiTakSportsPark.hk for further details and share with us their views.
