Quality Education Fund (QEF) has been supporting different projects to cater for the learning needs of different students including supporting the development of gifted students in the cultural and arts domains.

In the past five years, QEF has approved more than \$500,000 (\$548,200) to support two projects for gifted students in cultural and arts domains. The numbers of primary and secondary school students benefited from the two projects were 700 and 160 respectively.

(d) Details of HKAGE's plan to seek sponsorship from the business sector (requested by Hon WONG Yuk-man, time mark 16:22)

HKAGE will seek sponsorship for the following items:

- i. Direct sponsorship for the disadvantaged students to participate in local and overseas courses on Gifted Education
- ii. Sponsoring the HKAGE to train and organise a Hong Kong Delegation to participate in international competitions around the world

(e) Comparison between the Gifted Education Fund and the QEF (requested by Hon Claudia MO, time mark 16:26).

A. The Quality Education Fund (QEF) mainly caters for worthwhile non-profit making pilot initiatives and other independent projects within the ambit of basic education, i.e. kindergarten, primary, secondary and special education, with a view to enhancing the quality of school education. The key features are as follows:

- all applications are bottom-up initiatives by schools or educational bodies
- applications can be submitted throughout the year
- there is no quota for the number of applications submitted and no ceiling for the amount of grant sought
- schools, educational bodies and organisations registered under the laws of Hong Kong and individuals who are permanent residents in Hong Kong are eligible to apply
- the "QEF Steering Committee" comprises stakeholders from the society. It advises the Government on the policies and procedures governing the operation of the QEF;

the "Assessment and Monitoring Sub-committee" assesses applications for the Quality Education Fund (QEF) in accordance with approved guidelines; the "Dissemination and Promotion Sub-committee" formulates dissemination and promotion strategies for individual or groups of QEF projects as well as territory-wide strategies to enhance the image of QEF. The Permanent Secretary for Education is the trustee of the QEF and holds the authority to approve the grant.

B. The Gifted Education Fund is set up as an endowment fund for generating investment income to provide stable financial support to the Hong Kong Academy for Gifted Education, to enable more students to unleash their potential, enrich the talent pool and enhance the competitiveness of Hong Kong.

Approval to set up the Gifted Education Fund has been obtained from the Finance Committee in its meeting on 28 Jun 2016, and the Education Bureau will set up an Advisory Committee to advise SED on the use and management of the GE Fund.

The Committee will be chaired by a non-official member and will comprise representatives from tertiary institutions, schools, the public sector, parents, experts with knowledge on local and overseas gifted education practices, professional/ youth bodies, and ex-officio members from EDB.

The GE Fund will be established as a trust fund under the Permanent Secretary for Education Incorporated as its trustee. It will be managed in accordance with a trust deed which will stipulate the framework and the salient features necessary for its proper management and administration.
