Supplementary Note for Special Meetings of the Finance Committee to examine the Estimates of Expenditure 2016-2017

Estimated provisions for implementing new and enhanced measures relating to Belt and Road initiative

The Belt and Road Initiative covers a wide range of areas including financial services, logistics, maritime services, trading, professional services, education, cultural and youth services etc. falling within the purview of different policy bureaux and departments. Apart from existing resources, an additional recurrent provision of \$75 million and time-limited provision of \$152 million have been earmarked for implementing new and enhanced measures relating to the Belt and Road Initiative. For the 2016-17 draft Estimates, a total provision of \$125 million for estimated cash flow requirements has been included in eight relevant Expenditure Heads for the above purpose.

2. As committed at the Special Finance Committee meeting on 6 April 2016, we set out the breakdown of the above additional funding provision in the 2016-17 draft Estimates as follows –
