Over the years, the ICAC has been organising seminars/workshops, talks, visits and other publicity and education activities for flat owners, owners' corporations (OCs) (including the newly formed and those having received repair orders from Buildings Department or Fire Safety Directions) and other related organisations. Efforts have been made to explain anti-corruption laws, introduce preventive measures against bid-rigging and remind flat owners to actively participate in managing the buildings so as to effectively monitor building maintenance works. In the past year, over 8 600 people and 800 OCs/related organisations were reached.
- The ICAC also produced the "Building Maintenance Toolkit" which covered corruption preventive measures on building maintenance works and tendering. Measures like introducing the probity and anti-collusion clauses in tender documents, adopting open tendering and appointing project consultants with a good reputation etc., can reduce the opportunities of corruption and bid-rigging in building maintenance. Will the Administration inform this Council about the details of these measures including the estimated expenditure and manpower to be allocated for performing these duties?

- The ICAC has all along attached great importance to promoting integrity building management. Over the years, the ICAC has been organising seminars/workshops, talks, visits and other publicity and education activities for flat owners, owners' corporations (OCs) (including the newly formed and those having received repair orders from Buildings Department or Fire Safety Directions) and other related organisations. Efforts have been made to explain anti-corruption laws, introduce preventive measures against bid-rigging and remind flat owners to actively participate in managing the buildings so as to effectively monitor building maintenance works. In the past year, over 8 600 people and 800 OCs/related organisations were reached.
- The ICAC also produced the "Building Maintenance Toolkit" which covered corruption preventive measures on building maintenance works and tendering. Measures like introducing the probity and anti-collusion clauses in tender documents, adopting open tendering and appointing project consultants with a good reputation, etc., can reduce the opportunities of corruption and bid-rigging in building maintenance. - The Community Relations Department of the ICAC also provides enquiry services to OCs and flat owners through the "Integrity Building Management Enquiry Hotline" and its Regional Offices. More than 860 building management related enquiries were handled by the ICAC in the past year.
- In 2016-17, the ICAC will continue the services and provide corruption preventive education to the building management bodies and flat owners. It will also cooperate with relevant government departments, public bodies, and professional bodies, and district organisations, such as offering corruption prevention input regarding the Urban Renewal Authority's pilot scheme in providing support to flat owners.
- With regard to law enforcement, it is the statutory duty of the ICAC to receive and handle corruption complaints involving building management, including complaints related to building maintenance. If a complaint about bid-rigging allegedly involves corruption, the ICAC will take follow-up action in accordance with the law.
- The Operations Department of the ICAC has an established investigation group comprising 43 officers dedicated to the investigation of all corruption cases related to building management and maintenance, including those which involve bid-rigging. The Operations Department regularly reviews the trend of such complaints as well as the gravity and complexity of cases, so that its resources and manpower can be flexibly deployed. If necessary, it will consider setting up a task force to cope with investigation needs and step up enforcement actions against related corrupt activities. For instance, in April 2015, the Operations Department set up a task force successfully cracked several cases in which bid-rigging and corruption were involved in the tendering exercises for the renovation contracts of several housing estates and residential buildings. It is believed that such enforcement actions could effectively combat and deter corrupt activities.
- For cases of suspected corruption in the course of tendering exercises, the Operations Department will take law enforcement actions in a timely manner to combat bid-rigging activities at an early stage in order to prevent flat owners from suffering losses. This could also serve to remind flat owners and other stakeholders of the risks involved.
- As the above are regular duties of the ICAC, there is no separate budget for this end.

Reply:

The number of corruption reports received by the Independent Commission Against Corruption (ICAC) fluctuated in the past and the figure rose by 23% in 2015 as compared to that of 2014. The fluctuation in the number of corruption reports was attributable to many factors. One of the factors behind the increase in corruption reports received in 2015 was possibly the ICAC's continuous publicity campaign in recent years to encourage the public to report corruption, which has been well received by the community and proved effective.

The Operations Department has been granted approval to create 2 Commission Against Corruption Officer (Middle/Lower) posts in 2016-17 to deal with its increasingly heavy and complex investigation work. As always, the Operations Department will flexibly deploy manpower and resources to meet the investigation needs. If necessary, creation of new posts will be applied for in accordance with the existing mechanism.

### Question:

In 2016-17, the estimated expenditure for the 3 ICAC Programmes—Corruption Prevention, Preventive Education and Enlisting Support—is lower than the revised expenditure for the same in the previous financial year. What are the reasons for this? Whereas in Preventive Education, why is the target number of business organisations, government departments and non-profit-making organisations expected to be reached smaller than that of the previous year? What is the size of expenditure and manpower to be earmarked by the ICAC to enhance the confidence of members of the public and the international community in Hong Kong's probity situation? What are the details of the relevant plans?

Asked by: Dr Hon LAM Tai-fai (Member Question No. 56)

Reply:

- In line with the three-year 0-1-1 Savings Programme launched by the Government since 2015-16, the Independent Commission Against Corruption (ICAC) will achieve more efficient use of public resources through greater efforts in re-engineering and re-prioritisation in 2016-17 such that the savings can be re-deployed to the implementation of new or enhanced services.
- In formulating its annual work plan on preventive education, the Community Relations Department (CRD) of the ICAC considers a host of factors including the needs of society and service targets, corruption trends, and developments in different sectors/trades so as to set timely work strategies and priorities. As such, the Plan/Estimate figures for a specific sector may be adjusted across the years in line with the work priorities and strategies. In fact, in recent years, the overall total number of organisations and people reached through different sectors had not been reduced. Last year, the actual number of organisations and people reached for certain sectors exceeded the Plan/Estimate figures as a result of the need to step up preventive education efforts for particular sectors based on the actual circumstances and needs. Details are as follows:

### **Business Sector**

• The target number of business organisations to be reached by the ICAC each year has been set at around 1 500 over the past 3 years. The actual number of business organisations reached last year was higher than estimated mainly because of various "one-off" activities organised by the CRD in relation to the 20<sup>th</sup> Anniversary of the Hong Kong Ethics Development Centre. In addition, more training courses were arranged upon the request of different professions such as insurance and accounting, etc. Taking into account the different factors and the actual achievement in 2014, we have raised the number of business organisations planned to be reached from 1 500 to 1 700.

### Public Sector

- Regarding the corruption preventive education for the public sector, the target number of government departments and public bodies reached annually has been set at 120 for the past 3 years. These targets were set in light of the integrity training plans discussed and agreed with individual departments/public bodies.
- In the past few years, the actual number of government departments/public bodies reached by the CRD has exceeded 120, mainly due to the launch of several integrity training programmes organised on ad hoc basis. For example, to promulgate the newly produced Reference Package on Conflict of Interest for Managers in the Civil Service, the CRD has stepped up contact with the senior management of all government bureaux/departments between 2012 and 2014. Since 2015, CRD representatives have also attended meetings of Ethics Committees/Corruption Prevention Groups of different bureaux/departments to promulgate the newly launched "Web Learning Portal on Integrity Management for Civil Servants", for enhancing the integrity training for civil servants.
- In drawing up the planned number of organisations and people to be reached in the public sector in 2016, reference has also been made to the actual achievement in the past years. For the number of people reached, the planned figure is the same as last year as it has already been increased from 28 000 people in 2014 to 30 000 people in 2015. For the number of organisations reached, the over-achievement in the past years is mainly due to the launch of a number of new initiatives. As only on-going educational activities are planned for 2016, the number of organisations planned to be reached will be kept at the level of 120, after having considered the training plans worked out with government departments/public bodies.

Non-profit-making Organisations (NPOs)

• The ICAC has consistently aimed to reach a target of about 1 000 NPOs annually to provide corruption prevention training for their staff and members. Both the actual number of NPOs and their staff/members reached in 2015 had exceeded the Target figures due to some special activities being conducted in the year. To tie in with the 2015 District Council Election, the CRD conducted briefings for members of 140 elderly centres and district organisations to promote clean election messages. Upon invitation, the ICAC also attended a number of seminars organised by the Education Development Bureau to brief principals and teachers of some 700 education institutes on corruption prevention measures in

schools. In addition, representatives from a total of 70 non-governmental organisations (NGOs) attended the launching seminar for the Sample Code of Conduct for Board Members & Staff of NGOs in Social Welfare Sector. All these were not on-going activities. In setting the performance indicator for 2016, the ICAC had already made reference to the on-going activities and special/"one-off" activities. The number of NPOs planned to be reached had been suitably adjusted upward from 1 100 to 1 400.

- The CRD has diligently performed the statutory duties of educating the public against the evils of corruption and enlisting their support. Throughout the years, the CRD has organised various "face-to-face" preventive education activities and made flexible use of different mass media and new media to promote probity messages to all walks of life and to sustain public confidence and support to anti-corruption work. According to international ranking surveys and the Annual Survey conducted by independent survey firms commissioned by the ICAC, Hong Kong continues to have a clean society and a clean civil service as well as a level-playing business environment.
- To further enhance understanding of and support to Hong Kong's probity situation, the ICAC will launch a territory-wide education and publicity programme under the theme of "All for Integrity" to strengthen public support to safeguard the core value of integrity and anti-corruption work. Following the Slogan and Icon Design Competition launched late last year as the precursor, the ICAC will cooperate with the 18 District Councils to organise activities and invite partners from different strata of the community including the business sector, government departments, public bodies and schools, etc. to help promote integrity in support of the programme. A variety of media and online publicity activities will also be launched to widely publicise the Programme.
- While endeavouring to enlist support from local community through various activities, • the ICAC has also been proactively fostering close relationship with the international community, viz. international rating agencies, anti-corruption bodies in different countries and foreign chambers of commerce so as to update them on Hong Kong's probity situation and enhance their understanding of the effectiveness of our anti-corruption work through different channels. These channels include co-organising seminars with foreign chambers of commerce, participating in international conferences, conducting duty visits, inviting leaders of the relevant organisations to visit Hong Kong, and reaching them via electronic messages, etc. In parallel, the ICAC receives about 80 overseas and Mainland visitors under the Sponsored Visitors Programme of the Information Services Department every year to introduce the work of the ICAC and Hong Kong's probity situation. In the year ahead, the ICAC will further enhance the contents of its corporate website for the international community to facilitate their better understanding of the anti-corruption efforts and achievements in Hong Kong. The manpower and expenditure involved are included in the recurrent expenditure.

### Question:

The number of ICAC corruption cases involving the Hong Kong Police Force has all along been greater than that involving other departments, and some of the convictions even made the public feel surprised. While the ICAC periodically conducts refresher courses and reviews relevant work practices and procedures with its management, what will be done by the ICAC to ensure that the relevant work can be updated in a timely manner and reach sufficient police officers?

Asked by: Hon WONG Yuk-man (Member Question No. 20)

### Reply:

In 2015, corruption complaints involving the Hong Kong Police Force (HKPF) accounted for approximately 8% of the total complaints received, which was roughly the same as in the previous 5 years (8%-9%). Compared to other government departments, the HKPF attracted more corruption complaints probably because of their large number of officers. The relatively frequent contacts with the public by their frontline officers were likely to increase the chance of their being subjects of complaints.

The representatives of the Independent Commission Against Corruption (ICAC) regularly attend meetings of the Force Committee on Integrity Management and the Police Corruption Prevention Group (PCPG) of the HKPF to assist the Force in formulating and reviewing their integrity management policies and measures, and review work areas for conducting corruption prevention studies. In determining the priority of individual studies, the PCPG considers a number of factors including the corruption risks involved and whether the subject area is of public concern. For any of such assignment studies conducted for the Force by the Corruption Prevention Department (CPD) of the ICAC, the CPD will also follow up with the Police on the implementation of the related corruption preventive measures.

On preventive education, the ICAC has been working closely with the Police College to incorporate anti-corruption talks into their training programmes for new recruits as well as

officers newly posted to crime investigation units and the district special duty squads, and also the different command courses. Serving police officers are also arranged to attend refresher courses, etc. To ensure the training content up-to-date, the ICAC makes reference to the latest corruption trend and corruption prevention assignment reports on the HKPF recently completed by the CPD. For example, the course content on the common law offence "Misconduct in Public Office" was enhanced in 2014, and the scenarios for discussion in Sergeant Promotion and Station Sergeant Promotion courses are being updated.

Besides, Regional Offices of the Community Relations Department (CRD) also conduct tailor-made training sessions for individual police districts to enhance their staff's awareness on corruption prevention, and organise train-the-trainers workshops to facilitate district training officers to incorporate corruption prevention messages in their in-house training. Apart from face-to-face training, the "Web Learning Portal on Integrity Management for Civil Servants" launched by the CRD last year also facilitates police officers in receiving integrity training online.

### Question:

Last year, how many citizens were reached through the preventive education services provided for building management bodies and flat owners? What was the number of enquiries handled by the Community Relations Department in relation to building management?

In the coming year, apart from adopting the one-way approach in providing information, what are the new initiatives to be implemented by the Community Relations Department to strengthen the corruption prevention work in building management?

Reply:

- The Independent Commission Against Corruption (ICAC) attaches great importance to promoting integrity building management to flat owners, owners' corporations (OCs) (including the newly formed and those having received repair orders from the Buildings Department or the Fire Safety Directions) and other related organisations. Efforts have been made to explain the anti-corruption laws and introduce preventive measures.
- In the past year, the ICAC organised district seminars/workshops, talks, visits and other publicity and education activities on building management, reaching over 8 600 people and 800 OCs/related organisations. In these activities, participants received corruption prevention messages, raised questions and exchanged views with each other. Further corruption prevention and education services were subsequently provided to some of the OCs afterwards.
- The ICAC also produced toolkits on daily operation of building management, financial management and building maintenance, which covered useful corruption preventive measures to help reduce the opportunities of corruption in daily operation and building maintenance. The toolkits and educational videos were uploaded onto the ICAC

"Integrity and Quality Building Management" website for reference of the public. In 2015, the website recorded a view count of over 380 000.

- The Community Relations Department (CRD) of the ICAC also provides enquiry services to OCs and flat owners through its Regional Offices and the "Integrity Building Management Enquiry Hotline". More than 860 building management related enquiries were handled by the ICAC in the past year. In addition, apart from delivering corruption prevention talks in district seminars on building management, the Corruption Prevention Advisory Service offered corruption prevention advice to OCs/members of the public concerning building management on 32 occasions.
- In 2016-17, the CRD will continue the above services and provide corruption preventive education to the building management bodies and flat owners. It will also organise publicity projects on integrity building management at district level to explain the anti-corruption laws to OCs/related organisations and flat owners, and encourage flat owners to actively take part in daily operation of their buildings. Meanwhile, pamphlets will be produced for distribution to flat owners to enhance publicity and education effectiveness.

### Question:

The ICAC will assist kindergartens to enhance good governance with a view to achieving a high standard of integrity. Apart from ordinary briefings and workshops, are there any other preventive measures?

Reply:

- The Corruption Prevention Department (CPD) of the Commission is compiling a sample code of conduct for managers and staff of kindergartens (the Sample Code) to help enhance their integrity management and the governance of kindergartens to meet public expectation. The CPD has consulted the Education Bureau (EDB) and the stakeholders in the kindergarten sector in drafting the contents.
- The Sample Code provides guidelines covering acceptance of advantages and entertainment, managing conflict of interest, keeping of confidential information, use of kindergarten assets and resources, supervisory accountability and managing relationship with parents and voluntary service by parents, etc.
- The CPD will discuss with the EDB how to use its platforms (e.g. workshops and circulars) to promulgate the Sample Code to the kindergartens. Furthermore, the CPD will proactively approach kindergarten associations and school sponsoring bodies, and provide tailor made service to individual kindergartens to help them adopt the guidelines or assimilate the provisions therein into their existing codes.
- When the new funding policy and relating operation details for kindergarten come to implementation, the CPD will move on to provide corruption prevention guidelines and advice on the administrative areas with inherent corruption risks, e.g. admission of students, procurement of goods and services, staff administration and maintenance of school premises.

### Reply:

The Government has launched various Public-private partnership (PPP) programmes in recent years to provide medical services to eligible patients through collaboration with the private healthcare sector. In view of the substantial amount of public money and various private healthcare organisations/service providers involved (e.g. private hospitals, laboratories and private doctors), and the inherent corruption risks in the administration of the PPP programmes (e.g. securing service contracts from programme administrators by corrupt means, obtaining advantages from service providers by referring patients to them, favouring colluded patients by shortening their waiting time for services), the Corruption Prevention Department (CPD) will issue a corruption prevention guide on the administration of PPP programmes for reference by the Hospital Authority (HA), the Department of Health (DH) and other relevant parties engaged in managing the programmes. After launching the guide, the CPD will work closely with the HA and DH, through organising thematic seminars, to assist them in implementing the corruption prevention measures recommended in the guide and ensuring the safety and health of As a regular commitment, the CPD will continue to conduct assignment reviews patients. and offer corruption prevention advice on vulnerable work areas for the HA and DH to plug the corruption loopholes, and organise integrity management workshops for their staff to enhance their integrity awareness.

- 2. What are the work plans, schedules, expenses and manpower involved as well as the anticipated effectiveness regarding maintaining the integrity of voter registration for the direct elections of LegCo Members through GCs?

Reply:

- e past 5 years, the Independent Commission Against Corruption (ICAC) received 2 reports concerning alleged breaches of Section 16 of the Elections (Corrupt and Illegal Conduct) Ordinance (ECICO) (Cap. 554) by ineligible voters of the LegCo functional constituencies. The 2 cases were both received in 2012. No person was arrested or prosecuted after investigation.
- 2. The ICAC has been working closely and conducted a number of working meetings with the Registration and Electoral Office (REO) to discuss the focus of corruption prevention work for various public elections and to provide corruption prevention advice on various electoral procedures. Among corruption prevention work carried out for the 2016 Legislative Council Functional Constituencies election, the ICAC issued a Best Practice Checklist to the Specified Bodies under the Legislative Council Functional Constituencies in late 2015 with a view to improving the transparency, objectivity and accountability, as well as reducing the risk of conflict of interest of the

membership administration systems of the Specified Bodies. The ICAC will also take follow-up actions on reports of suspected breaches of ECICO in accordance with the law.

In addition, to maintain the integrity of voter registration for the elections of LegCo Members, the ICAC is now launching a series of education and publicity activities to tie in with the Government's voter registration campaign with an aim to alert members of the public on the requirements of Section 16 of ECICO. The activities include:

- distributing promotional leaflets on "anti-vote rigging" to newly registered electors and those who update their personal particulars as a registered elector through different channels of the REO and the Home Affairs Department;
- tying in with the REO by including information on "anti-vote rigging" in the reminder notes relating to voter registration arrangement issued by the REO to all elderly homes in Hong Kong;
- producing a series of radio programmes jointly with the Radio Television Hong Kong to widely publicise the "anti-vote rigging" messages;
- making use of both the traditional media and on-line channels such as compartments of public transports, public facilities, websites and social media to broadcast the educational filmlet on "anti-vote rigging";
- launching a new dedicated website on "Clean LegCo Election" to provide reference materials and up-to-date information; and
- maintaining a Clean Election Enquiry Hotline to answer public enquiries on the requirements of ECICO.

The above education and publicity activities will be implemented between March and May this year with funding of around \$600,000 provided by the Constitutional and Mainland Affairs Bureau. The ICAC's Programme Co-ordinator on Clean Election is responsible for the planning of these activities which are being executed with the assistance of the 7 Regional Offices of the CRD.

The ICAC will provide assistance and services for public elections and the related voter registration systems through deployment of internal resources without incurring additional manpower and expenditures.

- 1. As shown by statistics, the Independent Commission Against Corruption received a total of 1 834 pursuable corruption reports (excluding election-related reports) in 2015, representing an increase of about 23% as compared with 1 495 in 2014. According to records, the number of pursuable corruption reports received in 2014 was about 11% less than the 2013 figure of 1 673, which was about 41% less than the 2012 figure of 2 832. Please inform the Committee of the reasons for the sudden increase in corruption reports last year and the main areas involved. Will the Administration increase manpower to deal with corruption cases of these categories?
- 2. It was pointed out by the ICAC that, given the complexity and magnitude of many corruption cases, investigation work of the Operations Department remained onerous. Please inform the Committee of the number of ICAC officers currently responsible for handling complaints and investigation work. Does the ICAC find it necessary to increase manpower to cope with the investigation work? If so, what are the details?

### Reply:

1. The number of corruption reports received by the Independent Commission Against Corruption (ICAC) fluctuated in the past and the figure rose by 23% in 2015 as compared to that of 2014. Of the reports received, the numbers of corruption complaints involving different sectors, namely government departments, public bodies and the private sector, rose by 18%, 12% and 25% respectively. The fluctuation in the number of corruption reports was attributable to many factors. One of the factors behind the increase in corruption reports received in 2015 was possibly the ICAC's continuous publicity campaign in recent years to encourage the public to report corruption, which has been well received by the community and proved effective.

2. At present, a total of 465 officers in the Operations Department of the ICAC are directly responsible for handling complaints and investigation work. The ICAC has been granted approval to create 2 Commission Against Corruption Officer (Middle/Lower) posts in 2016-17 to deal with its increasingly heavy and complex investigation work. The ICAC will review its manpower from time to time and redeploy its staff when necessary to ensure that its investigation work will not be affected by any manpower shortage. If additional manpower is required due to investigation needs, the Commission will make the request in accordance with the established procedures.

### Question:

In 2016-17, the Community Relations Department of the Commission will continue to provide preventive education services on building management to owners' corporations. In this regard, please advise of the following:

- 1. How many corruption reports concerning bid-rigging in building maintenance works were received by the Commission in the past 3 years? How many cases were pursued and not pursued respectively? How many cases are being handled?
- 2. In 2016-17, will the Commission step up publicity and education efforts against corruption in building maintenance for owners and tenants of private buildings (including old buildings)? If so, what are the details of the additional resources, staff establishment and the specific details of the publicity programmes? Was any assessment conducted on the efficacy of previous publicity and education efforts? And
- 3. In 2016-17, will additional resources be allocated to strengthen cooperation with the Hong Kong Police Force and other related departments to jointly combat corrupt activities involved in building maintenance? If so, what are the details of the expenditure and the manpower involved? If not, what are the reasons?

Reply:

1. Building maintenance corruption complaints may involve bid-rigging or other malpractices. The Independent Commission Against Corruption (ICAC) does not maintain statistical breakdown in respect of the different types of malpractices. In the past 3 years, the number of corruption complaints received by the ICAC in relation to building maintenance and the corresponding number of pursuable complaints, completed investigations and on-going investigations are as follows:

2. To formulate work objectives in a timely manner and plan anti-corruption publicity and educational activities on a sustainable basis, the ICAC always takes into consideration the development of society and the needs of service targets in reviewing its work strategies, allocating resources and evaluating work performance. With regard to building management, the ICAC attaches great importance to promoting integrity building management to flat owners, owners' corporations (OCs) (including the newly formed and those having received repair orders from the Buildings Department or the Fire Safety Directions) and other related organisations. Efforts have been made to explain the anti-corruption laws and related preventive measures as well as to introduce our Building Maintenance Toolkit to promote effective monitoring of building maintenance works.

In the past year, the ICAC organised seminars/workshops, talks, visits and other publicity and education activities, reaching over 8 600 people and 800 OCs/related organisations. Most of the participants considered these corruption prevention education and publicity activities effective.

The ICAC also produced toolkits on daily operation of building management, financial management and building maintenance advising OCs to take useful corruption preventive measures to help reduce the opportunities of corruption in daily operation and building maintenance. The toolkits and educational videos were uploaded onto the ICAC "Integrity and Quality Building Management" website for reference of the public. In 2015, the website recorded a view count of over 380 000.

The Community Relations Department (CRD) of the ICAC also provides enquiry services to OCs and flat owners through its Regional Offices and the "Integrity Building Management Enquiry Hotline". More than 860 building management related enquiries were handled by the ICAC in the past year.

In 2016-17, the ICAC will continue the above services to provide corruption preventive education to the building management bodies and flat owners. It will also enhance cooperation with relevant government departments and professional bodies.

3. On the law enforcement front, the Operations Department of the ICAC has an established investigation group comprising 43 officers dedicated to investigation of all corruption cases relating to building management and maintenance. The Operations Department regularly reviews the trend of such complaints as well as gravity and complexity of the cases, so that its resources and manpower can be flexibly deployed. If necessary, it will consider setting up a task force to cope with investigation needs

and step up enforcement actions against related corrupt activities. For instance, in April 2015, the Operations Department set up a task force comprising 9 officers to investigate a number of interrelated complaints. The task force successfully cracked several cases in which bid-rigging and corruption were involved in the tendering exercises for the renovation contracts of several housing estates and residential buildings. In addition, for cases involving corruption in the course of tendering exercises, the Operations Department will take enforcement actions in a timely manner to combat bid-rigging activities at an early stage in order to prevent flat owners from suffering losses. This could also serve to remind flat owners and other stakeholders of the risks involved. It is believed that such enforcement actions could effectively combat and deter the relevant corrupt activities.

If the ICAC discovers illegal activities other than corruption in the course of investigation of individual cases, the ICAC will, in accordance with the established procedures, liaise closely with other relevant departments or organisations including the Hong Kong Police Force, the Home Affairs Department and the Competition Commission, etc.

Over the years, the ICAC has collaborated closely with the Hong Kong Police Force, the Home Affairs Department and the Urban Renewal Authority to promote integrity and corruption prevention in building maintenance through providing support to the various schemes (such as RenoSafe Scheme and Operation Building Bright) and holding of regional seminars for OCs and flat owners. The ICAC will continue to work closely with the relevant government departments and public organisations to assist flat owners in preventing corruption in their building maintenance projects.

The activities mentioned in paras. 2 and 3, which are the daily work of the ICAC, are not separately budgeted for.

#### Question:

The actual number of government officers recommended for disciplinary or administrative action in 2015 was 90, which was higher than 48 persons in 2014. What measures will the Administration implement to improve the relevant situation? What is the manpower responsible for handling these cases? Has the Administration provided additional funding to cope with the increased workload? If so, please give details? If not, what are the reasons?

### Reply:

In 2015, upon the conclusion of relevant investigations by the Independent Commission Against Corruption (ICAC) and the endorsement of the Operations Review Committee, a total of 33 cases involving 90 government officers were referred to the respective heads of departments for consideration of disciplinary and/or administrative action. Although fewer cases were referred in 2015 as compared to 39 cases in 2014, the number of persons has seen a rise because there was a case involving 41 non-civil service contract staff members who had submitted false sick leave certificates to their respective departments. The departments concerned were responsible for the related disciplinary and/or administrative work, and hence ICAC resources are not involved.

The ICAC will analyse individual corruption cases and provide the government departments concerned with tailor-made corruption prevention services, including conducting assignment studies on areas with incidents of corruption.

In addition, the ICAC has been proactively assisting government departments to review their integrity management strategies. Taking into consideration individual departments' actual circumstances and needs (including common staff integrity problems), the ICAC provides tailor-made corruption preventive education services to the departments through induction courses for civil servants, thematic workshops and refresher training courses. The ICAC also actively participates in departments' integrity steering committees, corruption prevention groups and senior staff meetings, etc., with a view to reviewing or assisting in the implementation of various training programmes to enhance the staff's awareness on corruption prevention and integrity culture of the departments.

Apart from conducting talks and workshops, the Community Relations Department of the ICAC launched the "Web Learning Portal on Integrity Management for Civil Servants" in 2015 to enable a wider coverage among civil servants. This package has been uploaded onto the *Cyber Learning Centre Plus*, an e-learning portal of the Civil Service Training and Development Institute, to provide diversified and handy resources on integrity training for civil servants.

#### Question:

With regard to enhancing the professional and investigative capabilities of investigating officers, what are the details? What are the resources and the number of persons involved?

Asked by: Prof Hon Joseph LEE Kok-long (Member Question No. 69)

Reply:

To cope with the increasingly complex corruption investigation work, the Operations Department of the Independent Commission Against Corruption (ICAC) will continue to strengthen its human resource management strategies through professional and structural training programmes for enhancement of the overall professional and investigative capabilities of investigating officers. The details are as follows:

- The Operations Department has set up a Curriculum Committee to regularly review the content and arrangement of different training programmes and to formulate well-defined training plans for investigating officers with a view to providing them with more systematic and professional training for enhancement of their investigative capabilities. Upon review, the total durations of induction training conducted at different stages for Assistant Investigators and Investigators have been extended to 21 weeks and 22 weeks respectively, and the programme content on legal knowledge, investigative skills, work procedures and integrity management has been reinforced. Moreover, different command courses are provided for newly promoted Investigators, Senior Investigators and Chief Investigators to strengthen their investigative capabilities and leadership skills.
- The Operations Department also provides refresher training and organises professional knowledge workshops on different topics for serving investigating officers, so that they can keep up to date on legal knowledge, investigative skills, as well as the operation and information of different trades or fields.

- To enhance the financial investigation capabilities of investigating officers in a more systematic and comprehensive manner, the Operations Department not only includes progressive training on a great variety of financial investigation topics in the induction courses, but also arranges for the Forensic Accounting Group to regularly provide investigating officers of different ranks with advanced training on financial investigation to enrich their knowledge. The Operations Department also arranges for officers to attend local and overseas professional financial investigation training courses, so as to intensify the exchanges with local and overseas law enforcement agencies and allow the officers to gain a better understanding of the latest developments of the relevant issues.
- To enhance their computer forensics capabilities, officers of the Computer Forensics Section of the Operations Department would from time to time attend computer forensics courses and lectures organised by local and overseas law enforcement agencies and international computer forensics organisations to keep abreast of the latest computer forensics techniques and procedures. Officers of the Section also maintain close liaison with computer forensics experts from local and overseas law enforcement agencies for sharing of knowledge, skills and experience in computer forensics through work exchanges.

As the above are regular items which have already been included in the recurrent expenditure, the ICAC has not made separate estimates for this end.

### Question:

Previously the 2 corruption cases involving former principal officials in Hong Kong, including the successful prosecution against a former Chief Secretary for Administration and a number of prominent businessmen as well as the on-going trial of the former Chief Executive TSANG Yam-kuen for his alleged acceptance of advantages, have shaken public confidence in public officers' determination to maintain integrity in Hong Kong. For the 2<sup>nd</sup> year in a row, no mention of maintaining integrity was made in the Civil Service paragraphs of the 2016 Policy Address, which has also shaken public confidence in public officers. In what way will the Administration rekindle public confidence in probity, and will there be a large-scale review targeting the public sector to prevent corruption from arising again in the civil service?

Asked by: Hon CHAN Chi-chuen (Member Question No. 31)

Reply:

- Over the years, the government remains clean and there is no sign of a revival of syndicated corruption within the civil service. The overall situation of corruption complaints against government officers remained stable in recent years and the recent corruption cases involving senior government officials are only isolated incidents.
- To ensure integrity in the civil service, the Independent Commission Against Corruption (ICAC) will continue to organise talks for the management and officers of different ranks of all bureaux and departments. The ICAC will also work with the Civil Service Bureau (CSB) to launch various measures and activities to enhance civil servants' integrity. In view of the corruption cases happened in recent years, the ICAC will set priorities with departments on areas of assignment studies.
- In late 2013, the ICAC and the CSB jointly launched a revised version of the sample code of conduct for civil servants and provide tailor-made preventive services for departments on request to ensure that the conduct of civil servants lives up to the

public expectation.

- Since 2006, the ICAC has joined hands with the CSB in launching the "Ethical Leadership Programme" (ELP). Under the ELP, each government department has appointed a senior officer to serve as its "Ethics Officer" to formulate, coordinate and steer the integrity promotion programmes of the department. Departments are required to report every 2 years on their work of anti-corruption and probity culture promotion carried out and completed during the period, as well as to regularly review integrity management strategies and enhance integrity training in light of the latest development. Currently, there are over 160 Ethics Officers and Assistant Ethics Officers from more than 70 bureaux/departments. The ICAC and the CSB jointly organise thematic workshops on a regular basis to facilitate the exchange of experience on integrity issues among Ethics Officers.
- The ICAC has been working with the CSB to continue stepping up efforts to enhance the integrity culture among high ranking civil servants (including directorate officers). In December 2015, the ICAC Commissioner attended for the first time the "Advanced Leadership Enhancement Programme" organised by the Civil Service Training and Development Institute (CSTDI) to share with course participants at D1 or D2 directorate level the importance of integrity leadership. The Community Relations Department (CRD) plans to organise thematic seminars for high ranking civil servants, which will cover the common law offence of Misconduct in Public Office, handling conflict of interests and managing staff integrity, etc.
- As for individual departments, the ICAC has been proactively assisting government departments to review their integrity promotion strategies. Taking into consideration individual departments' actual circumstances and needs (including serious and common staff integrity problems), tailor-made corruption preventive education services are provided to civil servants of all ranks through induction courses, thematic workshops and refresher training courses. The ICAC also actively participates in the departments' integrity steering committees, corruption preventive groups and senior staff meetings, etc., with a view to assisting the departments in enhancing their staff's awareness on corruption prevention and entrenching the integrity culture.
- To address the heightening public concerns over conflict of interest encountered by • civil servants, the ICAC launched a "Reference Package on Conflict of Interest for Managers in the Civil Service" in 2012, and approached all bureaux/departments in 2012-14 to promote the package to the senior management, while organising thematic workshops for individual departments at the same time. The CRD will continue to proactively closely latest corruption monitor the trend and approach bureaux/departments with more corruption complaints to offer timely and enhanced corruption preventive training for their staff.
- To provide a convenient means for civil servants to receive integrity training, the ICAC launched in 2015 the "Web Learning Portal on Integrity Management for Civil Servants", which was uploaded onto the Cyber Learning Centre Plus of the CSTDI. The Portal serves as a continuous integrity training platform, which enables civil servants who cannot attend face-to-face training to conduct web learning. The CRD has been promoting the Portal to the management of bureaux/departments to

encourage the effective use of web-based resources in strengthening integrity training for their staff.

• Moreover, the ICAC formulated an "Integrity and Corruption Prevention Guide on Managing Relationship with Public Servants" for reference by the business sector. The Guide explains the rules and regulations which govern the acceptance of advantages and entertainment by public servants, and the offering of advantages to public servants. It also provides guidance and the relevant safeguards against malpractices for reference by business operators having dealings with public servants. In March this year, the ICAC wrote to government departments, requesting them to promote the Guide to their suppliers, service contractors, licensees and subvented organisations. The electronic version of the Guide was also uploaded to the ICAC website for use by the relevant organisations or individuals.

#### Question:

The number of corruption complaints concerning building management and construction remained high in the past year, and was characterised by a year-on-year increase. Among the building maintenance projects of various large private housing estates carried out in recent years, there have been cases where maintenance companies were involved in serious bid-rigging activities, some of which even involved exorbitant maintenance fees. The earlier arrests of members of relevant companies and owners' corporations involved in bid-rigging activities had little effect in curbing minority flat owners from being exploited in maintenance projects. Some successful tenderers, upon being awarded the contract, employed different tactics by adding new works items, such as replacement of aluminum window frames at the communal passages of the building, which were not covered in the original tender documents, and charged the flat owners for the cost. It was reported that some maintenance companies have been prosecuted for contravening the Trade Descriptions In this regard, did the ICAC take any follow-up action on these problems Ordinance. concerning building maintenance? Is corruption involved? If corruption is not involved, what can be done to educate the minority flat owners on how to deal with the maintenance companies' indiscriminate alteration of works in tender documents? Moreover, how many corruption complaints concerning bid-rigging activities in buildings have been received in the past and how many of them ended up with successful prosecution?

Asked by: Hon CHAN Chi-chuen (Member Question No. 307)

Reply:

- If corruption is suspected in bid-rigging activities concerning building maintenance works, the Independent Commission Against Commission (ICAC) will conduct investigations in accordance with the law and, if there is evidence, refer the case to the Department of Justice for deciding whether prosecution should be instituted.
- Building maintenance corruption complaints may involve bid-rigging or other malpractices. Though the ICAC does not maintain statistical breakdown in respect of

the different types of malpractices, the Commission set up a task force in 2015 to investigate a number of interrelated complaints. The task force successfully cracked several cases in which bid-rigging and corruption were involved in the tendering exercises for the renovation contracts of several housing estates and residential buildings. A former proprietor of an engineering company involved is awaiting sentencing after pleading guilty to 4 counts of bribery offences. The relevant investigations and criminal proceedings are still in progress.

- In 2013, the ICAC promulgated a new Building Maintenance Toolkit which provided corruption prevention guidelines and advice on building maintenance projects for reference of owners' corporations (OCs)/flat owners. Such advice covers areas including identifying and deciding on the scope of works before inviting tenders, laying down clear tender specifications and implementing control measures concerning the alterations and procedures of works. Meanwhile, the ICAC also conducted district talks in collaboration with the Home Affairs Department and the Urban Renewal Authority to promote the preventive measures recommended in the Toolkit to members of the OC management committees. The Toolkit has been uploaded onto the ICAC "Integrity and Quality Building Management" thematic website for reference of the public. In 2015, the website recorded a view count of over 380 000. In addition, the Commission's Corruption Prevention Advisory Service also provides free and tailor-made preventive advice for OCs on matters concerning building maintenance.
- The ICAC has all along attached great importance to promoting integrity building management to flat owners, OCs (including the newly formed OCs and those having received repair orders from the Buildings Department or the Fire Safety Directions) and other related organisations. Flat owners are also reminded to actively take part in building management and effectively monitor the building maintenance projects. In the past year, over 8 600 people and 800 OCs/related organisations were reached through building management district seminars/workshops, talks, visits and other publicity and educational activities.
- The Community Relations Department of the ICAC also provides enquiry services to OCs and flat owners through its Regional Offices and the "Integrity Building Management Enquiry Hotline". More than 860 building management related enquiries were handled by the ICAC in the past year.
- In 2016-17, the ICAC will continue to provide preventive education services to building management bodies and flat owners in collaboration with the relevant government departments, public bodies, professional bodies and district organisations.

Regarding the corruption prevention work of the ICAC, please advise of the following:

- 1. Please list out by year and department the number of corruption cases involving government departments, the number of people involved, the respective numbers of persons arrested, prosecuted and convicted as well as the maximum and minimum penalties in each of the past 5 years;
- 2. Please list out by department the details, expenses and manpower involved in the work plans to deal with corruption in government departments.

Asked by: Dr Hon Kenneth CHAN Ka-lok (Member Question No. 183)

Reply:

1. From 2011 to 2015 (in the past 5 years), the numbers of investigations, and persons prosecuted and convicted, arising from pursuable corruption complaints made to the Independent Commission Against Corruption (ICAC) involving government departments in each of the past 5 years as well as the maximum and minimum penalties are listed in Annexes 1 to 4.

The ICAC does not maintain statistics on the number of persons involved or arrested in each investigation, and therefore cannot provide such information.

2. The ICAC set up Corruption Prevention Groups with government departments for holding regular discussions with the senior management of the relevant departments on areas warranting assignment studies, such as law enforcement, licensing and regulatory systems, procurement, contract management, staff management and public works, etc. The ICAC also provides corruption prevention advice on policies before its

implementation with a view to plugging corruption loopholes at the source. To date, the ICAC already conducted assignment studies on the major working procedures of government departments.

In late 2013, the ICAC and the Civil Service Bureau (CSB) jointly launched a revised version of the sample code of conduct for civil servants and provide tailor-made preventive services for departments on request to ensure that the conduct of civil servants lives up to the public expectation.

Moreover, to help sustain a clean civil service, the ICAC has been working closely with government departments to review and formulate integrity management strategies and provide timely integrity training for government officers of different ranks.

Since 2006, the ICAC has joined hands with the CSB in launching the "Ethical Leadership Programme" (ELP). Under the ELP, each government department has appointed a senior officer to serve as its "Ethics Officer" to formulate, coordinate and steer the integrity promotion programmes of the department. Departments are required to report every 2 years on their work of anti-corruption and probity culture promotion carried out and completed during the period, as well as to regularly review integrity management strategies and enhance integrity training in light of the latest development. Currently, there are over 160 Ethics Officers and Assistant Ethics Officers from more than 70 bureaux/departments. The ICAC and the CSB jointly organise thematic workshops on a regular basis to facilitate the exchange of experience on integrity issues among Ethics Officers.

The ICAC also works with the CSB to continue stepping up efforts to enhance the integrity culture among high ranking civil servants (including directorate officers). In December 2015, the ICAC Commissioner attended for the first time the "Advanced Leadership Enhancement Programme" organised by the Civil Service Training and Development Institute (CSTDI) to share with course participants at D1 or D2 directorate level the importance of integrity leadership. The Community Relations Department (CRD) also plans to organise thematic seminars for high ranking civil servants, covering the common law offence of Misconduct in Public Office, handling conflict of interests and managing staff integrity, etc.

As for individual departments, the ICAC has been proactively assisting government departments to review their integrity promotion strategies. Taking into consideration individual departments' actual circumstances and needs (including serious and common staff integrity problems), tailor-made corruption preventive education services are provided to civil servants of all ranks through induction courses, thematic workshops and refresher training courses. The ICAC also actively participates in the departments' integrity steering committees, corruption preventive groups and senior staff meetings, etc., with a view to assisting the departments in enhancing their staff's awareness on corruption prevention and entrenching the integrity culture.

To address the heightening public concerns over conflict of interest encountered by civil servants, the ICAC launched a "Reference Package on Conflict of Interest for Managers in the Civil Service" in 2012, and approached all bureaux/departments in

2012-14 to promote the package to the senior management, while organising thematic workshops for individual departments at the same time. The CRD will continue to closely monitor the latest corruption trend and proactively approach bureaux/departments with more corruption complaints to offer timely and enhanced corruption preventive training for their staff.

To provide a convenient means for civil servants to receive integrity training, the ICAC launched in 2015 the "Web Learning Portal on Integrity Management for Civil Servants", which was uploaded onto the Cyber Learning Centre Plus of the CSTDI. The Portal serves as a continuous integrity training platform, which enables civil servants who cannot attend face-to-face training to conduct web learning. The CRD has been promoting the Portal to the management of bureaux/departments to encourage the effective use of web-based resources in strengthening integrity training for their staff.

Being part of the daily work of the ICAC, the above services are not separately budgeted for.

Regarding the corruption prevention work of the ICAC, please advise of the following:

- 1. In regard to the integrity of voter registration for the Legislative Council (LegCo) functional constituencies, what were the number of corruption cases involving voters of the LegCo functional constituencies, the number of people involved, the respective numbers of persons arrested, prosecuted and convicted as well as the maximum and minimum penalties in each of the past 5 years?
- 2. What are the work plans, schedules, expenses and manpower involved as well as the anticipated effectiveness regarding maintaining the integrity of voter registration for the LegCo functional constituencies?

Asked by: Dr Hon Kenneth CHAN Ka-lok (Member Question No. 184)

Reply:

- 1. In the past 5 years, the Independent Commission Against Corruption (ICAC) received 2 reports concerning alleged breaches of Section 16 of the Elections (Corrupt and Illegal Conduct) Ordinance (ECICO) (Cap. 554) by ineligible voters of the LegCo functional constituencies. The 2 cases were both received in 2012. No person was arrested or prosecuted after investigation.
- 2. The ICAC has been working closely and conducted a number of working meetings with the Registration and Electoral Office (REO) to discuss the focus of corruption prevention work for various public elections and to provide corruption prevention advice on various electoral procedures. Among corruption prevention work carried out for the 2016 LegCo functional constituencies election, the ICAC issued a Best Practice Checklist to the Specified Bodies under the LegCo functional constituencies in late 2015 with a view to improving the transparency, objectivity and accountability,

as well as reducing the risk of conflict of interest of the membership administration systems of the Specified Bodies. The ICAC will also take follow-up actions on reports of suspected breaches of the ECICO in accordance with the law.

In addition, to maintain the integrity of voter registration for the elections of LegCo Members, the ICAC is now launching a series of education and publicity activities to tie in with the Government's voter registration campaign with an aim to alert members of the public on the requirements of Section 16 of the ECICO. The activities include:

- distributing promotional leaflets on "anti-vote rigging" to newly registered electors and those who update their personal particulars as a registered elector through different channels of the REO and the Home Affairs Department;
- tying in with the REO by including information on "anti-vote rigging" in the reminder notes relating to voter registration arrangement issued by the REO to all elderly homes in Hong Kong;
- producing a series of radio programmes jointly with the Radio Television Hong Kong to widely publicise the "anti-vote rigging" messages;
- making use of both the traditional media and online channels such as compartments of public transport, public facilities, websites and social media to broadcast the educational filmlet on "anti-vote rigging";
- launching a new dedicated website on "Clean LegCo Election" to provide reference materials and up-to-date information; and
- maintaining a Clean Election Enquiry Hotline to answer public enquiries on the requirements of the ECICO.

The above education and publicity activities will be implemented between March and May this year with funding of around \$600,000 provided by the Constitutional and Mainland Affairs Bureau. The ICAC's Programme Co-ordinator on Clean Election is responsible for the planning of these activities which are being executed with the assistance of the 7 Regional Offices of the Community Relations Department.

The ICAC will provide assistance and services for public elections and the related voter registration systems through deployment of internal resources without incurring additional manpower and expenditures.

## Question:

To strengthen computer forensics and information technology capabilities, is it necessary to upgrade the existing equipment and add new equipment? If it is necessary to procure additional equipment, what are the expenditure for each item and the deployment plan?

Asked by: Dr Hon Kenneth CHAN Ka-lok (Member Question No. 186)

Reply:

The rapid technology advancement has presented new challenges for the computer forensics work of the Independent Commission Against Corruption (ICAC). While the total data storage of the computers seized continues to increase, the ICAC also has to process increasingly popular mobile devices such as mobile phones and tablet computers in order to recover evidence. Officers of the Computer Forensics Section of the Operations Department will enhance their computer forensics capabilities by keeping themselves up to date on the latest developments of computer technology and computer forensics equipment, software and techniques, exploiting advanced computer forensics technology and applying their professional knowledge and experience. Besides, officers of the Section will from time to time attend computer forensics courses and lectures organised by local and overseas law enforcement agencies and international computer forensics organisations to keep abreast of the latest computer forensics techniques and procedures. Officers of the Section also maintain close liaison with computer forensics experts from local and overseas law enforcement agencies for sharing of knowledge, skills and experience in computer forensics through work exchanges. As computer forensics is a regular item which has already been included in the recurrent expenditure, the ICAC has not made separate estimates for this end.

Furthermore, in order to enhance its capability in meeting evolving information technology and better supporting the entire investigation process as well as case management work, the Finance Committee of the Legislative Council approved funding in May 2011 for the ICAC

to develop a New Generation Operations Department Information System. The approved estimate of expenditure on the whole project was \$57.46 million, covering the cost of hardware, software, and implementation service. The project is now in the stage of user acceptance testing and system cut-over. Data migration and system rollout are expected in mid 2016, and the estimated expenditure in 2016-17 is \$20.98 million.
