Letter from the Labour Party Requesting Revising the Sequence of Agenda Items of the Public Works Subcommittee Meeting on 1 June 2016

At the request of the Chairman of the Public Works Subcommittee (PWSC), the Government would like to respond to the subject letter from the Labour Party of 31 May 2016 as follows.

In its letter, the Labour Party requested the Chairman to place the three school projects in the PWSC agenda of 1 June 2016 prior to the Sai Kung Signature Project Schemes (SPS) item for discussion, and thus the discussion of the SPS item for Kwun Tong, Wan Chai and Tai Po would also be deferred. The school projects concerned are –

- (1) A school for social development for boys in Area 2B, Tuen Mun;
- (2) A 30-classroom primary school at Site KT2b, Development at Anderson Road, Kwun Tong; and
- (3) A 30-classroom secondary school at Site 1A-2, Kai Tak development.

While the SPS items for Sai Kung, Kwun Tong, Wan Chai and Tai Po were not discussed at the PWSC meeting on 1 June, the Chairmen or Vice-Chairman of Kwun Tong, Wan Chai and Tai Po District Councils (DCs) would not be available for the meeting on 11 June due to absence from Hong Kong or official commitments. The Government would arrange the relevant item to be discussed at the PWSC meeting on 15 June. In view of the above changes to the agenda, the three school projects of Labour Party's concern would be placed immediately after the Sai Kung SPS item. Considering that the PWSC meeting on 11 June would last for almost 8 hours, the Government is of the view that the above sequence of items would not hinder discussion on the school projects, hence does not recommend making further changes to the sequence of the school projects.

The funding proposal for Kwun Tong, Wan Chai and Tai Po SPS item has been included in the agendas for a total of 10 times since the PWSC meeting on 29 February 2016. Relevant DC Chairmen or Vice-Chairman and Government officials have for many times waited at the Legislative Council. As the funding proposal has long been submitted to the PWSC, we believe 15 June is a suitable time for PWSC to commence discussion and make an early decision on it.

The agenda for the PWSC meeting on 11 June 2016 is attached at the Annex.
