As PRH estates were densely populated with very limited space in domestic blocks and public areas, keeping of dogs might cause adverse effects to the environmental hygiene. Therefore dog keeping in PRH estates, except under special conditions, was not permitted under the tenancy agreement; and</p> <p>(b) PRH tenants should be well aware of the above restriction since the implementation of the Marking Scheme for Estate Management Enforcement in Public Housing Estates in 2003.</p> <p>The Chairman declared that he was a non-official member of the Housing Authority. He supported that animals should not be allowed to be kept in PRH estates.</p>
