I. The arrangement of offsetting severance payments and long service payments against Mandatory Provident Fund accrued benefits

- 2. <u>Members</u> requested the Administration to provide :
  - (a) information on the total number and amount of claims for offsetting severance payment ("SP") and long service payment ("LSP") against Mandatory Provident Fund ("MPF") accrued benefits of employees of government outsourced contractors and non-civil service contract staff; and
  - (b) information supporting the statement in paragraph 5.22 of the consultation document "Retirement Protection Forging Ahead" issued by the Commission on Poverty that "If the 'offsetting' arrangement is abolished, enterprises will need to make additional reserve to meet financial accounting requirements".

Employees or self-employed persons earning less than the minimum relevant income level did not need to contribute but employers still needed to make their contributions for the employees. For employees or self-employed persons earning more than the maximum relevant income level, the employees and their employers or the self-employed persons did not need to make contributions for the part of the income above this level; and	
		(c) the subject of raising the wage cap for calculating SP or LSP had been discussed by the Panel on Manpower and it had been
