I. The arrangement of offsetting severance payments and long service payments against Mandatory Provident Fund accrued benefits

<u>The Joint Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

- 2. The Deputy Chairman took over the chairmanship of the meeting in the absence of the Chairman.
- 3. <u>The Joint Subcommittee</u> received oral representations from 28 deputations/individual attending the meeting. The major views and concerns expressed by deputations/individual are summarized as follows:
  - (a) some deputations were of the view that the arrangement of offsetting severance payments ("SP") and long service payments ("LSP") against Mandatory Provident Fund ("MPF") accrued benefits arising from employers'

contribution ("the offsetting arrangement") should be abolished. They expressed the following views :

- (i) the Chief Executive ("CE") should honour his election manifesto regarding the offsetting issue and draw up a timetable for the abolition of the offsetting arrangement;
- (ii) the purpose of MPF was to assist the working population to save for retirement, while SP and LSP were intended for meeting the short-term financial needs of employees who became unemployed under specific circumstances. As the purposes of SP and LSP were different from that of MPF, it was unfair to offset SP or LSP against accrued benefits arising from employers' contribution to MPF;
- (iii) accrued benefits attributable to employers' contribution withdrawn for offsetting SP and LSP had amounted to more than \$25 billion since July 2001 when the Mandatory Provident Fund Schemes Authority first collected SP and LSP related withdrawal data. In 2014, some 43 500 employees, out of the total 2.549 million of employee scheme members, were affected by the offsetting arrangements. A large number of employees were affected by the offsetting arrangement;
- (iv) as a first step, the Administration should abolish the offsetting arrangement for non-civil service contract staff and employees of government outsourced contractors;
- (v) the Administration should introduce a universal retirement protection scheme; and
- (vi) instead of opposing the abolition of the offsetting arrangement, the business sector should seek for the implementation of rent control; and
- (b) some other deputations/individual were of the view that the offsetting arrangement should not be abolished. They expressed the following views:

- (i) the abolition of the offsetting arrangement was a deviation from the consensus reached during the enactment of the MPF Schemes Ordinance (Cap. 485);
- (ii) employers were facing a very difficult business environment. Abolition of the offsetting arrangement would further increase the financial burden of employers, especially those of the catering industry as well as medium, small and micro enterprises;
- (iii) instead of abolishing the offsetting arrangement, a review should be conducted on the MPF System to increase the transparency and reduce the management fees of MPF schemes, encourage employers and employees to increase their level of MPF contribution on a voluntary basis and transfer the management of MPF schemes to the Administration;
- (iv) there was overlapping between SP, LSP and MPF, which were not found in co-existence in most developed economies, including Australia, Canada, France, Germany, the United Kingdom and the United States of America;
- (v) MPF was not the only pillar for retirement protection. The Administration should do more in explaining this and the background to the offsetting arrangement to the public; and
- (vi) some of these deputations considered that the abolition of the offsetting arrangement might be explored, only if there was no retrospective effect on the MPF benefits accrued before the new law came into operation.
- 4. In response to the views and concerns of the deputations/individual attending the meeting, the Administration made the following points:
  - (a) CE had indicated in his election manifesto that he would progressively reduce the proportion of the offsetting amount. The Administration was playing an active role in the public

- consultation on retirement protection, which included the offsetting arrangement, and the study on the offsetting issue;
- (b) the offsetting issue and the issue of whether there was any functional overlapping among SP, LSP and MPF were complex;
- (c) in the longer term, there was a need to rationalize the relationship among SP, LSP and MPF; and
- (d) the views received in the public consultation exercise would be collated and analysed to facilitate thorough and in-depth discussions on the feasible options and the way forward.

#### II. Any other business

- 5. <u>Members</u> agreed that the next meeting would be held on 18 April 2016 at 9:00 am and relevant academics would be invited to give views at the meeting on the offsetting arrangement.
- 6. There being no other business, the meeting ended at 5:00 pm.
