**Proposed timing for discussion**

**1. The proposed legislation to implement the Law Reform Commission Report on Child Custody and Access**

The Administration has launched the public consultation on the proposed legislation to implement the recommendations of the Law Reform Commission Report on Child Custody and Access since 25 November 2015, which will last until 25 March 2016. The Administration will seek members' views at the Panel meeting on 14 December 2015.

**2. Infirmity care in non-hospital setting**

The Administration consulted the Panel in December 2004 on a proposal to launch a trial scheme to provide infirmity care places for medically stable elders in a non-hospital setting. Various options are being explored, including upgrading some of the places in subvented residential care homes for the elderly to provide infirmity care. The Administration will report the progress in due course.

**3. Charitable fund-raising activities**

On 6 December 2013, LRC released its report on charities, which put forward a number of recommendations including those on monitoring charitable fund-raising activities. The Home Affairs Bureau ("HAB") is responsible for formulating Government's responses to the report.

The Government's responses and actions with regard to LRC reports are reported to the Panel on

Administration of Justice and Legal Services ("AJLS Panel"), HAB is planning to report progress to the AJLS Panel later when the responses are ready.

**4. Review of Disability Allowance ("DA") and the system for processing applications thereof**

The Administration briefed members on the findings of the consultancy study on practices of places outside Hong Kong in respect of financial assistance for persons with disabilities at the Panel meeting on 9 March 2015. Hon CHEUNG Kwok-che requested the Administration to report to the Panel on the outcome of its review on the eligibility criteria for DA and related matters.

Dr Hon Fernando CHEUNG requested the Panel to discuss the progress of the review of DA (LC Paper No. CB(2)420/15-16(01) issued on 8 December 2015).

**6. Provision of barrier-free access and facilities for persons with disabilities**

The Subcommittee on Improving Barrier Free Access and Facilities for Persons with Disabilities submitted its report (LC Paper No. CB(2)2065/11-12) to the Panel in May 2012 and recommended, inter alia, that the Panel should follow up with the Administration on the matter in the Fifth Legislative Council.

Retrofitting programmes for upgrading the barrier-free facilities at Government and Housing Authority ("HA") premises had been completed by 30 June 2014. The progress report (LC Paper

No. CB(2)93/14-15(01)) was submitted to the Panel on 23 October 2014 and uploaded to the Labour and Welfare Bureau's website for public information.

The Administration will continue to enhance the barrier-free facilities in Government and HA premises and facilities and take forward any additional proposals having regard to views and suggestions of stakeholders in accordance with the established mechanism. The Administration will also continue to work closely with the Equal Opportunities Commission, the Rehabilitation Advisory Committee, the rehabilitation sector and the community in building a barrier-free and inclusive society.

**7. Elderly care policy**

(a) Residential care services for the elderly

1<sup>st</sup> or 2<sup>nd</sup> quarter of 2016

The Panel acceded to Prof Hon Joseph LEE's request for holding a joint meeting with the Panel on Health Services in the 2015-2016 session to discuss the Residential Care Homes (Elderly Persons) Ordinance (Cap. 459) with a view to improving the quality of these residential care homes.

(b) Elderly Services Programme Plan

14 March 2016

The Panel requested the Administration to prepare an interim report on the Elderly Services Programme Plan and brief the Panel on the report in November or December 2015. The Panel also appointed a subcommittee to follow up Elderly Commission("EC")'s preparation of the Programme Plan and study the policies and measures relating to the future development of elderly services schemes. The subcommittee is currently on the waiting list pending activation.

**8. Provision of welfare service premises for the elderly and enhancement of facilities therein**

**9. Social welfare planning**

Hon CHEUNG Kwok-che suggested that the Panel should discuss social welfare planning.

The Panel discussed medium and long-term social welfare planning at its meetings on 19 February, 26 March and 8 July 2013. Members suggested that the Panel should discuss with the Administration progress of the subject matter as soon as possible.

Hon CHEUNG Kwok-che has suggested that the Panel discuss planning for rehabilitation services.

**10. Proposal for formation of a subcommittee on issues relating to welfare of people with disabilities**

Item proposed by Hon CHAN Yuen-han at the Panel meeting on 12 November 2012. In deciding that the Panel would receive views from deputations on review of the system for processing applications for DA at the regular meeting to be held in December 2013, Hon CHAN Yuen-han suggested that the proposal for formation of a subcommittee on issues related to welfare of persons with disabilities should be included in the list of outstanding items for discussion by the Panel.

**11. Provision of child care services and after-school care services**

In its submission to the Panel (LC Paper No. CB(2)601/12-13(01)), Hong Kong Women Workers' Association requests the Panel to discuss, as soon as possible, improving the provision of child care services and after-school care services.

Dr Hon Helena WONG suggested on 20 January 2014 (LC Paper No. CB(2)748/13-14(01)) that the Panel fix a date for discussing the subject and receiving views from deputations. She has requested the Panel to deal with the subject as soon as possible.

The subject was covered in the discussion of "Measures to unleash labour force in families for increasing the grassroots' income" by the Subcommittee on Poverty at its meeting on 28 April 2015. Apart from meeting with deputations and the Administration, the Subcommittee had also invited members of the Panel to join the discussion at that meeting.

**12. Manpower of paramedical and supporting staff in the social welfare sector**

In discussing the shortage of supporting staff (including Programme Workers) in the social welfare sector at the Panel meeting on 13 January 2014, the Panel passed a motion urging the Administration to, among others, submit a report on matters related to Programme Workers to the Panel within six months. The report was forwarded to members on 31 July 2014 (LC Paper No. CB(2)2162/13-14(01)).

Hon CHEUNG Kwok-che has requested that the manpower situation of paramedical and supporting staff in the social welfare sector be discussed at a Panel meeting.

**13. Review of Old Age Living Allowance ("OALA")**

Item proposed by Hon LEUNG Che-cheung.

The Administration has undertaken to review OALA one year after its implementation and report the outcome of the review to the Panel.

**14. Salary adjustment arrangement for staff in non-governmental organizations ("NGOs") receiving Lump Sum Grant ("LSG") subvention and the progress of the implementation of the Best Practice Manual ("BPM")**

The Panel was briefed on the progress report on the implementation of the LSG BPM at its meeting on 12 May 2014. Hon CHAN Yuen-han suggested that the Panel revisit the subject matter relating to LSG Subvention.

11 January 2016

The Panel discussed salary adjustment arrangements for staff in NGOs receiving LSG subvention at its meeting on 11 May 2015. Hon CHEUNG Kwok-che suggested that the Panel should follow up the matter. The Panel agreed that deputations should be invited to give views on these matters.

The item is to inform the Panel of the progress of the implementation of BPM among NGOs receiving LSG subvention since BPM was brought into operation on 1 July 2014, and the staff salary adjustment arrangement in subvented welfare NGOs for the year 2015-2016.

**15. Targets for provision of hostels for mentally handicapped persons**

Hon CHAN Yuen-han suggested that the Panel consider discussing the subject of setting targets for the provision of hostels for mentally handicapped persons, e.g. setting a target waiting time and a specific percentage of the total area of a new public housing project for such provision.

**16. Progress of implementation of Special Scheme on Privately Owned Sites for Welfare Uses ("Special Scheme")**

The Administration briefed the Panel in February 2014 on the implementation of the Special Scheme and obtained the Finance Committee ("FC")'s approval of its proposal to transfer \$10 billion to the Lotteries Fund to ensure the availability of sufficient resources to implement the feasible projects under the Special Scheme. The Administration updated the Panel on the progress of implementation of the Special Scheme on 13 April 2015. Hon TANG Ka-piu requested the Administration to provide a paper to update the Panel every six months on the progress of the Special Scheme.

Item proposed by Hon CHEUNG Kwok-che. The issue has been studied by the former Joint Subcommittee and covered in its report (LC Paper No. CB(2)2154/13-14(01) Annex I).

The Panel discussed the captioned subject at its meeting on 11 May 2015. Hon Frederick FUNG suggested that the subject be further discussed at a Panel meeting. Representatives of the Development Bureau and Planning Department should also be invited for the discussion.

**19. Child Fatality Review ("CFR") Report**

Dr Hon Fernando CHEUNG proposed to discuss issues relating to child fatality review mechanism.

14 December 2015

The purpose of CFR is to facilitate the enhancement of social service systems pertaining to child welfare with focus on inter-sectoral collaboration and multi-disciplinary cooperation for prevention of occurrence of avoidable child death cases. Further to its first report published in May 2013, the Review Panel of the Pilot Project on CFR released its second report in July 2015 covering the review findings of the 238 child death cases which occurred in 2010 and 2011. Including the cases reviewed in the pilot project on CFR, a total of 685 child death cases occurred from 2006 to 2011 were reviewed. The Administration will brief members on the CFR Report at the Panel meeting on 14 December 2015.

**20. Issues relating to welfare of refugees, torture claimants and asylum seekers and proposed legislative amendments to the unified screening mechanism for non-refoulement claimants**

Item proposed by Hon CHAN Yuen-han. Hon CHAN Yuen-han suggested that the Panel hold a joint meeting with the Panel on Security to discuss with the Administration the subject matter.

**22. The Pilot Scheme on On-site Pre-school Rehabilitation Services**

Item proposed by the Administration. The Administration plans to brief members on a two-year pilot scheme which provides on-site rehabilitation service for children with special needs studying in kindergartens and kindergartens-cum-child care centres participating in the scheme.

**23. Setting up a new contract residential care home for the elderly ("RCHE") at the Social Welfare Facilities Block of the public rental housing ("PRH") development at North West Kowloon Reclamation Area Site 6, Sham Shui Po, Kowloon**

Item proposed by the Administration. The item is to consult the Panel on the proposal to set up a new contract RCHE at the Social Welfare Facilities Block of the PRH Development at North West Kowloon Reclamation Area Site 6, Sham Shui Po, Kowloon. Following the established arrangements, the construction cost of the proposed facilities is to be funded by the Lotteries Fund. As the proposed facilities are anticipated to give rise to an additional recurrent cost exceeding \$10 million per annum, funding approval will rest with FC. The Administration intends to submit the relevant funding proposal to FC on 5 or 26 February 2016.
