#### Proposed timing for discussion

### 1. Review of Disability Allowance ("DA") and the system for processing applications thereof

The Administration briefed members on the findings of the consultancy study on practices of places outside Hong Kong in respect of financial assistance for persons with disabilities at the Panel meeting on 9 March 2015. Hon CHEUNG Kwok-che requested the Administration to report to the Panel on the outcome of its review on the eligibility criteria for DA and related matters.

Dr Hon Fernando CHEUNG requested the Panel to discuss the progress of the review of DA (LC Paper No. CB(2)420/15-16(01) issued on 8 December 2015).

The review conducted by the Inter-departmental Working Group on Review of DA has been completed. The Administration will brief the Panel on the outcome of the review.

### 2. Pilot Scheme on Living Allowance for Carers of the Elderly Persons from Low Income Families

Item proposed by the Administration. The Administration will brief the Panel on the implementation progress of the Pilot Scheme.

## 3. The proposed legislation to implement the Law Reform Commission Report on Child Custody and Access

The Administration has launched the public consultation on the proposed legislation to implement the recommendations of the Law

Reform Commission Report on Child Custody and Access since 25 November 2015, which will last until 25 March 2016. Members' views were sought on the proposed legislation at the Panel meeting on 14 December 2015. The Panel will hold a special meeting to receive deputations' views on 22 February 2016.

### 4. Implementation of the pilot project on child care training for grandparents

Item proposed by the Administration. The item is to inform the Panel of the implementation of the pilot project on child care training for grandparents ("the Pilot Project"). The two-year Pilot Project aims at reinforcing family support between generations, promoting active ageing of grandparents, as well as enhancing child care. The funding application for the Pilot Project was supported by the Lotteries Fund Advisory Committee on 25 November 2015.

#### 5. Elderly care policy

#### (a) Residential care services for the elderly

2<sup>nd</sup> quarter of 2016

The Panel acceded to Prof Hon Joseph LEE's request for holding a joint meeting with the Panel on Health Services in the 2015-2016 session to discuss the Residential Care Homes (Elderly Persons) Ordinance (Cap. 459) with a view to improving the quality of these residential care homes.

#### (b) Elderly Services Programme Plan

14 March 2016

The Panel requested the Administration to prepare an interim report on the Elderly Services Programme Plan and brief the Panel on the report in November or December 2015. The Panel also appointed a subcommittee to follow up Elderly Commission ("EC")'s preparation of the Programme Plan and study the policies and measures relating to the future development of elderly services schemes.

The subject matter will be followed up by the Subcommittee on Issues Relating to the Future Development of Elderly Services Schemes which has been activated in January 2016.

The Administration will brief the Panel on the latest progress of the formulation of Elderly Services Programme Plan. The Administration intends to submit the relevant funding proposal to the Finance Committee ("FC") on 27 May or 24 June 2016.

6. Setting up a hostel for moderately mentally handicapped persons ("HMMH") and an integrated vocational rehabilitation services centre ("IVRSC") at the PRH site at Hung Shui Kiu Area 13

Item proposed by the Administration.

7. Setting up integrated welfare service complexes in two vacant school premises in Tuen Mun and Sai Kung

## 11. Progress of implementation of Special Scheme on Privately Owned Sites for Welfare Uses ("Special Scheme")

The Administration briefed the Panel in February 2014 on the implementation of the Special Scheme and obtained FC's approval of its proposal to transfer \$10 billion to LF to ensure the availability of sufficient resources to implement the feasible the Special projects under Scheme. The Administration updated the the Panel implementation progress of the Special Scheme on 13 April 2015. Hon TANG Ka-piu requested the Administration to provide a paper to update the Panel every six months on the progress of the Special Scheme.

# 12. Setting up a new day activity centre ("DAC") cum hostel for severely mentally handicapped persons ("HSMH") in Pokfulam Shine Skills Centre, Pokfulam

Item proposed by the Administration. The item is to consult the Panel on the proposal to set up a new DAC cum HSMH in Pokfulam Shine Skills Centre at Pokfulam. Following the established arrangements, the costs for fitting-out, furniture and equipment of the proposed facilities are to be funded by LF. As the proposed facilities are anticipated to give rise to an additional recurrent cost exceeding \$10 million per annum, funding approval will rest with FC.

#### 15. Infirmary care in non-hospital setting

The Administration consulted the Panel in December 2004 on a proposal to launch a trial scheme to provide infirmary care places for medically stable elders in a non-hospital setting. Various options are being explored, including upgrading some of the places in subvented residential care homes for the elderly to provide infirmary care. The Administration will report the progress in due course.

#### 16. Charitable fund-raising activities

On 6 December 2013, LRC released its report on charities, which put forward a number of recommendations including those on monitoring charitable fund-raising activities. The Home Affairs Bureau ("HAB") is responsible for formulating Government's responses to the report.

The Government's responses and actions with regard to LRC reports are reported to the Panel on Administration of Justice and Legal Services ("AJLS Panel"), HAB is planning to report progress to the AJLS Panel later when the responses are ready.

### 18. Provision of barrier-free access and facilities for persons with disabilities

The Subcommittee on Improving Barrier Free Access and Facilities for Persons with Disabilities submitted its report (LC Paper No. CB(2)2065/11-12) to the Panel in May 2012 and recommended, inter alia, that the Panel should follow up with the Administration on the matter in the Fifth Legislative Council.

Retrofitting programmes for upgrading the barrier-free facilities at Government and Housing Authority ("HA") premises had been completed by 30 June 2014. The progress report (LC Paper No. CB(2)93/14-15(01)) was submitted to the Panel on 23 October 2014 and uploaded to the Labour and Welfare Bureau's website for public information.

The Administration will continue to enhance the barrier-free facilities in Government and HA premises and facilities and take forward any additional proposals having regard to views and

suggestions of stakeholders in accordance with the established mechanism. The Administration will also continue to work closely with the Equal Opportunities Commission, the Rehabilitation Advisory Committee, the rehabilitation sector and the community in building a barrier-free and inclusive society.

### 19. Provision of welfare service premises for the elderly and enhancement of facilities therein

#### 20. Social welfare planning

Hon CHEUNG Kwok-che suggested that the Panel should discuss social welfare planning.

## 21. Proposal for formation of a subcommittee on issues relating to welfare of people with disabilities

Item proposed by Hon CHAN Yuen-han at the Panel meeting on 12 November 2012. In deciding that the Panel would receive views from deputations on review of the system for processing applications for DA at the regular meeting to be held in December 2013, Hon CHAN Yuen-han suggested that the proposal for formation of a subcommittee on issues related to welfare of persons with disabilities should be included in the list of outstanding items for discussion by the Panel.

#### 22. Provision of child care services and after-school care services

In its submission to the Panel (LC Paper No. CB(2)601/12-13(01)), Hong Kong Women Workers' Association requests the Panel to discuss, as soon as possible, improving the provision of child care services and after-school care services.

To be decided

Dr Hon Helena WONG suggested on 20 January 2014 (LC Paper No. CB(2)748/13-14(01)) that the Panel fix a date for discussing the subject and receiving views from deputations. She has requested the Panel to deal with the subject as soon as possible.

The subject was covered in the discussion of "Measures to unleash labour force in families for increasing the grassroots' income" by the Subcommittee on Poverty at its meeting on 28 April 2015. Apart from meeting with deputations and the Administration, the Subcommittee had also invited members of the Panel to join the discussion at that meeting.

### 23. Manpower of paramedical and supporting staff in the social welfare sector

In discussing the shortage of supporting staff (including Programme Workers) in the social welfare sector at the Panel meeting on 13 January 2014, the Panel passed a motion urging the Administration to, among others, submit a report on matters related to Programme Workers to the Panel within six months. The report was forwarded to members on 31 July 2014 (LC Paper No. CB(2)2162/13-14(01)).

Hon CHEUNG Kwok-che has requested that the manpower situation of paramedical and supporting staff in the social welfare sector be discussed at a Panel meeting.

#### 24. Review of Old Age Living Allowance ("OALA")

### 25. Targets for provision of hostels for mentally handicapped persons

#### 28. Child Fatality Review ("CFR") Report

Further to its first report published in May 2013, the Child Fatality Review Panel released its second report in July 2015 covering the review findings of the 238 child death cases which occurred in 2010 and 2011. Including the cases reviewed in the pilot project on CFR, a total of 685 child death cases occurred from 2006 to 2011 were reviewed. The Panel was briefed on the CFR Report at its meeting on 14 December 2015. Members have agreed to hold a special meeting to discuss the Report with relevant government departments.
