LEGISLATIVE COUNCIL BRIEF

PUBLIC HEALTH AND MUNICIPAL SERVICES ORDINANCE SETTING ASIDE PLACES FOR USE AS PUBLIC PLEASURE GROUNDS

INTRODUCTION

The Director of Leisure and Cultural Services, in her capacity as the Authority ("Authority") under the Public Health and Municipal Services Ordinance, Cap.132 ("the Ordinance"), manages the public pleasure grounds listed in the Fourth Schedule to the Ordinance. Under Section 106 of the Ordinance, the Authority may, from time to time, by order set aside places for use as public pleasure grounds, and may by order amend the Fourth Schedule.

2. We propose to introduce amendments through the Public Health and Municipal Services Ordinance (Public Pleasure Grounds) (Amendment of Fourth Schedule) (No. 2) Order 2015 (the Amendment Order) to set aside the places specified in Schedule 1 of the Amendment Order for use as public pleasure grounds, to cease to set aside places specified in Schedule 2 for use as public pleasure grounds and to rename the public pleasure grounds specified in the Schedule 3 of the Amendment Order. The Amendment Order is at <u>Annex</u> to this Brief.

JUSTIFICATIONS

3. The proposal to set aside 16 venues as public pleasure grounds will enable the Authority to enforce the Pleasure Grounds Regulation in those venues. We also propose to delete two venues from the Fourth Schedule as they cease to be used as public pleasure grounds and to rename five venues.

PLACES TO BE SET ASIDE FOR USE AS PUBLIC PLEASURE GROUNDS

4. The following 16 venues will be designated as public pleasure

grounds and be included in the Fourth Schedule —

- (i) Nine newly completed venues that are or will open for public use by the Leisure and Cultural Services Department (LCSD):
 - (a) Ha Tam Shui Hang Sitting-out Area No. 2
 - (b) Ha Tsuen Soccer Pitch
 - (c) Lo Tsz Tin Tsuen Children's Playground
 - (d) Sheung Shui Hang Tau Village Sitting-out Area No. 2
 - (e) Shuen Wan Joint Village Basketball Court
 - (f) Shui Wo Tsuen Sitting-out Area
 - (g) Tat Wan Road Sitting-out Area
 - (h) Tong Kung Leng Basketball Court
 - (i) Yuen Long Sports Centre
- Seven venues that are taken over from the Home Affairs Department and former Territory Development Department for management by LCSD :
 - (a) Cheung Sha Ha Tsuen Basketball Court
 - (b) Ham Tin Garden
 - (c) Ngan Kwong Wan Road Amenity Plots
 - (d) Sham Hong Road Playground
 - (e) Silver Mine Bay Waterfall Garden
 - (f) Tai Tei Tong Sitting-out Area
 - (g) Yung Shue Wan Tin Hau Temple Sitting-out Area

PLACES CEASING TO BE SET ASIDE FOR USE AS PUBLIC PLEASURE GROUNDS

5. Two venues, namely North Point Promenade and Ta Kwu Ling Chuk Yuen Playground, will be deleted from the Fourth Schedule as they have ceased to be public pleasure grounds. The North Point Promenade has been handed over to Lands Department (LandsD) for comprehensive development of the Ex-North Point Estate while the Ta Kwu Ling Chuk Yuen Playground has been handed over to Civil Engineering Development Department permanently to facilitate the establishment of the new boundary control points in eastern part of Hong Kong-Shenzhen boundary.

RENAMING OF PUBLIC PLEASURE GROUND

6. We recommend renaming the following five venues in the Fourth Schedule:

- (a) Tung Hei Road Children's Playground Tung Hei Road Children's Playground is recommended to be renamed as Tung Hei Road Sitting-out Area after its conversion from the existing children's playground into a sitting-out area.
- (b) Shun Lee Tsuen Road Lookout Shun Lee Tsuen Road Lookout is recommended to be renamed as Shun Lee Tsuen Road Sitting-out Area as the venue is no longer serving as a scenic point due to the change of surrounding.
- (c) Kowloon Park Drive Children's Playground Kowloon Park Drive Children's Playground is recommended to be renamed as Haiphong Road Children's Playground in order to make it clear to the public that the venue is not a part of Kowloon Park.
- (d) Lower Cheung Sha Village Children's Playground The English name of Lower Cheung Sha Village Children's Playground is recommended to be renamed as Cheung Sha Ha Tsuen Children's Playground suggested by LandsD for the consistency of adjacent venue, Cheung Sha Ha Tsuen Basketball Court.
- (e) Yim Tin Pok Temporary Playground Yim Tin Pok Temporary Playground is recommended to be renamed as Yim Tin Playground to tie in with the change of land status from short term tenancy to permanent land allocation as well as to reflect the geographical places in the vicinity as suggested by LandsD.

The renaming is supported by the respective district councils.

AMENDMENT OF FOURTH SCHEDULE

7. The Amendment Order at <u>Annex</u> amends the Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to give effect to the changes set out in paragraphs 4, 5 and 6 above.

Explanatory Note

This Order sets aside 16 places for use as public pleasure grounds and provides that 2 places cease to be set aside for use as public pleasure grounds.

2. The Order also amends the Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to—

- (a) add the 16 places and remove the 2 places mentioned in paragraph 1; and
- (b) reflect that-
 - "Tung Hei Road Children's Playground" has been renamed as "Tung Hei Road Sitting-out Area";

- (ii) "Kowloon Park Drive Children's Playground" has been renamed as "Haiphong Road Children's Playground";
- (iii) "Shun Lee Tsuen Road Lookout" has been renamed as "Shun Lee Tsuen Road Sitting-out Area";
- (iv) "Lower Cheung Sha Village Children's Playground" has been renamed, in English only, as "Cheung Sha Ha Tsuen Children's Playground" for 長沙下村兒童遊樂場; and
- (v) "Yim Tin Pok Temporary Playground" has been renamed as "Yim Tin Playground".
