Pilotage Ordinance (Chapter 84)

Pilotage (Dues) (Amendment) Order 2016

INTRODUCTION

The Director of Marine, as Pilotage Authority, has made the Pilotage (Dues) (Amendment) Order 2016 (the Order) under section 22 of the Pilotage Ordinance (Cap. 84) to amend the amount of pilotage dues.

JUSTIFICATION

2. Pilotage dues are charged by licensed pilots for provision of pilotage services. The levels of dues are reviewed periodically taking into account a number of factors including inflation and market situation and mutually agreed between the Hong Kong Pilots Association Limited (HKPA) representing all pilots and the Hong Kong Liner Shipping Association (HKLSA) representing users of pilotage services. The pilotage dues were last revised in 2012. HKPA and HKLSA reviewed the current levels of pilotage dues in 2014 and proposed to increase dues by an average of 8%. Details are at **Annex A**.

LEGISLATIVE PROPOSAL

3. The Order, at <u>Annex B</u>, amends the Schedule to the Pilotage (Dues) Order (Cap. 84D) to give effect to the proposed revision of pilotage dues.

IMPLICATIONS OF THE PROPOSAL

5. Pilotage dues are an insignificant cost item for international shipping. There will not be any economic implications.

6. The proposal has no productivity, financial, family, gender, civil service, environmental, or sustainability implications. It is in conformity with the Basic Law, including the provisions concerning human rights. It will not affect the current binding effect of the Pilotage Ordinance.

PUBLIC CONSULTATION

7. The proposal was considered and endorsed by the Pilotage Advisory Committee, which comprises stakeholders of the shipping industry, namely, licensed pilots, ship-owners, terminal operators, liner operators, dockyard operators, tug operators, shipping agencies, bulk cargo operators and master mariners on 2 June 2015. We consulted the Legislative Council Panel on Economic Development on 19 April 2016. Members supported the proposed revisions.

PUBLIC REACTION

8. The revisions have been mutually agreed by the service providers as represented by HKPA and users as represented by HKLSA. There is no adverse public reaction to the proposed revision.

9. A press release will be issued on 20 May 2016. A spokesman will be available to answer enquires.

Explanatory Note

This Order amends the Pilotage (Dues) Order (Cap. 84 sub. leg. D)—

- (a) to increase the basic amount of the standard pilotage due (section 3(1));
- (b) to revise the scale of the additional amount of the standard pilotage due (section 3(2) to (6));
- (c) to increase certain additional pilotage dues (section 3(7) to (11)); and
- (d) to increase the due payable where the engagement of a pilot is cancelled (section 3(12)).
