### LEGISLATIVE COUNCIL BRIEF

### PUBLIC HEALTH AND MUNICIPAL SERVICES ORDINANCE SETTING ASIDE PLACES FOR USE AS PUBLIC PLEASURE GROUNDS

### INTRODUCTION

The Director of Leisure and Cultural Services, in her capacity as the Authority ("Authority") under the Public Health and Municipal Services Ordinance, Cap.132 ("the Ordinance"), manages the public pleasure grounds listed in the Fourth Schedule to the Ordinance. Under Section 106 of the Ordinance, the Authority may, from time to time, by order set aside places for use as public pleasure grounds, and may by order amend the Fourth Schedule.

2. We propose to introduce amendments through the Public Health and Municipal Services Ordinance (Public Pleasure Grounds) (Amendment of Fourth Schedule) Order 2016 (the Amendment Order) to set aside the places specified in Schedule 1 of the Amendment Order for use as public pleasure grounds, to cease to set aside places specified in Schedule 2 for use as public pleasure grounds and to rename the public pleasure ground specified in the Schedule 3 of the Amendment Order. The Amendment Order is at Annex to this Brief.

### **JUSTIFICATIONS**

3. The proposal to set aside 12 venues as public pleasure grounds will enable the Authority to enforce the Pleasure Grounds Regulation in those venues. We also propose to delete five venues from the Fourth Schedule as they cease to be used as public pleasure grounds and to rename one venue.

# PLACES TO BE SET ASIDE FOR USE AS PUBLIC PLEASURE GROUNDS

4. The following 12 venues will be designated as public pleasure grounds and be included in the Fourth Schedule —

- (i) Five newly completed venues that are or will be opened for public use by the Leisure and Cultural Services Department (LCSD):
  - (a) Ngau Tau Kok Park
  - (b) Wang Kwong Road Sitting-out Area
  - (c) University Station Cycling Entry/Exit Hub
  - (d) Yuen Chau Kok Sports Centre
  - (e) Hung Tak Road Sitting-out Area No. 2
- (ii) Seven venues that are taken over from the Home Affairs Department and former Territory Development Department for management by LCSD:
  - (a) Tong Yam Street Hillside Sitting-out Area
  - (b) Cheung Chau North Lookout Pavilion
  - (c) Don Bosco Road Garden
  - (d) Hang Mei Sitting-out Area
  - (e) Lantau Island Shui Hau Sitting-out Area
  - (f) Po Chue Tam Barbecue Area
  - (g) Tong Fuk Barbecue Area

# PLACES CEASING TO BE SET ASIDE FOR USE AS PUBLIC PLEASURE GROUNDS

- 5. The following five venues will be deleted from the Fourth Schedule as they have ceased to be public pleasure grounds:
  - (i) & (ii) Ngau Tau Kok Road Flyover Rest Garden and Kwun Tong Road/Ngau Tau Kok Road Amenity Plot have been handed over to Architectural Services Department for construction of the East Kowloon Cultural Centre.
  - (iii) Hoi Lai Temporary Garden has been handed over to Lands Department(LandsD) for development by Education Bureau.
  - (iv) Don Bosco Road Leisure Shelter, Cheung Chau has been included as part of the Don Bosco Road Garden.
  - (v) Wo Keng Shan Road Garden has been handed over to Civil Engineering and Development Department permanently for the Liantang / Heung Yuen Wai Boundary Control Point and associated works project.

### RENAMING OF PUBLIC PLEASURE GROUND

6. Ting Yu Square Temporary Sitting-out Area is recommended to be renamed as Ting Yue Square Sitting-out Area in order to tie in with the change of land status from short term tenancy to permanent land allocation. The renaming is supported by the Kwun Tong District Council.

### AMENDMENT OF FOURTH SCHEDULE

7. The Amendment Order at <u>Annex</u> amends the Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to give effect to the changes set out in paragraphs 4, 5 and 6 above.

### **Explanatory Note**

This Order sets aside 12 places for use as public pleasure grounds and provides that 5 places cease to be set aside for use as public pleasure grounds.

- The Order also amends the Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to—
  - (a) add the 12 places and remove the 5 places mentioned in paragraph 1; and
  - (b) reflect that "Ting Yu Square Temporary Sitting-out Area" has been renamed as "Ting Yue Square Sittingout Area".
