Council meeting of 29 March 2017

**Amendments to motion on
“Urging the next Chief Executive to reactivate constitutional reform”**

Further to LC Paper No. CB(3) 410/16-17 issued on 16 March 2017, Hon LEUNG Che-cheung and Dr Hon Helena WONG have respectively given notice of their intention to move separate amendments to Dr Hon KWOK Ka-ki’s motion on “Urging the next Chief Executive to reactivate constitutional reform” scheduled for the Council meeting of 29 March 2017. As directed by the President, Hon LEUNG Che-cheung’s and Dr Hon Helena WONG’s amendments will be printed in the terms in which they were handed in on the Agenda of the Council.

2. The President will order a joint debate on the above motion and the two amendments. To assist Members in debating the motion and the amendments, I set out below the procedure to be followed during the debate:

- (a) the President calls upon Dr Hon KWOK Ka-ki to speak and move his motion;
- (b) the President proposes the question on Dr Hon KWOK Ka-ki’s motion;
- (c) the President calls upon the two Members who wish to move amendments to speak in the following order, but no amendment is to be moved at this stage:
 - (i) Hon LEUNG Che-cheung; and
 - (ii) Dr Hon Helena WONG;

- (d) the President calls upon the public officer(s) to speak;
- (e) the President invites other Members to speak;
- (f) the President gives leave to Dr Hon KWOK Ka-ki to speak for the second time on the two amendments;
- (g) the President calls upon the public officer(s) to speak again;
- (h) in accordance with Rule 34(5) of the Rules of Procedure, the President has decided that he will call upon the two Members to move their respective amendments in the order set out in paragraph (c) above. The President invites Hon LEUNG Che-cheung to move his amendment to the motion, and forthwith proposes and puts to vote the question on Hon LEUNG Che-cheung's amendment;
- (i) after Hon LEUNG Che-cheung's amendment has been voted upon, the President deals with Dr Hon Helena WONG's amendment to the motion; and
- (j) after Dr Hon Helena WONG's amendment has been dealt with, the President calls upon Dr Hon KWOK Ka-ki to reply. Thereafter, the President puts to vote the question on Dr Hon KWOK Ka-ki's motion, or his motion as amended, as the case may be.

3. For Members' reference, the terms of the original motion and of the motion, if amended, are set out in the **Appendix**.

**Motion debate on
“Urging the next Chief Executive to reactivate constitutional reform”
to be held at the Council meeting of 29 March 2017**

1. Dr Hon KWOK Ka-ki’s original motion

That this Council urges the next Chief Executive to request the Central People’s Government to seek the invalidation by the National People’s Congress (‘NPC’) of the decision made by the Standing Committee of NPC on 31 August 2014 on Hong Kong’s constitutional development, and reactivate the statutory process for constitutional reform to allow Hong Kong people to, by way of nomination with no screening, including civil nomination, elect the Chief Executive on a ‘one person, one vote’ basis; and to abolish the functional constituencies in the Legislative Council to allow Hong Kong people to elect all Legislative Council Members by direct elections, so as to implement genuine dual universal suffrage under the principles of universality and equality, thereby manifesting ‘one country, two systems’, ‘Hong Kong people administering Hong Kong’ and ‘a high degree of autonomy’, and hence eliminating deep-rooted social conflicts.

2. Motion as amended by Hon LEUNG Che-cheung

That *in order to expeditiously implement the election of the Chief Executive by universal suffrage*, this Council urges the next Chief Executive to ~~request the Central People’s Government to seek the invalidation by the National People’s Congress (‘NPC’) of the decision made by the Standing Committee of NPC on 31 August 2014 on Hong Kong’s constitutional development, and~~ *actively create conditions, including strengthening mutual trust and communication among various social sectors to build social consensus, and in accordance with the Basic Law and the relevant decisions of the Standing Committee of the National People’s Congress*, reactivate the statutory process for constitutional reform to allow Hong Kong people to, by way of nomination with no screening, including civil nomination, *all eligible electors of Hong Kong to* elect the Chief Executive on a ‘one person, one vote’ basis; and to abolish the functional constituencies in the Legislative Council to allow Hong Kong people to elect all Legislative Council Members by direct elections, so as to implement genuine dual universal suffrage under the principles of universality and equality, thereby manifesting ‘one country, two systems’, ‘Hong Kong people administering Hong Kong’ and ‘a high degree of autonomy’, and hence eliminating deep-rooted social conflicts *make*

preparation for the subsequent implementation of universal suffrage for the election of all Members of the Legislative Council.

3. Motion as amended by Dr Hon Helena WONG

That this Council urges the next Chief Executive to request the Central People's Government to seek the invalidation by the National People's Congress ('NPC') of the decision made by the Standing Committee of NPC on 31 August 2014 on Hong Kong's constitutional development, and reactivate the statutory process for constitutional reform to allow Hong Kong people to, *in compliance with the provisions of the International Covenant on Civil and Political Rights ('ICCPR') and the Basic Law and* by way of nomination with no screening, including civil nomination, ~~elect~~ *nomination by political parties, nomination by members of a nominating committee and/or other nomination methods that comply with ICCPR and the Basic Law, nominate people with different political views to stand for the election of the Chief Executive, and elect* the Chief Executive on a 'one person, one vote' basis; and to abolish the functional constituencies in the Legislative Council to allow Hong Kong people to elect all Legislative Council Members by direct elections, so as to implement genuine dual universal suffrage under the principles of universality and equality, thereby manifesting 'one country, two systems', 'Hong Kong people administering Hong Kong' and 'a high degree of autonomy', and hence eliminating deep-rooted social conflicts.
