# NOTE FOR PUBLIC WORKS SUBCOMMITTEE OF FINANCE COMMITTEE 

Forecast of submissions<br>for the 2016-17 Legislative Council session

This note gives an overview of the potential capital works items to be submitted to the Public Works Subcommittee (PWSC) in the 2016-17 Legislative Council session.
2. On the basis of the latest advice from bureaux and departments, a total of 43 items, as listed in Enclosure 1, may be ready for submission to the PWSC before the 2017 summer recess. To enable Members to have a better understanding of the items, we have provided supplementary information on each item at Enclosure 2 following the same order presented in Enclosure 1. The list is our best projection for now and is subject to refinements.
3.

The Government will try to adhere to the target dates as set out in Enclosures 1 and 2 as much as possible. However, there may be programme changes arising during the design, statutory gazettal and objections, and consultation stages, etc. for individual items. We will account for deviations from the current forecast in a year-end report for Members' reference.

Project Code and Title: Provision for Capital Works Reserve Fund block allocations in 2017-18

Policy Bureau and Branch: Various controlling officers of CWRF block allocations

Works Department: Various

## Project Description:

Finance Committee (FC) has authorised the Government to seek funding for the various block allocations on a lump-sum basis once every year. Within the lump sum approved for each Capital Works Reserve Fund (CWRF) block allocation, FC has further delegated to the Government the power to approve expenditure on individual projects.

The submission seeks PWSC's support and FC's approval for the proposed allocation for the CWRF block allocations for 2017-18, additional allocation for Subhead 9100WX—Waterworks, studies and investigations for items in Category D of the Public Works Programme under Head 709-Waterworks for 2016-17, and revision to the ambit of Subhead 6101TX-Universal Accessibility Programme under Head 706-Highways.

Indicative cost of the proposed allocation (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

Previous or planned panel consultation: We consulted the Panel on Information Technology and Broadcasting, the Panel on Development and the Panel on Transport on 14, 18 and 22 November 2016 respectively.

Project Code and Title: 6056TR—South Island Line (East)—Essential Public Infrastructure Works

Policy Bureau and Branch: Transport and Housing Bureau (Transport Branch)
Works Department: Highways Department

## Project Description:

The project was upgraded to Category A in April 2011 at an Approved Project Estimate (APE) of $\$ 927$ million. The approved scope of the project mainly comprises (a) construction of a public transport interchange underneath the proposed Wong Chuk Hang (WCH) Station; (b) improvement of the existing road network in the vicinity of the proposed Ocean Park Station and WCH Station; (c) modification of a section of the existing WCH nullah between Ocean Park Road and Nam Long Shan Road; (d) construction of a covered footbridge connecting the WCH Station with the adjacent industrial area; (e) construction of a covered footbridge connecting South Horizons Station and Ap Lei Chau Estate; (f) construction of a pedestrian link to the Aberdeen Channel Promenade; and (g) road improvement works at the road junction of Ap Lei Chau Drive and Ap Lei Chau Bridge Road.

The Government entrusted the above works to the MTR Corporation Limited in May 2011 under the South Island Line (East) project. Construction commenced in May 2011. Due to unforeseen ground conditions, obstructions by underground utilities, design changes, and the necessity to increase the provision for price adjustments, we need to seek the approval of the Finance Committee for increasing the APE to meet the latest forecast of construction expenditure.

Indicative cost of the proposed increase in APE (Below \$200 million /
\$200 million - \$500 million / Above \$500 million): \$200 million - $\$ 500$ million
Previous or planned panel consultation: We plan to consult the Subcommittee on Matters Relating to Railways of the Panel on Transport on the proposed increase in the APE in 2016-Q4.

Project Code and Title: 6063TR—Shatin to Central Link—construction of railway works-advance works

Policy Bureau and Branch: Transport and Housing Bureau (Transport Branch)
Works Department: Highways Department

## Project Description:

The project was upgraded to Category A in February 2011 at an Approved Project Estimate (APE) of $\$ 6,254.9$ million. The approved scope of the project comprises expansion of Admiralty Station to accommodate the Shatin to Central Link (SCL) railway facilities including overrun tunnels of approximately 200 metres long and ventilation facilities for the station, and construction of the portion of Ho Man Tin Station for SCL.

The Government entrusted the works concerned to the MTR Corporation Limited in May 2011. The construction works commenced in May 2011. Due to factors such as unforeseen ground conditions, design changes and the necessity to increase the provision for price adjustments, we need to seek the approval of the Finance Committee for increasing the APE to meet the latest forecast of construction expenditure.

Indicative cost of the proposed increase in APE (Below \$200 million / \$200 million - \$500 million / Above \$500 million): Above \$500 million

Previous or planned panel consultation: We plan to consult the Subcommittee on Matters Relating to Railways of the Legislative Council Panel on Transport on the proposed increase in the APE in 2016-Q4.

Project Code and Title: 3185GK—Re-provisioning of Transport Department's vehicle examination centres at Tsing Yi

Policy Bureau and Branch: Development Bureau (Works Branch)
Works Department: Architectural Services Department

## Project Description:

The proposed project is for the relocation of three existing vehicle examination centres (VECs) of the Transport Department in Kowloon Bay and To Kwa Wan to Sai Tso Wan, Tsing Yi in order to release the development potential of the sites according to the Conceptual Master Plan for Energizing Kowloon East and to make way for the planned development at Kai Tak. The proposed scope of the project comprises (a) design and construction of a new VEC; (b) local widening works along Sai Tso Wan Road to improve the traffic near the new VEC site; and (c) decontamination and demolition of the three existing VECs. The construction is tentatively scheduled to commence in 2017-Q1 for completion in 2019-Q4, with the new VEC anticipated to commence operation around 2020-Q2. The subsequent decontamination works and demolition works for the three existing VECs are scheduled for completion in 2020-Q4 and 2022-Q1 respectively.

Indicative cost of the proposed project (Below \$200 million / \$200 million \$500 million / Above \$500 million): Above $\$ 500$ million

Previous or planned panel consultation: The Panel on Development was consulted but did not support the project on 24 May 2016. Having taken into account Members' views at the panel meeting, we plan to consult the Panel on Development on the proposed works again in December 2016.

Project Code and Title: 3794CL—The demolition of existing superstructures at Caroline Hill Road site, Causeway Bay

Policy Bureau and Branch: Development Bureau (Works Branch)
Works Department: Architectural Services Department

## Project Description:

The proposed project is for the demolition of all the existing superstructures except substructures of the buildings within the site located at the junction of Leighton Road and Caroline Hill Road in Causeway Bay. The proposed scope of the project comprises (a) demolition of (i) ex-Electrical and Mechanical Services Department Headquarters including a 11 -storey office building, a 5 -storey building for Apprentice Workshop, a 7 -storey building for staff quarters, three 1 -storey workshops, a 1-storey storage shed and a covered vehicle workshop; (ii) a 6-storey ex-Civil Aid Service building; (iii) a 1 -storey building for Post Office Recreation Club; and (iv) a 3-storey building for Pacific Century Cyber Works Recreation Club; and (b) other associated works including fencing off the site upon completion of demolition works. The demolition works are tentatively scheduled to commence in 2017-Q2 for completion in 2018-Q3.

Indicative cost of the proposed project (Below \$200 million / \$200 million \$500 million / Above \$500 million): Below \$200 million

Previous or planned panel consultation: We plan to consult the Panel on Development on the proposed works in December 2016.

Project Code and Title: 3111ET—A special school for students with mild, moderate and severe intellectual disabilities in Area 108, Tung Chung

Policy Bureau and Branch: Education Bureau
Works Department: Architectural Services Department

## Project Description:

The proposed project is for the construction of a special school with boarding facilities for children with mild, moderate and severe intellectual disabilities in Area 108, Tung Chung. The proposed scope of the project comprises (a) a school section with 18 classrooms and other related teaching and ancillary facilities; and (b) a boarding section of 60 boarding places with associated facilities. The construction is tentatively scheduled to commence in 2017-Q2 for completion in 2019-Q3.

Indicative cost of the proposed project (Below \$200 million / \$200 million \$500 million / Above \$500 million): \$200 million - $\$ 500$ million

Previous or planned panel consultation: We plan to consult the Panel on Education on the proposed works in December 2016.

Project Code and Title: 3070JA—Redevelopment of Junior Police Officers Married Quarters at Fan Garden, Fanling

Policy Bureau and Branch: Security Bureau
Works Department: Architectural Services Department

## Project Description:

The proposed project is to redevelop the existing Police Married Quarters at Fan Garden, Fanling. The proposed scope of the project comprises the construction of 1184 quarters units and other ancillary facilities, including a multi-purpose room and car parking spaces. The construction is tentatively scheduled to commence in 2017-Q2 for completion in 2020-Q4.

Indicative cost of the proposed project (Below \$200 million / \$200 million \$500 million / Above \$500 million): Above $\$ 500$ million

Previous or planned panel consultation: We plan to consult the Panel on Security on the proposed works in 2017-Q1.

Project Code and Title: 3086MM—Extension of Operating Theatre Block for Tuen Mun Hospital

Policy Bureau and Branch: Food and Health Bureau (Health Branch)
Works Department: Hospital Authority

## Project Description:

The proposed project is for carrying out the main works for the extension of the Operating Theatre (OT) Block for Tuen Mun Hospital (TMH). The proposed scope of the project comprises (a) construction of the extension block; (b) construction of a link bridge connecting the extension block and the existing OT Block; (c) expansion of the existing accident and emergency (A\&E) department and radiology department at the extension block and on the ground floor of Block D of TMH respectively; and (d) refurbishment of the existing OT Block and the existing A\&E and radiology departments on the ground floor of Block D of TMH. The construction is tentatively scheduled to commence in 2017-Q2 for completion in 2021-Q4.

Indicative cost of the proposed project (Below \$200 million / \$200 million \$500 million / Above \$500 million): Above \$500 million

Previous or planned panel consultation: We plan to consult the Panel on Health Services on the proposed works in February 2017.

Project Code and Title: 3087MM—New Acute Hospital at Kai Tak Development Area

Policy Bureau and Branch: Food and Health Bureau (Health Branch)
Works Department: Hospital Authority

## Project Description:

The part of the project proposed for upgrading to Category A is for the preparatory works of the New Acute Hospital at Kai Tak Development Area including site investigations, minor studies and surveys, as well as consultancy services for outline sketch design, detailed design, and tender documentation and assessment for the main works. The whole project proposes to build a new acute general hospital at Kai Tak Development Area with modern service models and incorporating advanced technology and facilities for the delivery of a comprehensive range of acute hospital services including 2400 beds with inpatient and ambulatory services of major specialties. It will also house an accident and emergency department, an oncology centre and a neuroscience centre. The preparatory works are tentatively scheduled to commence in 2017-Q2 for completion in 2020-Q4.

Indicative cost of the proposed project (Below \$200 million / \$200 million \$500 million / Above \$500 million): Above $\$ 500$ million

Previous or planned panel consultation: We plan to consult the Panel on Health Services on the proposed works in February 2017.

Project Code and Title: 4394DS—Upgrading of Kwun Tong preliminary treatment works

Policy Bureau and Branch: Environmental Bureau
Works Department: Drainage Services Department

## Project Description:

The project is for the upgrading of the existing Kwun Tong preliminary treatment works (KTPTW) through the construction of additional facilities and upgrading of existing facilities to increase its treatment capacity from 10.92 cubic metres $\left(\mathrm{m}^{3}\right) /$ second (s) to $13.13 \mathrm{~m}^{3} / \mathrm{s}$. The proposed scope of the project comprises (a) upgrading of the inlet screw pumping system; (b) provision of an additional grit removal system together with associated grit handling facility and deodorisation system; (c) construction of one new grit building and one odour control room; (d) modification of the existing influent channel and construction of a new influent channel; (e) modification of emergency seawall bypass system; (f) carrying out of architectural and landscaping modification works for the existing KTPTW; and (g) other ancillary works. The works is tentatively scheduled to commence in 2017-Q2 for completion in 2022-Q2.

Indicative cost of the proposed project (Below \$200 million / \$200 million \$500 million / Above \$500 million): \$200 million - \$500 million

Previous or planned panel consultation: We plan to consult the Panel on Environmental Affairs on the proposed works in January 2017.

Project Code and Title: 5751CL—Planning and engineering study on Sunny Bay reclamation

Policy Bureau and Branch: Development Bureau (Works Branch)
Works Department: Civil Engineering and Development Department

## Project Description:

The proposed project is to conduct a planning and engineering study on the potential nearshore reclamation site at Sunny Bay for increasing land supply by reclamation on an appropriate scale outside Victoria Harbour. The proposed scope of the study comprises (a) detailed planning and engineering study to establish the reclamation extent, land uses and the technical feasibility; (b) environmental impact assessment for the proposed developments and the associated engineering infrastructure; (c) community engagement exercises with relevant stakeholders; (d) formulation of the implementation strategy and programme; and (e) associated site investigation works including supervision. The planning and engineering study is tentatively scheduled to commence in 2017-Q2 for completion in 2019-Q2.

Indicative cost of the proposed project (Below \$200 million / \$200 million \$500 million / Above \$500 million): Below \$200 million

Previous or planned panel consultation: The Panel on Development was consulted and supported the project on 22 April 2014. Given the project was not supported by PWSC on 9 January 2015, we plan to consult the Panel on Development on the proposed works again in 2017-Q1.

Project Code and Title: 5758CL—Site formation and associated infrastructural works for development of columbarium, crematorium and related facilities at Sandy Ridge Cemetery

Policy Bureau and Branch: Food and Health Bureau (Food Branch)
Works Department: Civil Engineering and Development Department

## Project Description:

The part of the project proposed for upgrading to Category A is for the site formation works at Sandy Ridge Cemetery. The proposed scope of the project comprises (a) site formation for development of columbarium facilities; and (b) associated environmental mitigation measures, landscaping works, geotechnical works, drainage and sewerage works, waterworks, roadworks, traffic engineering works and other utilities services, etc. The construction is tentatively scheduled to commence in 2017-Q2 for completion in 2020-Q4.

Indicative cost of the proposed project (Below \$200 million / \$200 million \$500 million / Above \$500 million): Above $\$ 500$ million

Previous or planned panel consultation: We plan to consult the Panel on Food Safety and Environmental Hygiene on the proposed works in December 2016.

Project Code and Title: 9357WF—Design and construction for first stage of desalination plant at Tseung Kwan O

Policy Bureau and Branch: Development Bureau (Works Branch)

## Project Description:

The part of the project proposed for upgrading to Category A is for the laying of dedicated fresh water mains for conveying the fresh water produced at the proposed Tseung Kwan O desalination plant to existing fresh water service reservoirs. The construction is tentatively scheduled to commence in 2017-Q2 for completion in 2021-Q2.

Indicative cost of the proposed project (Below \$200 million / \$200 million \$500 million / Above \$500 million): Above \$500 million

Previous or planned panel consultation: We plan to consult the Panel on Development on the proposed works in January 2017.

Project Code and Title: 7754CL—Infrastructure works for West Kowloon Cultural District, phase 1-Construction

Policy Bureau and Branch: Home Affairs Bureau
Works Department: Civil Engineering and Development Department

## Project Description:

The part of the project proposed for upgrading to Category A is for the second construction package of supporting infrastructure for West Kowloon Cultural District (WKCD) to tie in with the development of the Artist Square Development Area and Xiqu Centre undertaken by the WKCD Authority. The proposed scope of the project comprises (a) construction of a pedestrian linkage system across Austin Road West connecting WKCD with Kowloon Station; (b) beautification works for the existing pedestrian subway across Austin Road West and Canton Road; and (c) ancillary works including footpaths, lighting and landscaping. The construction is tentatively scheduled to commence in mid-2017 for phased completion in 2020.

Indicative cost of the proposed project (Below \$200 million / \$200 million \$500 million / Above \$500 million): \$200 million - \$500 million

Previous or planned panel consultation: We plan to consult the Joint Subcommittee to Monitor the Implementation of the WKCD Project under the Panel on Home Affairs and Panel on Development on the proposed works in April 2017.

Project Code and Title: 3183GK—Reprovisioning of Shanghai Street refuse collection point and street sleepers' services units to the site on Hau Cheung Street, Yau Ma Tei for the phase II development of the Yau Ma Tei Theatre project

## Works Department: Architectural Services Department

## Project Description:

The proposed project is for the reprovisioning of the Shanghai Street refuse collection point (RCP) and street sleepers' services units (SSSU) on Hau Cheung Street, Yau Ma Tei, so as to vacate the existing site for the phase II development of the Yau Ma Tei Theatre.
