### NOTE FOR PUBLIC WORKS SUBCOMMITTEE OF FINANCE COMMITTEE

#### Year-end Report on Submissions to Public Works Subcommittee for the 2016-17 Legislative Council Session

Since the 2001-02 Legislative Council (LegCo) session, the Government has been providing Members with an annual forecast of the capital works items planned to be submitted to the Public Works Subcommittee (PWSC) during the respective LegCo session.

- 2. For the 2016-17 LegCo session, we provided Members with a list of 43 potential items vide PWSCI(2016-17)8 on 30 November 2016. This year-end report summarises the deviations between the actual submissions and the forecast provided in PWSCI(2016-17)8. Members are requested to note the following
  - (a) **Enclosure 1**: 31 of the 43 items shown in PWSCI(2016-17)8 were submitted to PWSC as planned.
  - (b) **Enclosure 2**: Five items not included in the forecast were submitted to PWSC.

The total number of items submitted to PWSC in the 2016-17 LegCo session was therefore 36.
